Sub: Umaria Underground Coal Mine Project of M/s South Eastern Coalfields Ltd. (SECL), in village Umaria, Bandogarn Tehsil, District Umaria, Madhya Pradesh – application for environmental clearance –reg.

This has reference to M/s South Eastern Coalfields Ltd.'s letter dated 23.02,2005 and subsequent letters dated 18.03.2004 and of M/s Coal India Ltd. dated 15.04.2005, 28.03.2005 and 01.04.2005 on the above-mentioned subject. The Ministry of Environment and Forests has considered the application. It has been noted that the project is for expansion of Umaria Underground Coal Mine Project In terms of production capacity from 0.144 MTPA to 0.35 MTPA. The total mining lease area is 857.675 ha of which 773.651 ha is agricultural land and 92.817 ha is Government land. Of the total lease area, area for excavation is \$67,701.0 ha, 13.77 ha is for infrastructure and 276,197 ha is for safety zone and newly acquired land. An area of 8.801 ha is for township outside the lease area. There are no National Parks, Wildlife Sanctuary, Biosphere Reserves found in the 10 km buffer zone. The Umaria Reserve Forest is located within 2 km in the buffer zone and the Badrehal RF is 3 km in the buffer zone. Mining will be underground by mechanised method. Drilling and blasting are involved. Expansion of rated capacity of the mine is from 0.144 million tonnes per annum (MTPA) to 0.35 MTPA of coal production. Mineral transportation of 666 TPD of coal shall be by use of conveyor belt. Water table is in the range of 6.14m to 9.49 m bgl in pre-monsoon and 2.06m to 4.31m bgl in post-monsoon. Average water requirement is 755 m3/d, which will be met from mine discharge water. Public Hearing was held on 14.10.2003. NOC from Madhya Pradesh State Pollution Control Board has been obtained on 24.12.2005. Balance life of the mine at the rated capacity is 12 years. The project has been approved by M/s SECL on 28.03.2005, The capital cost of the project is Rs. 1704 lakhs,

- 2. The Ministry of Environment & Forests hereby accords environmental clearance for the above-mentioned Umaria Underground Coal project of M/s SECL for expansion in production of coal to 1.31 MTPA in a total lease area of 857.675 ha under the provisions of Environmental Impact Assessment Notification, 1994 and subsequent amendments thereto subject to the compliance of the terms and conditions mentioned below:
- A. Specific Conditions
- (i) Catch drains and siltation ponds of appropriate site should be constructed to arrest silt and sediment flows from around the mine. The water so collected should be utilised for watering the mine area, roads, green belt development, etc. The drains should be regularly desilted and maintained properly.

Garland drains (size, gradient & length) and sump capacity should be designed keeping 50% safety margin over and above the peak sudden rainfall and maximum discharge in the area adjoining the mines site. Sump capacity should also provide adequate retention period to allow proper settling of silt material.

- Crushers at the CHP should be operated with high efficiency bag filters, water sprinkling (ii) system should be provided to check fugitive emissions from crushing operations, haulage roads, transfer points, etc.
- Drills should be wet operated or with dust extractors. (lii)
- Controlled blasting should be practiced with the use of delay detonators. (iv)
- The area that shall be brought under green belt development shall include roads, periphery (v) along ML boundary and undisturbed area by planting native plant species in consultation with the local DFO/Agriculture Department. The density of the trees should be around 2500 plants
- (vi) Regular monitoring of groundwater level and quality should be carried out by establishing a network of existing wells and construction of new plezometers. The monitoring for quantity should be done four times a year in pre-monsoon (May), monsoon (August), post-monsoon (November) and winter (January) seasons and for quality in May. Data thus collected should be submitted to the Ministry of Environment & Forests and the Central Ground Water Board, Regional Office quarterly within one months of monitoring.
- The Company shall put up artificial groundwater recharge measures for augmentation of groundwater resource. The project authorities should meet water requirement of nearby village(s) in case the village wells go dry due to de-watering of the mine.
- Sewage treatment plant should be installed in the existing colony. ETP should also be provided for workshop and CHP wastewater.
 - (ix) $_{\chi}$ Land oustees shall be compensated as per State Government and CIL norms. 11.
 - Digital processing of the entire lease area using remote sensing techniques should be done (x) regularly once in 3 years for monitoring land use pattern and report submitted to MOEF and its Regional Office at Bhopal.
 - A Final Mine Closure Plan along with details of Corpus Fund should be submitted to the Ministry of Environment & Forests 5 years in advance of final mine closure for approval.

B. General conditions

- No change in mining technology and scope of working should be made without prior approval
- No change in the calendar plan including excavation, quantum of mineral coal and waste (II) should be made.
- Four ambient air quality monitoring stations should be established in the core zone as well as in the buffer zone for RPM, SPM, SO₂, NO_x, monitoring. Location of the stations should be decided based on the meteorological data, topographical features and environmentally and ecologically sensitive targets in consultation with the State Poliution Control Board. (iv)
- Data on ambient air quality (RPM, SPM, SO₂,NO₂) should be regularly submitted to the Ministry Including its Regional Office at Bhopal and the State Pollution Control Board and the (v)
- Fugitive dust emissions from all the sources should be controlled regularly monitored and data recorded properly. Water spraying arrangement on haul roads, wagon loading, dump trucks (loading & unloading) points should be provided and properly maintained.

- (vi) Adequate measures should be taken for control of noise levels below 85 dBA in the work environment. Workers engaged in blasting and drilling operations, operations of HEMM, etc., should be provided with ear plugs/muffs.
- (vii) Industrial wastewater (workshop and wastewater from the mine) should be properly collected, treated so as to conform to the standards prescribed under GSR 422 (E) dated 19th May 1993 and 31st December 1993 or as amended from time to time. Oil and grease trap should be installed before discharge of workshop effluents.
- (vili) Vehicular emissions should be kept under control and regularly monitored. Vehicles used for transporting the mineral should be covered with tarpaulins and optimally loaded.
- (ix) Environmental laboratory should be established with adequate number and type of pollution monitoring and analysis equipment in consultation with the State Pollution Control Board.
- (x) Personnel working in dusty areas should wear protective respiratory devises and they should also be provided with adequate training and information on safety and health aspects.

 Occupational health surveillance programme of the workers should be uncertaken periodically to observe any contractions due to exposure to dust and take corrective measures, if needed.
- (xi) A separate environmental management cell with sultable qualified personnel should be set-up under the control of a Senior Executive, who will report directly to the Head of the Company.
- (xii) The funds earmarked for environmental protection measures should be kept in separate account and should not be diverted for other purpose. Year-wise expenditure should be reported to the Ministry and its Regional Office located at Bhopal.
- (xiii) The Regional Office of this Ministry located at Bhopal shall monitor compilance of the stipulated conditions. The project authorities should extend full cooperation to the office(s) of the Regional Office by furnishing the requisite data/information/monitoring reports.
- (xiv) A copy of the clearance letter will be marked to concerned Panchayat/local NGO, if any, from whom and suggestion/representation has been received while processing the proposal.
- (xv) State Pollution Control Board should display a copy of the clearance letter at the Regional office, District Industry Centre and Collector's office/ Tehsildar's Office for 30 days.
- The project authorities should advertise at least in two local newspapers widely circulated around the project, one of which shall be in the vernacular language of the locality concerned within seven days of issue of the clearance letter informing that the project has been accorded environmental clearance and a copy of the clearance letter is available with the State Pollution Control Board and may also be seen at web site of the Ministry of Environment & Forests at http://envfor.nic.in.
- The Ministry or any other competent authority may stipulate any further condition for environmental protection.
- 4. Failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of the Environment (Protection) Act, 1986.
- 5. The above conditions will be enforced, Inter-alla, under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1986 and the Public Liability Insurance Act, 1991 along with their amendments and rules.
