Goleti 1 & 1A Incline Underground Coal Mine Expansion Project (0.6 MTPA peak production and expansion in lease area from 408.26 ha to 658.26 ha) of M/s Singareni Collieries Company Ltd., located in village Goleti, Mandal Rebbana, District Adilabad, Andhra Pradesh- environmental clearance – reg.

This is with reference to your letter No. CRP/ENV/A/534/186 dated 05.03.2007 for Terms of Reference, which was granted vide MOEF letter dated 28.08.2007 and with reference to your application for environmental clearance based on the prescribed Terms of Reference vide letter No. CRP/ENV/A/491/357 dated 27.05.2008 on the above-mentioned subject. The Ministry of Environment & Forests has considered your application. It has been noted that the project is for expansion of the existing Goleti 1 & 1A Incline Underground Coal Mine Project in terms of lease area from 408.26 ha to 658.26 ha with a peak production of 0.60 million tonnes per annum (MTPA) of coal. Of the total ML area of 167 ha, 112.64 ha is agricultural land, 465.10 ha is forestland, 9.30 ha is water bodies, 5.01 ha is waste land, 14.20 ha is grazing land, and 52.01 ha is village land and SCCL Township. Forestry clearance has been obtained for 83.77 ha of forestland. The ML falls within a Reserve Forest (RF) and is surrounded by a number of RF in the buffer zone. Two nalas- Sonapur Nala and Narsapur Nala traverse the ML, which are tributaries of River Godavari.

Mining is by underground method and is semi-mechanised. Mineral transportation of 2000 TPD of coal from the mine to Shanti Khani CHP is by 35-Ttippers covering a road length of 28 km and from there by rail and by road. Ultimate working depth of the mine is 400m below ground level (bgl). Water table of the study area is in the range of 5.09-13.96 bgl during the pre-monsoon and in the range of 2.78m -10.47m bgl during post-monsoon period. Peak water requirement of 1110 m3/d is met from mine pit water. No R&R is involved. Life of the mine at a production of 0.6 MTPA is 38 years. Public Hearing was held on 11.03.2008. Mining Plan has been approved by Ministry of Coal on 09.12.2005. Capital cost of the project is Rs. 25.01 crores.

The Ministry of Environment & Forests hereby accords environmental clearance for the above-mentioned Goleti 1 & 1A Incline Underground Coal Mine Project of M/s Singareni Collieries Company Ltd. for a peak production of coal at 0.60 MTPA within a lease area of 658.26 ha under Section 12 of the Environmental Impact Assessment Notification, 2006 and subsequent amendments thereto and under Para 2.1.1 of MOEF Circular dated 13.10.2006 subject to the compliance of the terms and conditions mentioned below:

Mining shall not be carried in forestland for which forestry clearance has not been obtained under the provisions of FC Act, 1980. Sufficient coal pillars shall be left unextracted around the airshaft (within the subsidence influence area) to protect from any damage from subsidence, if any.

Depression due to subsidence resulting in water accumulating within the low lying areas shall be filled up or drained out by cutting drains. (iv)

Solid barriers shall be left below the roads falling within the blocks to avoid any damage to the roads.

- While extracting panels in the lower seam, all water bodies in the low-lying/subsidence area shall be drained. Dewatering of the old goaves of the upper seam shall be continued as long as the lower seam is worked (v)
- Regular monitoring of subsidence movement on the surface over and around the working area and impact on natural drainage pattern, water bodies, vegetation, structure, roads, and surroundings should be (vi) continued till movement ceases completely. In case of observation of any high rate of subsidence movement, appropriate effective corrective measures should be taken to avoid loss of life and material. Cracks should be
- Garland/surface drains (size, gradient and length) around the safety areas such as mine shaft and low lying areas and sump capacity should be designed keeping 50% safety margin over an above the peak sudden (vii) rainfall and maximum discharge in the area adjoining the mine sites. Sump capacity should also provided adequate retention period to allow proper settling of silt material. Sufficient number of pumps of adequate capacity shall be deployed to pump out mine water during peak rainfall.
- Crushers at the CHP should be operated with high efficiency bag filters, water sprinkling system should be provided to check fugitive emissions from crushing operations, conveyor system, haulage roads, (viii) transfer points, etc.

- A progressive afforestation plan shall be prepared and implanted for the undisturbed area and shall include area brought under green belt development, areas along roads, infrastructure, over surface where mining is (xi) being done below, along ML boundary an township outside the lease areas, etc, by planting native species in consultation with the local DFO/Agriculture Department. The density of the trees should be around 2500 plants per ha.
- Conservation Plan for endangered species found in and around the project area shall be formulated in consultation with the State Forest and Wildlife Departments. (xii)
- in pre-monsoon (May), monsoon (August), post-monsoon (November) and winter (January) seasons and for quality in May. Data thus collected should be submitted to the Ministry of Environment & Forests and tot eh Central Pollution Control Board quarterly within one month of monitoring.

Regular monitoring of groundwater level and quality should be carried out by establishing a network of exiting wells and construction of new peizometers. The monitoring for quantity should be done four times a year

- The Company shall put up artificial groundwater recharge measures for augmentation of groundwater resource. The project authorities should meet water requirement of nearby village(s) in case the village wells go dry due to dewatering of mine.
- Sewage treatment plant should be installed in the existing colony. ETP should also be provided for workshop and CHP wastewater. (xvi)

The company shall obtain approval of CGWA/CGWB Regional Office for use of groundwater if any, for mining operations.

- Digital processing of the entire lease area using remote sensing technique should be done regularly once in 3 years for monitoring land use pattern and report submitted to MOEF and its Regional office at Bangalore. (xvii)

A Final Mine Closure Plan along with details of Corpus Fund should be submitted to the Ministry of Environment & Forests 5 years in advance of final mine closure for approval.

General Conditions В.

- No change in mining technology and scope of working shall be made without prior approval of the Ministry of Environment and Forests.
- No change in the calendar plan including excavation, quantum of mineral coal and waste shall be made. Four ambient air quality monitoring stations shall be established in the core zone as well as in the buffer zone monitoring of SPM, RPM, SO2, NOx Hg and other heavy metals such as Pb, Cr, As, etc. Location
- of the stations shall be decided based on the meteorological data, topographical features and environmentally and ecologically sensitive targets in consultation with the State Pollution Control Board.
- wagon loading, dump trucks (loading and unloading) points shall be provided and properly maintained.

Fugitive dust emissions (SPM and RSPM, Hg and other heavy metals) from all the sources shall be controlled regularly monitored and data recorded properly. Water spraying arrangement on haul roads,

Adequate measures shall be taken for control of noise levels below 85 dBA in the work environment. Workers engaged in blasting and drilling operations, operation of HEMM, etc shall be provided with ear

Industrial wastewater (workshop and wastewater from the mine) shall be properly collected, treated so as to conform to the standards prescribed under GSR 422 (E) dated 19th May 1993 and 31st

- Data on ambient air quality (SPM, RSPM, SO2, NOx, Hg and other heavy metals) shall be regularly submitted to the Ministry including its Regional Office at Bangalore and to the State Pollution Control (v) Board and the Central Pollution Control Board once in six months.

- (xi) A separate environmental management cell with suitable qualified personnel shall be set up under the control of a Senior Executive, who will report directly to the Head of the company.

- State Pollution Control Board shall display a copy of the clearance letter at the Regional Office, District Industry Centre and Collector's Office/Tehsildar's Office for 30 days. (xv)
- The Project authorities shall advertise at least in two local newspapers widely circulated around the project, one of which shall be in the vernacular language of the locality concerned within seven days of the (xvi) clearance letter informing that the project has been accorded environmental clearance and a copy of the clearance letter is available with the State Pollution control Board and may also be seen at the website of the ministry of Environment & Forests at http://envfor.nic.in.
- The Ministry or any other competent authority may stipulate any further condition for environmental protection. 3.
- 4. Failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract the provisions of the Environment (Protection) Act, 1986.
- The above conditions will be enforced inter-alia, under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1981, the Environment (Protection) Act, 1986 and the Public Liability Insurance Act, 1991 along with their amendments and Rules.
