43.3 Proposal for consideration

43.3.1. Proposed 70200 TPA of Limestone production including subgrade and OB from Putka Limestone Mine (MLA 97.013 Ha) of M/s Jyoti Pramanik located at Village Putka, District Bargarh, Orissa - Environmental Clearance Proposal No. IA/OR/MIN/195617/2018 and File No. 23-151/2018-IA.III (V)

Project Proponent along with the consultant made the detailed presentation before the EA and provided following information:

Putka Limestone Mines over an area of 97.031 hectares situated in village Putka, Thana – Jharbandh, in the district of Bargarh of Odisha State of Sri Jyoti Pramanik. The Mining Lease of Putka limestone mine over 240.674 Hectares was granted by Government of Odisha and executed

on 25.09.1974 for a period of 20 years. After part surrender an area of 97.031 ha. Was executed on 13.09.2017 for operation w.e.f. 25.09.1994. The lease period expired on 24.09.2014 and renewal application submitted. In view of section 8A of MM (D & R) Act, 2015 (as amended), lease period is deemed extent up to 24.09.2024.

There was no mining plan/scheme upto 2004-05. Mining Plan for a period of 5 yrs i.e. from 2005-06 to 2009-10 was approved by IBM, Bhubaneswar. Vide letter no. BBS/BR6/LST/MP-264 dated 16.11.2005 for a production of 70,200 TPA. Mining Plan could not be prepared from 2010-11 to 2015-16 as the mine was not under operation (violation case) due to want of environmental clearance. Mining Plan has been prepared for a period 2016-17 to 2021 and has been duly approved vide letter no MPM/OTFM/06-ORI/BHU/2016-17 dated 02.09.2016 with a maximum production 70,200 TPA.

The proposed project is listed in the new EIA notification S.O. 1533, dated 14th September 2006 as Category A under heading No.1(a) Mining of minerals. The project requires prior Environmental Clearance from MoEF & CC, New Delhi.

Present Status of the project

- ToR for the project was approved vide letter no: J-11015/167/2014-IA.II (M) on dated 23.11.2015.
- Environment Consultant Engaged for EIA/EMP study: M/s Visiontek Consultancy services Pvt. Ltd.
- Baseline study for the project was conducted during March to May 2016.
- Public hearing for the project was conducted on: 04.11.2016
- Final EIA/EMP report has been prepared and submitted to EAC, New Delhi
- The online proposal was submitted on 16th May 2017 for ToR/ EC as per provision of notification vide S.o. 804 (E) dated 14.03.2017 for Putka Limestone Mines over an area of 97.031 Ha under the case of violation of EIA notification 2006.
- A case has been initiated at SJDM, Padampur vide CC no: 02 of 2015 on dated 26.09.2015
- Based on the application a letter has been issued by MoEF & CC on 5th Jan 2018 regarding the compliance to violation.
- Hon'ble Supreme Court Judgment dated 02.08.2017 limited to Iron and Manganese ore mines only and it does cover the scope of limestone mines. So the invocation of section 21(5) under MMDR Act to determine excess of mining is not rational and so also the certification of state govt. with regard to recovery of such cost is under processing.
- Compensation assessed by DDM mines for the said mines is Rs.10, 50,906.00 and a show cause notice was issued. However the proponent approached the authority regarding the above show cause.

- The mining authority has advised that as there is no demand against the proponent hence the said amount cannot be deposited.
- The Lessee files an affidavit before the executive magistrate, Sambalpur on 26.08.2019 with regard to not repetition of the violation further and shall be abided by rule and regulation stipulated there in in statute. This affidavit has been submitted to MoEF & CC.
- In the mean time there is the change in EIA consultant from M/s Visiontek Consultancy services Pvt. Ltd to M/s Kalyani Laboratories Pvt. Ltd.

Now onwards M/s Kalyani Laboratory will be involved in the project regarding the case of violation and complying the ToR issued by the Hon'ble committee regarding violation.

On account of exposure of limestone and its limited depth opencast semi mechanized (OTFM) mining method will be adopted. The various mining operations such as drilling, blasting, excavation, loading, sizing and transportation will be done by jack hammer drill as well as 100mm dia DTH drill on single shift basis. Height and width of the benches will be kept at 3m and 6m respectively. The individual bench faces will be kept nearly vertical ($75^0 - 85^0$) whereas the overall quarry slope angle (the angle between the line joining the toe of bottom bench and the crest of the top bench with the horizontal) is proposed to be kept at less than 27^0 with the horizontal.

Power gel explosive in conjunction with safety fuse & ordinary / electric detonators will be used for blasting to loosen hard rock mass for ease in excavation. Low capacity excavator and tippers will be used for excavation & loading and transportation. Jack hammers will be used for short hole drilling & blasting. Explosive consumption 0.5 kg/hole will be consumed.

Observation and recommendation of the EAC in the present meeting:

After detailed presentation by the PP, EAC observed that proposed proposal is for 70200 TPA of Limestone production including subgrade and OB from Putka Limestone Mine (MLA 97.013 Ha). The Mining Lease of Putka limestone mine over 240.674 Hectares was granted by Government of Odisha and executed on 25.09.1974 for a period of 20 years. After part surrender an area of 97.031 ha. Was executed on 13.09.2017 for operation w.e.f. 25.09.1994. The lease period expired on 24.09.2014 and renewal application submitted. In view of section 8A of MM (D & R) Act, 2015 (as amended), lease period is deemed extent up to 24.09.2024. Mining Plan has been prepared for a period 2016-17 to 2021 and has been duly approved vide letter no MPM/OTFM/06-ORI/BHU/2016-17 dated 02.09.2016 with a maximum production 70,200 TPA. PP has started the work onsite without prior EC under EIA notification, 2006. There is no National Park or wild life Sanctuary within 10km from the project site.

EAC deliberated on the information submitted by the Project Proponent (Form 2, EIA/EMP report, PH issues, Annexures etc) **deferred** the project for want of following information:

- Revised damage assessment cost as suggested during the meeting shall be assessed. Remediation, Natural and Community resource Augmentation plan is related to the EMP activities and confined to project site, therefore activities under all the three plan shall be revised for outside he project area.
- 2) Remediation, Natural and Community resource augmentation plan shall be prepared for three with monitorible capital investments
- 3) Rework on the table for monitoring stations w.r.t to predominant wind direction and accordingly incremental load shall be assessed using modelling tools.
- 4) Safety measures for water bodies in the vicinity of the mine lease area with details of safety zone for near habitation, agriculture and water bodies.
- 5) Rework on the dumpling plan with details of garland drain and toe wall etc.
- 6) Details of peripheral plantation shall be submitted.

- 7) Monitorible Physical targets w.r.t the issues raised during Public Hearing shall be identified and incorporated under EMP.
- 8) Issues raised during the Public Hearing shall be tabulated alogwith the compliance submitted in response.
- 9) Details for reclamation of external dumps.
- 10) Details of transportation of mineral.

Observations and recommendations of committee of 14th EAC meeting held on 22th - 24th October, 2018:

EAC deferred the proposal as PP did not attend the meeting.

Observations and recommendations of the EAC in the present meeting (43rd) held on 08th-09th February 2021.

EAC noted that the Project proponent did not attend the meeting, however verification of the kml file on the DSS the instant mine lease was found adjacent to Tiger reserve. EAC advised the Ministry to obtain the comments from National Tiger conservation authority for the applicability of Hon'ble Supreme Court in its interim order dated 04.08.2006 in IA 1000 WP 202 of 1995 (T.N. Godavaram Vs Union of India) had directed inter alia, that no mining activity should be granted within the safety zone of 1 Km.

EAC further opined that proposal was listed earlier for appraisal, however, PP did not attend the meeting. This time again PP did not attend, therefore EAC opined that Ministry may initiate action and issue necessary directions to the Project Proponent as may be deemed fit.

43.3.3. Proposed expansion of Perwa Calcite Mine (ML No. 64/2012, Area 129.50 ha) and enhancement in production from 12500 TPA to 2001870 TPA by M/s Perwa Minerals, located near Village Perwa, Tehsil Reodar, District Sirohi, Rajasthan - Terms of Reference Proposal No. IA/RJ/MIN/74486/2018 and File No. 23-274/2018-IA.III (V)

The EAC deferred the proposal as the project proponent did not attend the meeting.

Observations and recommendations of the EAC in the present meeting (43rd) held on 08th-09th February 2021.

EAC observed that proposal was listed earlier for appraisal, however, PP did not attend the meeting. This time again PP did not attend, therefore EAC opined that Ministry may initiate action and issue necessary directions to the Project Proponent as may be deemed fit.

Observations and recommendations of committee of 14th EAC meeting held on 22th - 24th October, 2018:

The EAC deferred the proposal as the project proponent did not attend the meeting.

Observations and recommendations of the EAC in the present meeting (43rd) held on 08th-09th February 2021.

EAC observed that proposal was listed earlier for appraisal, however, PP did not attend the meeting. This time again PP did not attend, therefore EAC opined that Ministry may initiate action and issue necessary directions to the Project Proponent as may be deemed fit.

43.3.5. Gandlapally Limestone Mine of M/s Seetharam Cements Limited for production of 2.25 MTPA (M.L. Area 429.07 Ha), located at Survey. No. 58 to 74, 81 to 85 & 88 to 101, Village Gandlapally, Mandal Kodangal, District Mahabubnagar, Telangana - Terms of Reference Proposal No. IA/TG/MIN/74487/2018 and File No. 23-276/2018-IA.III (V)

Observations and recommendations of committee of 14th EAC meeting held on 22th - 24th October, 2018:

The EAC deferred the proposal as the project proponent did not attend the meeting.

Observations and recommendations of the EAC in the present meeting (43rd) held on 08th-09th February 2021.

Project proponent vide letter dated 04.02.2021 informed the Ministry that the State Government did not grant renewal/extension of the Mining lease. The Director of Mines and Geology & Indian Bureau of Mines, Hyderabad have also communicated that the mining lease was not in force and the question of extension of ML does not arise. Since SCL does not have valid Mining leases in hand as well as SCL also withdrew its proposal to setup the cement plant in view of the inadequate limestone resources available in the ML area, we are not keen to pursue the ToRs, hence request to close the subject matter submitted to the Ministry.

EAC deliberated on the above communication of the PP and opined that since the proposal was submitted under violation category by the project proponent itself therefore proposal should be examined by the EAC for the violation, if any. Accordingly, EAC recommend that the subject matter

cannot be closed as of now. Project proponent should make a detailed presentation on the project proposal in the next EAC meeting for further consideration.

Observations and recommendations of committee of 14th EAC meeting held on 22th - 24th October, 2018:

The EAC deferred the proposal as the project proponent did not attend the meeting.

Silica Sand & Masonary stone mining along with Processing, Crushing, Sizing, Grinding, Washing and beneficiation with proposed production capacity of 79,00,000 TPA (ROM) by M/s Shivalik Silica, located near Village Agawali, Tehsil Bayana, District Bharatpur, Rajasthan (MLA 49.56 Ha & ML No. 2/93) - Further consideration for Terms of Reference Proposal No. IA/RJ/MIN/73413/2018 and File No. J-11015/50/2018-IA.II (M)

Observations and recommendations of committee of 23rd EAC meeting held on 25th - 26th June, 2019:

Project proponent did not attend the meeting.

Observations and recommendations of committee of EAC in its 43rd meeting (present meeting) held during 08th – 09th February,2021:

EAC observed that proposal was listed earlier for appraisal, however, PP did not attend the meeting. This time again PP did not attend, therefore EAC opined that Ministry may initiate action and issue necessary directions to the Project Proponent as may be deemed fit.

43.4.6. Proposed expansion of Insecticide (Insecticide Active Ingredients) production plant at Brahmanpara, P.O. & P.S. - Haripal, District Hooghly, west Bengal by M/s Solex Chemicals Pvt. Ltd. - Further consideration for Terms of Reference Proposal No. IA/WB/IND2/70221/2017 and File No. J-11011/511/2017- IA-II(I)

Observations and recommendations of committee of 33rd EAC meeting held on 18th - 19th May, 2020:

Project Proponent did not attend the meeting.

Observations and recommendations of committee in the present meeting (43rd)

Project Proponent (PP) vide email dated 09.02.2021 informed that there proposal have been appraised by EAC ind-2 in its 26th Meeting and recommended for grant of Environmental Clearance. Accordingly Environmental Clearance has been accorded from MoEF&CC vide file no J-11011/511/2017-IA-II(I) dated 5th January 2021. Hence, PP requested for no further action to be taken.

EAC deliberated on the submission of the PP. EAC noted that instant proposal was referred to this committee by the Industry sector as lateral entry proposal and accordingly it was listed in the 33rd EAC meeting for violation cases. However, PP did not attend the meeting. Now having informed by the PP that Industry sector has appraised this project and granted EC, therefore EAC (violation) opined and recommend that proposal along with the file may be returned to the Industry sector for further necessary action at their end.

43.4.7. Proposed residential cum commercial project at Nilemore village, Vasai Tal, Palghar District, Maharashtra State by M/s Anil R Gupta - Further consideration for Terms of Reference Proposal No. IA/MH/MIS/63953/2017 and File No. 23-3/2017-IA.III

Observations and recommendations of committee of 1st EAC meeting held on 22nd June, 2017:

During appraisal of the proposal, the Committee noted the following:-

- Initially, sanctions were obtained by the individual landowners on 23rd September, 2009. Later, all the plots were amalgamated on 11th July, 2012 for better planning purpose and infrastructure in the name of M/s Anil R. Gupta.
- (ii) The proposed residential project involves construction of 628614.14 sqm of built up area in total plot area of 378746.39 sqm at Nilemore village, Vasai Taluka in District Thane (Maharashtra) by M/s Anil R Gupta.
- (iii) Based on the recommendations of SEAC, ToR for the project was issued on 5th October, 2012.
- (iv) The proposal for grant of EC was first considered by the SEAC in its meeting held on 24th March, 2014 under Category 8(a) B1 as per the EIA Notification, 2006. The Committee noted that the construction was already taken up at the project site without obtaining prior EC. Based on their observations, show cause notice was issued by the Environment Department of the State Government on 3rd June, 2014. In reply dated 12th June, 2014, the project proponent themselves admitted the total construction area of 134184.97 sqm.
- (v) The proposal was further considered by the SEAC in its meetings held on 1st February, 2015
 & 17th November, 2015. The SEAC was informed about the action taken on violations by the Environment Department of the State Government vide their letter dated 8th December,

2014, and the criminal case No.88/2015 dated 21st January, 2015 filed before the First Class Judicial Magistrate, Vasai by the Maharashtra Pollution Control Board (MPCB). The SEAC in its 40th meeting held on 17th November, 2015 decided to recommend the proposal to SEIAA for grant of EC subject to compliance of certain conditions.

- (vi) During 95th meeting of SEIAA held on 12th January, 2016, the Authority noted the recommendations of the SEAC and also the case filed against the project proponent for construction of 52304.26 sqm without obtaining prior EC required under the EIA Notification, 2006. The SEIAA further observed and concluded that in view of the blatant violation and disregard of the provisions contained in the Environment (Protection) Act, 1986, the proposal was not a fit case for grant of EC and to defer the case till the criminal case No.88/2015 dated 21st January, 2015 filed before the First Class Judicial Magistrate, Vasai is decided.
- (vii) The project proponent informed to the EAC that the total construction area as on today is 463274.76 sqm.

The EAC, after deliberations on the proposal in terms of the provisions of the MoEF&CC Notification dated 14th March, 2017, noted that the project continued even after the issue of show cause notice on 3rd June, 2014 by the Environment Department of State Government, and the area of 463274.76 sqm already built up as on today without obtaining the prior EC, and thus amounts to blatant violation of the provisions of the EP Act, 1986.

The Committee also observed the discrepancy in respect of construction area reported to SEAC/SEIAA on 12th January, 2016 and the State Government of Maharashtra on 12th June, 2014.

In order to have the actual scenario and to recommend for actions accordingly, the EAC desired to know the physical progress of the project as on when the amalgamation of plots was executed, application was made for grant of EC, proposal was considered by the SEAC and SEIAA on 17th November, 2015 and 12th January, 2016 respectively, and also on 14th March, 2017 (date of issue of the Notification) in the form of an undertaking on oath. The Committee also desired to seek information from the State Government whether the case already filed against the project proponent was for violation of the EP Act, 1986.

Observations and recommendations of committee of EAC in its 43rd meeting (present meeting) held during 08th – 09th February, 2021:

Project Proponent did not attend the meeting. Therefore, EAC opined that Ministry may initiate action and issue necessary directions to the Project Proponent as may be deemed fit.

43.4.8. Capacity expansion of Chlorinated Paraffin Plasticizer and Hydrochloric Acid (By product) Manufacturing Unit at Village DandilaKhurd, Garhwa Road, Tehsil Bishrampur, P.O. Rehla, District Palamau (Jharkhand) by M/s Manav Chemicals - Further consideration for Terms of Reference Proposal No. IA/JH/IND2/63794/2017 and File No. 23-7/2017-IA.III

Project Proponent along with the consultant made the detailed presentation and provided following information to the EAC:

M/s. Manav Chemicals has existing Chlorinated paraffin plasticizers and Hydrochloric Acid manufacturing unit at Garhwa Road, P.O. Rehla, District: Palamau (Jharkhand). First manufacturing Unit established with 4x6 MT reactors for production of 15 MT/day Chlorinated paraffin plasticizer I & II and 30 MT/day Hydrochloric Acid (By Product) in the year 2005. The first expansion was done by setting up 2 x 6 MT reactors during the financial year 2008-09 for production of 30 MT/day Chlorinated paraffin plasticizer and 60 MT/day Hydrochloric Acid without taking prior Environmental Clearance. Second Expansion was made during 2014-15 by setting up 6 x 8 MT reactors for production of 40 MT Chlorinated paraffin plasticizer and 80 MT/day Hydrochloric Acid

Chronology: The plant was earlier setup with the consent to establish dated **15/7/2005** from the **Jharkhand State Pollution Control Board (JSPCB).** Subsequently, the unit is reported to be in operation with consent to operate renewed from time to time by the JSPCB. The consent to operate was valid upto 31st December, 2019 for existing capacity. After that JSPCB asked to take environment clearance before renewal of consent. The chronology of events for seeking EC, deliberations by the respective authorities and the actions taken are reported to be as under:-

The said project/activity is covered under **category A** of item **5(f)** "Synthetic Organic Chemicals" of the Schedule to the EIA Notification, 2006, and requires prior EC from Expert Appraisal Committee, MoEF&CC.

Action taken by the State Government/SEIAA: Credible action has been taken by State Government/SPCB against the project proponent under section 19 of the EP Act, 1986 & Closure Notice has been issued for the Project on 09.04.2019. JSPCB has issued CTO on dated 22nd Oct. 2019 Vide Letter No. JSPCB/HO/RNC/CTO-2182959/2019/2159. In the CTO under Specific Conditions it is clearly directed in to Condition No. 1 and 5 to M/s. Manav Chemicals. Condition are as follows:

- That, the occupier shall not make any alteration, addition, deletion and modification in the plant without prior clearance from the Board.
- That, the occupier shall not operate the expanded part without obtaining EC, CTE and CTO for the same.

Complaint case filed by the State Government/State Pollution Control Board: A complaint petition has been filed on behalf of petitioner Mr. Raghvendra Narayna Kashyap v/s the Environment (Protection) Act against accused Ramesh Kumar and others vide case no. 682 dated 11/4/2019.

Observations and recommendations of committee of 1st EAC meeting held on 22nd June, 2017:

The EAC, after detailed deliberations on the proposal in terms of the provisions of the MoEF&CC Notification dated 14th March, 2017, confirmed the case to be of violation of the EIA Notification, 2006 and recommended for the following: -

- (i) The State Government of Jharkhand to ensure compliance of the directions under section 5 of the EP Act, 1986 issued by MoEF&CC.
- (ii) The State Government/SPCB shall take action against the project proponent under section 19 of the EP Act, 1986 and further, no Consent to Operate to be issued till the project is granted the EC.
- (iii) After ensuring the actions at (i) & (ii) above, grant of Terms of Reference for undertaking EIA and preparation of Environment Management Plan (EMP) as enumerated in Annexure-II.
- (iv) The project proponent shall be required to submit a bank guarantee equivalent to the amount of remediation plan and natural and community resource augmentation plan with the SPCB prior to the grant of EC. The quantum shall be recommended by the EAC and finalized by the regulatory authority. The bank guarantee shall be released after successful implementation of the EMP, followed by recommendations of the EAC and approval of the regulatory authority.

Observations and recommendations during the 24th EAC meeting held on 22nd -24th July 2019:

PP along with consultant made the presentation on the information sought in the 1st meeting by the EAC. EAC after detailed deliberation deferred the project for want of following information:

1. Latest compliance report of CTO.

2. Submit the certificate from the State PCB regarding stopping date of the expansion unit i.e 30 TPD (10950 TPA) for Chlorinated paraffin plasticizer and 60 TPD (21900 TPA) for Hydrochloric acid.

3. Year wise production details from 2005 to till today.

Observations and recommendations of committee of EAC in its 43rd meeting (present meeting) held during 08th - 09th February,2021:

Information sought by the EAC in the 24th meeting was submitted to the Ministry through Parivesh Portal. Accordingly, proposal was discussed in the 43rd meeting (present meeting). After detailed presentation by the PP, EAC noted that PP has gone for expansion without taking prior environment clearance. Credible action has been taken by State Government/SPCB against the project proponent under section 19 of the EP Act, 1986 & Closure Notice has been issued for the Project on 09.04.2019. JSPCB has issued CTO on dated 22nd Oct. 2019 Vide Letter No. JSPCB/HO/RNC/CTO-2182959/2019/2159. In the CTO under Specific Conditions it was directed that the occupier shall not operate the expanded part without obtaining EC, CTE and CTO. The EAC, after detailed deliberations on the proposal in terms of the provisions of the MoEF&CC Notification dated 14th March, 2017, confirmed the case to be of violation of the EIA Notification, 2006 and **recommended** for issuing Standard Term of Reference along with the following specific Term of Reference for undertaking EIA and preparation of Environment Management Plan (EMP):

- i. Detailed status of Court case filed by the MPCB against the PP under the Environment (Protection) Act, 1986 for violation of EIA Notification 2006, shall be submitted
- ii. The project proponent shall be required to submit a bank guarantee equivalent to the amount of remediation plan and natural and community resource augmentation plan with the SPCB prior to the grant of EC. The quantum shall be recommended by the EAC and finalized by the regulatory authority. The bank guarantee shall be released after successful implementation of the EMP, followed by recommendations of the EAC and approval of the regulatory authority.
- iii. Assessment of ecological damage with respect to air, water, land and other environmental attributes. The collection and analysis of data shall be done by an environmental laboratory duly notified under the Environment (Protection) Act, 1986, or an environmental laboratory accredited by NABL, or a laboratory of a Council of Scientific and Industrial Research (CSIR) institution working in the field of environment.
- iv. Preparation of EMP comprising remediation plan and natural and community resource augmentation plan corresponding to the ecological damage assessed and economic benefits derived due to violation.
- v. The remediation plan and the natural and community resource augmentation plan to be prepared as an independent chapter in the EIA report by the accredited consultants
- vi. One season fresh base line data shall be collected for preparation of EIA/EMP reports.
- vii. The PP is required to conduct public hearing as per EIA notification, 2006 and as amended thereof.
- viii. The PP should also address the all the issues raised during the already held public hearing along with commitments made and with fund provision to address above issues in tabular form to be submitted along with EIA/EMP report.
- ix. Certified production details shall be submitted since inception of the industry.
- x. A plan for implementation of ZLD to be submitted.
- xi. Layout plan earmarking space for development of peripheral green belt.
- xii. Transportation details to be submitted in the EIA/MEP report.
- xiii. Latest certified compliance report of CTO from the SPCB shall be submitted.
- xiv. Details of any Court Case pending against the project proponent.
- 43.4.9. Proposal for Colour Granite Mine at Khazipur village, Karimnagar Mandal, Karimnagar District (Telangana) by M/s Sri Venkatesh Granites - Further

consideration for Terms of Reference Proposal No. IA/TG/MIN/63702/2017 and File No. 23-9/2017-IA.III

The project was reconsidered based on the Ministry's OM dated 30th May 2018 in its 10th EAC meeting (violation) held on 11-12th , July 2018 Observations and recommendations of committee:

The EAC, after detailed deliberations on the proposal in terms of the provisions of the MoEF&CC Notification dated 14th March, 2017, confirmed the case to be of violation of the EIA Notification, 2006 and recommended to defer the proposal for want of following information from project proponent:

- (i) Submission of cluster certificate from District Mines and Geology to ascertain the category of the project i.e. B1 or B2 as per the Ministry's Notification dated 15.01.2016 & 01.07.2016.
- (ii) Details of past production of mine since its inception duly authenticated by Department of Mines & Geology, State Government.
- (iii) Validity of LOI/mine lease along with the documentary proof.
- (iv) To submit the KML/Shape Files of the mine lease area at the time of presentation before EAC.

Observations and recommendations of committee of EAC in its 43rd meeting (present meeting) held during 08th – 09th February,2021:

EAC observed that proposal was listed earlier for appraisal and deferred as EAC sought certain additional information. This time PP did not attend, therefore EAC opined that Ministry may initiate action and issue necessary directions to the Project Proponent as may be deemed fit.

43.4.10. Residential apartment 'COSMOCITY' by M/s Puravankara Limited at Survey Nos: 53/3,53/4,53/10B,55,56/1,57/2 & 57/4, Pudupakkam Village Chengalpattu Taluk, District Kancheepuram (Tamilnadu) Further consideration for Terms of Reference Proposal No. IA/TN/NCP/63558/2017 and File No. 23-19/2017-IA.III

Observations and recommendations during the 2nd EAC meeting held on 15-16 January, 2018:

The EAC, after detailed deliberations on the proposal in terms of the provisions of the MoEF&CC Notification dated 14th March, 2017, noted that the construction continued even after show cause notices issued by the Ministry for non compliance of the earlier EC conditions not settled yet and even continued to do construction for expansion without obtaining prior EC for the expansion project (990 dwelling units), and thus amounts to blatant violation of the EIA Notification, 2006 and recommended for the following:-

- (i) The project proponent shall submit the monitoring report on compliance status of the earlier EC conditions (EC dated 24th July, 2008 issued by SEIAA) from the Regional Office of the Ministry to conclude the show cause notices issued by the Ministry.
- (ii) The EAC The State Government/SPCB to take action against the project proponent under the provisions of section 19 of the Environment (Protection) Act, 1986, and further no consent to operate or occupancy certificate to be issued till the project is granted EC.

Observations and recommendations of committee of EAC in its 43rd meeting (present meeting) held during 08th – 09th February, 2021:

EAC observed that PP did not attend the meeting and therefore EAC opined that Ministry may initiate action and issue necessary directions to the Project Proponent as may be deemed fit.

43.4.11. Discussion on any other item with permission of the Chair

The Hon'ble NGT order dated 30.06.2020 in the Original Application No. 136 of 2017 (SZ) was deliberated on its applicability to the mining proposals submitted to the violation sector.

EAC observed that Hon'ble NGT order dated 30.06.20 has directed that;

- I. The applications which are pending as on 31.3.2016 for Environment Clearance have to be treated as normal applications and not violation applications and the authorities are directed to dispose of those applications in accordance with law.
- II. The persons, who have not filed applications on or before 31.3.2016 and filed thereafter, can be treated as violation applications and the MoEF & CC/SEIAA is directed to dispose of those applications as violation cases in accordance with law.
- III. It is also made clear that all mining leases, either major or minor, even less than 5 hectares area, has to apply and get Environment Clearance as per the amended EIA Notification dated 15.1.2016. This will apply to the existing mining leases as well.

Regarding applicability of above Order to the mining proposals submitted to the violation sector, EAC opined that Hon'ble NGT order may not be applicable to all cases whose applications are pending with the Ministry prior to 31.03.2016. Infact genesis of the case is related to the ambiguity on the applicability of the EIA Notification 2006 to mine leases having area less than 5 hectares for major minerals. Therefore, above order, is applicable for mine leases of major minerals having area less than 5 hectares.

However, as suggested by the Senior Consultant of MoEFCC, EAC opined that matter may be referred to the Ld. Panel Counsel appeared in the matter on behalf of the Ministry or legal opinion may also be sought from MoLJ, for clarity.
