MINUTES OF 77th MEETING OF EXPERT APPRAISAL COMMITTEE (INFRASTRUCTURE-2) HELD ON 30thNOVEMBER, 2021.

PROCEEDINGS

77.1 Opening Remarks of the Chairman: The Chairman and Members extended warm welcome with each other and other participants of the meeting. Thereafter, the meeting was opened to start proceeding as per the agenda adopted for this meeting.

77.2 Confirmation of Minutes of 76th Meeting of Expert Appraisal Committee (Infrastructure-2) held on 16th November, 2021.

The Expert Appraisal Committee (Infrastructure-2), hereinafter called the EAC, was informed that no representation has been received regarding projects considered in 76th meeting. Minutes of 76th meeting of EAC were confirmed. The typo errors, if any noticed during processing of these cases may be corrected in the light of facts and figures provided by the respective Project Proponent.

77.3 Consideration of Proposals: The EAC considered proposals as per the agenda adopted for 77th meeting. The details of deliberations held and decisions taken in the meeting are as under:

AGENDA ITEM NO. 77.3.1

Proposed residential project to be developed with built-up area of 97,466.3 sqm. at Pantheerankavu Village, Olavanna Panchayat, Kozhikode Taluk and District, Kerala by M/s CL Township LLP - Environmental Clearance

(IA/KL/MIS/235988/2021; F. No. 21-106/2021-IA-III)

- **1.** The Project Proponent (M/s. CL Township LLP) along with his consultant 'M/s. Environmental Engineers & Consultants Pvt. Ltd.', made a presentation on the key parameters and salient features of the project to the EAC (Infra-2). The EAC took note of following key parameters and salient features of the project, aspresented during the meeting; provided in the brief and application for this project:
 - i. The project is located atsurvey nos. 36/6, 35/1B, 59/1B, 60/1, Pantheerankavu Village, Olavanna Panchayat, Kozhikode Taluk and District, Kerala with coordinates from 11°12'59.57"N to 11°13'7.49"N Latitude and 75°51'9.47"E to 75°51'14.45"E E Longitude.
- ii. The project is new.

iii. The total plot area is 18,859.02 sqm., FSI area is 73,738.76 sqm. and total construction (Built-up) area is 97,466.30 sqm. The project will comprise of 1 no. of residential apartment block. Total 476 nos. of flats shall be developed. Maximum height of the building is 90 m. The details of the building are as follows:

- iv. During construction phase, total water requirement is expected to be 89 KLD which will be met by recycled water from portable STP/stored rain water (tank) for construction purposes and well water/Kerala Water Authority (KWA) supply for meeting the domestic water requirement of 11 KLD.Portable STP will be provided for the disposal of waste water. Temporary sanitary toilets will be provided during peak labor force.
- v. During operational phase, total water demand of the project is expected to be 383 KLD and the same will be met by 218 KLD fresh water from stored rain water tanks/KWA/well water and 165 KLD recycled water. Wastewater generated (267 KLD) will be treated in STP of total 320 KLD capacity. 240 KLD of treated wastewater will be recycled and re-used (115 KLD for flushing, 50 KLD for gardening etc.). About 75 KLD of excess treated water from STP will be used for farming & horticulture purposes of Olavanna Grama Panchayat.
- vi. About 1 TPD of solid waste will be generated in the project. The biodegradable waste (0.5 TPD) will be processed in bio-gas generation unit/bio-bin unit and the non-biodegradable waste generated (0.5 TPD) will be handed over to authorized local vendor. An area equivalent of about 250 sqm. for about 15 days storage of non-biodegradable waste wouldbe provided. The hazardous waste (used oil & discarded batteries attached to D.G. sets) will be stored in the designated services area and will be disposed to CPCB/SPCB authorized vendors.
- vii. There are two old buildings (built-up area of 80 sqm.) within the site which are in dilapidated condition and the same would be demolished. The salvageable materials from the demolition debris would be recovered. The remaining demolition debris and the construction debris would be used for site preparatory works.
- viii. The total power requirement during operation phase is 6,500 kW and will be met through Kerala State Electricity Board (KSEB) and DG Sets (500 kVA x 1 No and 600 kVA x 2 Nos) as standby. Total power requirement during construction phase is 100 kW and will be met through KSEB & DG Sets (standby).
 - ix. Rooftop rainwater of buildings will be collected in RWH tanks of total 2,025 KL capacity for harvesting after filtration.

- x. Parking facility for 550 cars + 1,375 two wheelers is proposed to be provided as per the local norms. Provision for charging for electrically operated vehicles (20%) is proposed in each parking floor.
- xi. Rooftop solar PV installation of 302 kWp capacity shall be provided to meet 10.1% of the connected load.
- xii. Total area for landscaping proposed is 10,037.61 sqm. (about 53% of total plot area). 150 trees will be cut and 1,800 trees are proposed to be planted within the site.
- xiii. The total excavated soil is about 23,200 cu.m. The excavated earth of about 2,200 cu.m. will be preserved for landscaping purposes, 7,100 cu.m. for backfilling purposes,5,600 cu.m. for internal road construction and balance 8,300 cu.m. will be stored in the identified place at Chelannur located about 25 km from the site.
- xiv. The project requires height clearance from airport authority for which application has been submitted.
- xv. The project is not located in Critically Polluted area.
- xvi. The project is not located within 10 km of Eco Sensitive Zone. NBWL Clearance is not required.
- xvii. Forest Clearance is not required.
- xviii. No court case is pending against the project.
- xix. Expected timeline for completion of the project About 48 months from the date of start of construction.
- xx. Investment/Cost of the project is ₹350 Crores.
- xxi. Employment potential About 150 persons during construction phase and about 300 persons during operation phase.
- xxii. Benefits of the project Employment opportunities andrevenue to the State. The residential project would provide better residential facilities with supporting infrastructure facilities and amenities to the residents.
 - **2.** The EAC noted that the project/activity is covered under category 'A' of item 8(a) Building and Construction projects' of the Schedule to the EIA Notification, 2006 and its subsequent amendments, and requires appraisal at State level. However, due to non-existence of SEIAA in Kerala, it requires appraisal at Central level by sectoral EAC.
 - **3.**The EAC (Infra-2), based on the information submitted and clarifications provided by the Project Proponent and detailed discussions held on all the issues, recommended granting environmental clearance to the project subject to the following specific conditions and other Standard EC Conditions as specified by the Ministry vide OM dated 4th January, 2019 for the said project/activity while considering for accord of environmental clearance:
 - i. Abstraction of ground water shall be subject to the permission of Central Ground Water Authority (CGWA). Fresh water requirement shall not exceed 218 KLD during operational phase.
 - ii. As proposed, wastewater shall be treated in an onsite STP of 320 KLD capacity. At-least 165 KLD of treated water from the STP shall be recycled and re-used for flushing (115 KLD) and for gardening (50 KLD). Excess treated water from STP (75 KLD)shall be used for

- farming & horticulture purposes of Olavanna Grama Panchayat, as proposed. PP shall submit MoU for the disposal of excess treated water (outside the site) to the Regional Office of MoEF&CC along with six-monthly compliance report.
- iii. The project proponents would commission a third-party study on the implementation of conditions related to quality and quantity of recycle and reuse of treated water, efficiency of treatment systems, quality of treated water being supplied for flushing (specially the bacterial counts), comparative bacteriological studies from toilet seats using recycled treated waters and fresh waters for flushing, and quality of water being supplied through spray faucets attached to toilet seats.
- iv. Area for greenery shall be provided as per the details provided in the project document i.e., area under plantation/greenery will be at-least 10,037.61 sqm. As proposed, at least 1800 trees shall be maintained during the operation phase of the project. The landscape planning should include plantation of native species. A minimum of 01 tree for every 80 sqm. of land should be planted and maintained. The existing trees will be counted for this purpose. Plantations to be ensured species (cut) to species (planted). The species with heavy foliage, broad leaves and wide canopy cover are desirable. Water intensive and/or invasive species should not be used for landscaping.
- v. No tree can be felled/transplanted unless exigencies demand. Where absolutely necessary, tree felling shall be with prior permission from the concerned regulatory authority. Old trees should be retained based on girth and age regulations as may be prescribed by the Forest Department. Plantations to be ensured species (cut) to species (planted).
- vi. Where the trees need to be cut with prior permission from the concerned local Authority, compensatory plantation in the ratio of 1:10 (i.e., planting of 10 trees for every 1 tree that is cut) shall be done and maintained. Plantations to be ensured species (cut) to species (planted). Area for green belt development shall be provided as per the details provided in the project document.
- vii. The local bye-law provisions on rain water harvesting should be followed. If local bye-law provision is not available, adequate provision for storage and recharge should be followed as per the Ministry of Urban Development Model Building Byelaws, 2016. As proposed, RWH tank of total 2,025 KL capacity shall be provided by PP for rain water harvesting after filtration.
- viii. The solid waste shall be duly segregated into biodegradable and non-biodegradable components and handled in separate area earmarked for segregation of solid waste, as per SWM Rules, 2016. As committed, biodegradable waste shall be utilized through bio-gas generation unit/bio-bin system to be installed within the site. Inert waste shall be disposed off as per norms at authorized site. The recyclable waste shall be sold to authorized vendors/recyclers. Construction & Demolition (C&D) waste shall be segregated and

- managed as per C&D Waste Management Rules, 2016.
- ix. The PP shall provide electric charging points in parking areas for evehicles as committed.
- x. As committed, roof top solar energy installation of 302 kWp capacity shall be implemented.
- xi. The Environmental Clearance to the project is primarily under provisions of EIA Notification, 2006. The Project Proponent is under obligation to obtain approvals/clearances under any other Acts/Regulations or Statutes as applicable to the project.

Proposed Residential Building Project 'Artech L'Attitude' with built-up area of 59878.50 sqm. at Sreekariyam, Ulloor Village, Thiruvananthapuram Taluk & District, Kerala by M/s Artech Realtors Private Limited - Environmental Clearance

(IA/KL/MIS/238013/2021; F. No. 21-107/2021-IA-III)

The EAC noted that the Project Proponent (M/s. Artech Realtors Private Limited) and his consultant 'M/s. ULTRA-TECH' did not submit the project documents to the committee members before the stipulated time. The PP and the consultant also expressed technical difficulties in video conferencing. Accordingly, the EAC (Infra-2) decided to defer the project and asked the project proponent to circulate the project documents to the committee members in advance and present the proposal in the forthcoming meeting of EAC.

Proposed Shopping Mall cum Fun Park project with built-up area of 48,094 sqm. at Kodencheri Village & Panchayat, Thamarassery Taluk, Kozhikode District, Kerala to be developed by M/s Ozo Mall LLP - Environmental Clearance

(IA/KL/MIS/239672/2021; F. No. 21-104/2021-IA-III)

1. The Project Proponent(M/s. Ozo Mall LLP) along with his consultant 'M/s. Environmental Engineers & Consultants Pvt. Ltd.', made a presentation on the key parameters and salient features of the project to the EAC (Infra-2). The EAC took note of following key parameters and salient features of the project, as presented during the meeting; provided in the brief and application for this project:

- i. The project is located at survey nos15/3923, 38/7, 38/180, 15/3921, 15/7243, 15/7244, 15/7245, 15/7246, 15/7247, 15/7248, 15/249, 38/270, 38/271, 38/272, 38/723, Kodencheri Village & Panchayat, Thamarassery Taluk, Kozhikode District, Kerala with coordinates from 11°28'34.94"N to 11°28'59.69"N Latitude and 76°00'23.25"E to 76°00'40.07"E Longitude.
- ii. The project is new.
- iii. The total plot area is 61,639 sqm. and total construction (Built-up) area is 48,094 sqm. The project will comprise of shopping retail area, restaurant/food courts (700 seats), indoor amusement &theme park along with outdoor water park. Maximum height of the building is 20 m. The details of building are as follows:

- iv. During construction phase, water requirement is expected to be 60 KLD, which will be met by recycled water from portable STP/stored rainwater tank for construction purposes and Kerala Water Authority (KWA) and ground water supply for meeting the domestic water requirement of 7 KLD. Portable STP will be provided for disposal of wastewater. Temporary sanitary toilets will be provided during peak labour force.
- v. During operational phase, total water demand of the project is expected to be 294 KLD and the same will be met by 115 KLD fresh water from stored rainwater tank/KWA/ground water (4 nos wells) and 179 KLD recycled water. Wastewater generated (199 KLD) will be treated in STP of total 240 KLD capacity. 179 KLD of treated wastewater will be generated which will be completely recycled and re-used within the site for flushing(154 KLD), gardening (5 KLD)and for make-up water requirement for cooling towers attached with the HVAC system (20 KLD).
- vi. About 1,207 kg/day solid waste will be generated in the project. The biodegradable waste (604 kg/day) will be processed in bio-bin system and the non-biodegradable waste generated (603 kg/day) will be handed over to authorized local vendor. An area equivalent of about 250 sqm. for about 15 days storage of non-biodegradable waste would be provided. The hazardous waste (used oil & discarded batteries attached to D.G. sets) will be stored in the designated services area and will be disposed to CPCB/SPCB authorized vendors.
- vii. The total power requirement during operation phase is 3,500 kW (connected load) and will be met from Kerala State Electricity Board (KSEB) and DG Sets (500 kVA x 3 Nos + 750 kVA x 3 Nos+ 600 kVA x

- 1 No) as standby. Total power requirement during construction phase is 100 kW and will be met from KSEB and DG Sets (standby).
- viii. Rooftop rainwater of buildings will be collected in RWH tanks of total 1,687.50 KL (562.50 KL x 3 Nos) capacity for harvesting after filtration.
 - ix. Parking facility for 586 cars + 735 two wheelers + 10 buses is proposed to be provided as per local norms. Provision for charging for electrically operated vehicles (20%) is proposed in the parking area.
 - x. Solar power plant of 572 kWp capacity will be installed to meet about 16.34% of connected load.
- xi. The total excavated soil is about 6,500 cu.m. About 1,600 cu.m. of excavated soil will be used for back filling work and 1,800 cu.m. topsoil will be preserved for landscaping. The remaining excavated earth of 3,100 cu.m. will be used for internal road construction work.
- xii. Malabar Wildlife Sanctuary is located about 6 km (NW) from the project site. An application for obtaining NBWL clearance has been submitted at MoEF&CC vide proposal no. FP/KL/Others/6110/2021 dated 20.11.2021. However, the project site is located outside the eco-sensitive zone of the Malabar Wildlife Sanctuary as specified in draft notification issued by MoEF&CC dated 05.08.2020.
- xiii. The project is not located in Critically Polluted area.
- xiv. Forest Clearance is not required.
- xv. No court case is pending against the project.
- xvi. Total area for landscaping proposed is 17,288 sqm. (about 28% of total plot area). 100 trees will be cut and it is proposed to plant about 1,800 tree species within the site.
- xvii. Expected timeline for completion of the project About 36 months from the date of start of construction
- xviii. Investment/Cost of the project is ₹200 Crores.
 - xix. Employment potential About 150 persons during construction phase and about 1,100 persons during operation phase.
 - xx. Benefits of the project Employment opportunities generation and revenue to the State. The project would provide better commercial retail shopping area and entertainment facilities with supporting infrastructure facilities and amenities to the people. Direct and indirect employment opportunities; The potential for employment and access to new services may draw people to the area around the project. There will be an increase in economic activity and employment for the local community, local skills development.
 - **2.** The EAC noted that the project/activity is covered under category 'A' of item 8(a) Building and Construction projects' of the Schedule to the EIA Notification, 2006 and its subsequent amendments, and requires appraisal at State level. However, due to non-existence of SEIAA in Kerala, it requires appraisal at Central level by sectoral EAC.
 - **3.** The EAC (Infra-2), based on the information submitted and clarifications provided by the Project Proponent and detailed discussions held on all the issues, recommended granting environmental clearance to the project subject

to the following specific conditions and other Standard EC Conditions as specified by the Ministry vide OM dated 4th January, 2019 for the said project/activity while considering for accord of environmental clearance:

- i. Prior Clearance from standing committee of NBWL should be obtained before commencing the project.
- ii. Abstraction of ground water shall be subject to the permission of Central Ground Water Authority (CGWA). Fresh water requirement shall not exceed 115 KLD during operational phase.
- iii. As proposed, wastewater shall be treated in an onsite STP of 240 KLD capacity. At-least 179 KLD of treated water from the STP shall be recycled and re-used for flushing (154 KLD) and for gardening (5 KLD)and for make-up water requirement for cooling towers attached with the HVAC system (20 KLD). There shall be no discharge of treated water outside the project premises, as committed.
- iv. The project proponents would commission a third-party study on the implementation of conditions related to quality and quantity of recycle and reuse of treated water, efficiency of treatment systems, quality of treated water being supplied for flushing (specially the bacterial counts), comparative bacteriological studies from toilet seats using recycled treated waters and fresh waters for flushing, and quality of water being supplied through spray faucets attached to toilet seats.
- v. Area for greenery shall be provided as per the details provided in the project document i.e., area under plantation/greenery will be at-least 17,288 sqm. As proposed, at least 1800 trees shall be maintained during the operation phase of the project. The landscape planning should include plantation of native species. Expansion of Dr.Babasaheb Ambedkar International Airport at Nagpur, Maharashtra by M/s MIHAN India Limited (MIL) – Terms of Reference

(IA/MH/MIS/239062/2021; F. No. 21-103/2021-IA-III)

1. The Project Proponent (M/s MIHAN India Limited (MIL)) along with his consultant 'M/s. ABC Techno Labs India Private Limited', made a presentation on the key parameters and salient features of the project to the EAC (Infra-2). The EAC took note of following key parameters and salient

features of the project, as presented during the meeting; provided in the brief and application for this project:

- i. The project is located at Sonegaon on National Highway 44, Nagpur Dhantoli Road with coordinates 21°5′5.08" to 21°6′35.23" NLatitude and 79°02′3.84″E to 79°3′4.43"ELongitude and altitude of 306-320 m above MSL.
- ii. The proposal is for 'Expansion'.
- iii. Earlier, the project was granted Environmental Clearance from then MoEF vide letter no. 10-14/2004-IA-III dated 01.06.2006.The proposed expansion project involves Extension of Phase I and Phase II Runway with RESA, Taxiway, Apron, GSE Area, Isolation Bay, Terminal Building and Miscellaneous Works.
- **2.** The EAC noted that the project/activity is covered under category 'A' of item 7(a) 'Airports' of the Schedule to the EIA Notification, 2006 and its subsequent amendments, and requires appraisal at Central level by sectoral EAC.
- **3.** The EAC observed that the existing Environmental Clearance was issued to the project in the name of M/s Maharashtra Airport Development Company Limited (MADC). However, the project proponent in the instant proposal has applied in the name of M/s MIHAN India Limited. The PP explained that the airport is being operated since 2009 by M/s MIHAN India Limited which is a Joint Venture of M/s MADC (51%) and M/s Airports Authority of India (AAI) (49%).
- **4.** The EAC (Infra-2), based on the information and clarifications provided by the Project Proponent and detailed discussions held on all the issues, decided to defer the proposal and advised the PP to withdraw the instant proposal and apply for expansion only after obtaining transfer of EC in the name of M/s MIHAN India Limited.

1.The Project Proponent (Shri Mathew Kuruvilla & Shri Raunaq Kuruvilla Mathew) along with his consultant 'M/s. Environmental Engineers & Consultants Pvt. Ltd.', made a presentation on the key parameters and salient features of the project to the EAC (Infra-2). The EAC took note of

following key parameters and salient features of the project, aspresented during the meeting; provided in the brief and application for this project:

- i. The project is located at Re-Survey Nos. 60, 61, 62, 13, 14/1-1, 14/2, 14/1, 22, 19, 51 in Block 52 in Muttambalam Village, Kottayam Municipality, Kottayam Taluk & District, Kerala with coordinates 09°35'43.29"N to 09°35'44.30"N Latitude and 76°31'23.68"E to 76°31'30.12"E Longitude.
- ii. The project is new.
- iii. The total plot area is 11,403.06 sqm. and total construction (Built-up) area is 47,923.71 sqm. The project will comprise of 2nos buildings. The commercial complex shall consist of shopping mall retail area, multiplex (1,000 seats), assembly hall (1,500 seats), restaurant/food court (500 seats) and office space with supporting infrastructure facilities. During construction phase, total water requirement is expected to be 60 KLD which will be met by recycled water from portable STP/stored rain water tank for construction purposes and Kerala Water Authority (KWA) and ground water supply for meeting the domestic water requirement of 7 KLD. Portable STP will be provided for disposal of waste water. Temporary sanitary toilets will be provided during peak labor force.
- v. During operational phase, total water demand of the project is expected to be 259 KLD and the same will be met by 92 KLD fresh water from stored rain water tanks (400 KL total capacity)/ KWA/ground water (2 nos open wells) and 167 KLD recycled water. Wastewater generated (185 KLD) will be treated in STP of total 222 KLD capacity. 167 KLD of treated wastewater will be generated which will be completely recycled and re-used for flushing (145KLD), gardening (2 KLD) and for make-up water requirement for cooling towers attached with the HVAC system (20 KLD).
- vi. About 1,100 kg/day solid waste will be generated in the project. The biodegradable waste (550 kg/day) will be processed through bio-bin system and the non-biodegradable waste generated(550 kg/day) will be handed over to authorized local vendor. An area equivalent to200 sqm for about 10-15 days storage of non-biodegradable waste would be provided. The hazardous waste (used oil & discarded batteries attached to D.G. sets) will be stored in the designated services area and will be disposed to CPCB/SPCB authorized vendors.

- vii. There is a small building (110 sqm. of built-up area) and temporary sheds existing at site which will be cleared during construction phase. The salvageable material will be recovered from the debris and the remaining demolition debris and the construction debris would be used for site preparatory works.
- viii. There is a narrow seasonal open drain (about 2 m wide) existing at site. This drain will be protected & maintained during construction phase and in operation phase.
- ix. The total power requirement during operation phase is 3,780 kW (connected load) and will be met from Kerala State Electricity Board (KSEB) & DG Sets (1,250 kVA x 1 nos + 500 kVA x 1 nos) as standby. Total power requirement during construction phase is 100 kW and will be met from KSEB & DG Sets (standby).
- x. Rooftop rainwater of buildings will be collected in RWH tank of total 400 KL capacity for harvesting after filtration.
- xi. Parking facility for 590 cars + 791 two wheelers is proposed to be provided against the requirement of 578 cars + 723 two wheelers respectively (according to local norms). Provision for charging for electrically operated vehicles (20%) is proposed in each parking floor.
- xii. The total excavated soil is about 40,258 cu.m. 8,350 cu.m. of excavated soil will be used for back filling work, 15,150 cu.m. of topsoil will be preserved for landscaping and the excess excavated earth of 16,758 cu.m. will be utilized for internal road construction.
- xiii. Proposed energy saving measures would save about 20% of power.
- xiv. Solar power plant of 431 kWp capacity will be installed to meet 11.40% of the connected load.
- xv. The project is not located in Critically Polluted area.
- xvi. The project is not located within 10 km of Eco Sensitive Zone. NBWL Clearance is not required.
- xvii. Forest Clearance is not required.
- xviii. No court case is pending against the project.
- xix. Total area for landscaping proposed is 1,316 sqm. (about 12% of total plot area). 11 trees will be cut and it is proposed to plant 250 trees within the site. 175 trees will be planted along the periphery.
- xx. Expected timeline for completion of the project About 36 months from the date of start of construction.
- xxi. Investment/Cost of the project is ₹242 Crores.
- xxii. Employment potential –About 150 persons during construction phase and about 775 persons during operation phase.
- xxiii. Benefits of the project The project would provide better commercial retail shopping facilities with supporting infrastructure facilities and amenities to the people. Direct and indirect employment opportunities; The potential for employment and access to new services may draw people to the area around the project. There will be an increase in economic activity and employment for the local community, local skills development. Employment opportunities generation and revenue to the State.

- **2.** The EAC noted that the project/activity is covered under category 'A' of item 8(a) Building and Construction projects' of the Schedule to the EIA Notification, 2006 and its subsequent amendments, and requires appraisal at State level. However, due to non-existence of SEIAA in Kerala, it requires appraisal at Central level by sectoral EAC.
- **3.**The EAC (Infra-2), based on the information submitted and clarifications provided by the Project Proponent and detailed discussions held on all the issues, recommended granting environmental clearance to the project subject to the following specific conditions and other Standard EC Conditions as specified by the Ministry vide OM dated 4th January, 2019 for the said project/activity while considering for accord of environmental clearance:
 - i. Abstraction of ground water shall be subject to the permission of Central Ground Water Authority (CGWA). Fresh water requirement shall not exceed 92 KLD during operational phase.
- ii. As proposed, wastewater shall be treated in an onsite STP of 222 KLD capacity. At-least 167 KLD of treated water from the STP shall be recycled and re-used for flushing (145KLD) and for gardening (2 KLD)and for make-up water requirement for cooling towers attached with the HVAC system (20 KLD). There shall be no discharge of treated water outside the project premises, as committed.
- iii. The project proponents would commission a third-party study on the implementation of conditions related to quality and quantity of recycle and reuse of treated water, efficiency of treatment systems, quality of treated water being supplied for flushing (specially the bacterial counts), comparative bacteriological studies from toilet seats using recycled treated waters and fresh waters for flushing, and quality of water being supplied through spray faucets attached to toilet seats.
- iv. Area for greenery shall be provided as per the details provided in the project document i.e., area under plantation/greenery will be at-least 1,316 sqm. As proposed, atleast250 trees shall be maintained within the site during the operation phase of the project and 175 trees shall be planted along the periphery. The landscape planning should include plantation of native species. A minimum of 01 tree for every 80 sqm. of land should be planted and maintained. The existing trees will be counted for this purpose. Plantations to be ensured species (cut) to species (planted). The species with heavy foliage, broad leaves and wide canopy cover are desirable. Water intensive and/or invasive species should not be used for landscaping.
- v. No tree can be felled/transplanted unless exigencies demand. Where absolutely necessary, tree felling shall be with prior permission from the concerned regulatory authority. Old trees should be retained based on girth and age regulations as may be prescribed by the Forest Department. Plantations to be ensured species (cut) to species (planted).
- vi. Where the trees need to be cut with prior permission from the concerned local Authority, compensatory plantation in the ratio of

- 1:10 (i.e., planting of 10 trees for every 1 tree that is cut) shall be done and maintained. Plantations to been sured species (cut) to species (planted). Area for green belt development shall be provided as per the details provided in the project document.
- vii. The local bye-law provisions on rain water harvesting should be followed. If local bye-law provision is not available, adequate provision for storage and recharge should be followed as per the Ministry of Urban Development Model Building Byelaws, 2016. As proposed, RWH tank of total 400 KL capacity shall be provided by PP for rain water harvesting after filtration.
- viii. The solid waste shall be duly segregated into biodegradable and non-biodegradable components and handled in separate area earmarked for segregation of solid waste, as per SWM Rules, 2016. As committed, biodegradable waste shall be utilized through bio-bin system to be installed within the site. Inert waste shall be disposed off as per norms at authorized site. The recyclable waste shall be sold to authorized vendors/recyclers. Construction & Demolition (C&D) waste shall be segregated and managed as per C&D Waste Management Rules, 2016.
 - ix. The PP shall provide electric charging points in parking areas for evenicles as committed.
 - x. As committed, roof top solar energy installation of 431 kWp capacity shall be implemented.
 - xi. The Environmental Clearance to the project is primarily under provisions of EIA Notification, 2006. The Project Proponent is under obligation to obtain approvals/clearances under any other Acts/Regulations or Statutes as applicable to the project.

Proposed Construction of New Integrated Terminal Building at Veer Savarkar Airport, Port Blair by M/s Airports Authority of India (AAI) – Environmental Clearance

The EAC noted that the proposal was recommended in its 69th Meeting held on 30th July, 2021. During processing of the file in the Ministry, the PP was asked to submit the Certified Compliance Report for earlier EC issued to the project vide letter no. 10-39/2010-I.A.III dated 27.05.2011. The PP submitted the same on Parivesh Portal vide dated 25.11.2021 and with due permission of the EAC-Chairman (Infra-2), the project was placed for reconsideration as additional agenda item. However, it was noted that the PP has not submitted the action taken report (ATR) to Integrated Regional Office (IRO), MoEF&CC. Accordingly, it was decided to re-consider the proposal only after the PP has submittedthe ATR to IRO, MoEF&CC.

Standard EC Conditions for Project/Activity 7(a): Airport

I. Statutory compliance:

- i. The project proponent shall obtain forest clearance under the provisions of Forest (Conservation) Act, 1980, in case of the diversion of forest land for non-forest purpose involved in the project.
- ii. The project proponent shall obtain clearance from the National Board for Wildlife, if applicable.
- iii. The project proponent shall prepare a Site-Specific Conservation Plan & Wildlife Management Plan and approved by the Chief Wildlife Warden. The recommendations of the approved Site-Specific Conservation Plan/Wildlife Management Plan shall be implemented in consultation with the State Forest Department. The implementation report shall be furnished along with the six-monthly compliance report (in case of the presence of schedule-I species in the study area).
- iv. The project proponent shall obtain Consent to Establish/Operate under the provisions of Air (Prevention & Control of Pollution) Act, 1981 and the Water (Prevention & Control of Pollution) Act, 1974 from the concerned State Pollution Control Board/Committee.
- v. The project proponent shall obtain the necessary permission from the Central Ground Water Authority, in case of drawl of ground water/from the competent authority concerned in case of drawl of surface water required for the project.
- vi. Clearance from Directorate General of Civil Aviation (DGCA) and Airports Authority of India (AAI) for safety and project facilities shall be obtained.
- vii. A certificate of adequacy of available power from the agency supplying power to the project along with the load allowed for the project should be obtained.
- viii. All other statutory clearances such as the approvals for storage of diesel from Chief Controller of Explosives, Fire Department, Civil Aviation Department shall be obtained, as applicable by project proponents from the respective competent authorities.

II. Air quality monitoring and preservation:

- i. The project proponent shall install system to carryout Ambient Air Quality monitoring for common/criterion parameters relevant to the main pollutants released (e.g., PM₁₀ and PM_{2.5} in reference to PM emission, and SO₂ and NOx in reference to SO₂ and NOx emissions) within and outside the airport area at least at four locations (one within and three outside the plant area at an angle of 120°each), covering upwind and downwind directions.
- ii. Diesel power generating sets proposed as source of backup power should be of enclosed type and conform to rules made under the Environment (Protection) Act, 1986. The height of stack of DG sets should be equal to the height needed for the combined capacity of all proposed DG sets. Use of low sulphur diesel. The location of the DG sets may be decided with in consultation with State Pollution Control Board.
- iii. A detailed traffic management and traffic decongestion plan shall be drawn up to ensure that the current level of service of the roads within a 05 kms radius of the project is maintained and improved upon after the implementation of the project. This plan should be based on cumulative impact of all development and increased habitation being carried out or proposed to be carried out by the project or other agencies in this 05 Kms radius of the site in different scenarios of space and time and the traffic management plan shall be duly validated and certified by the State Urban Development department and the P.W.D./competent authority for road augmentation and shall also have their consent to the implementation of components of the plan which involve the participation of these departments.
- iv. Soil and other construction materials should be sprayed with water prior to any loading, unloading or transfer operation so as to maintain the dusty material wet
- v. The excavation working area should be sprayed with water after operation so as to maintain the entire surface wet.
- vi. Excavated materials shall be handled and transported in a manner that they do not cause any problems of air pollution.
- vii. The soil/construction materials carried by the vehicle should be covered by impervious sheeting to ensure that the dusty materials do not leak from the vehicle.

III. Water quality monitoring and preservation:

- i. Run off from chemicals and other contaminants from aircraft maintenance and other areas within the airport shall be suitably contained and treated before disposal. A spillage and contaminant containment plan shall be drawn up and implemented to the satisfaction of the State Pollution Control Board.
- ii. Proper drainage systems, emergency containment in the event of a major spill during monsoon season etc. shall be provided.

- iii. The runoff from paved structures like Runways, Taxiways, can be routed through drains to oil separation tanks and sedimentation basins before being discharged into rainwater harvesting structures.
- iv. Storm water drains are to be built for discharging storm water from the air-field to avoid flooding/water logging in project area. Domestic and industrial waste water shall not be allowed to be discharged into storm water drains.
- v. Rain water harvesting for roof run-off and surface run-off, as plan submitted should be implemented. Rain water harvesting structures shall conform to CGWA designs. Before recharging the surface run off, pre-treatment must be done to remove suspended matter, oil and grease.
- vi. Total fresh water use shall not exceed the proposed requirement as provided in the project details. Prior permission from competent authority shall be obtained for use of fresh water.
- vii. Sewage Treatment Plant shall be provided to treat the wastewater generated from airport. Treated water shall be reused for horticulture, flushing, backwash, HVAC purposes and dust suppression
- viii. A certificate from the competent authority for discharging treated effluent/untreated effluents into the Public sewer/ disposal/drainage systems along with the final disposal point should be obtained.
- ix. A detailed drainage plan for rain water shall be drawn up and implemented.

IV. Noise monitoring and prevention:

- i. Noise level survey shall be carried as per the prescribed guidelines and report in this regard shall be submitted to Regional Officer of the Ministry as a part of six-monthly compliance report.
- ii. Noise from vehicles, power machinery and equipment on-site should not exceed the prescribed limit. Equipment should be regularly serviced. Attention should also be given to muffler maintenance and enclosure of noisy equipment's.
- iii. Acoustic enclosures for DG sets, noise barriers for ground-run bays, ear plugs for operating personnel shall be implemented as mitigation measures for noise impact due to ground sources.
- iv. During airport operation period, noise should be controlled to ensure that it does not exceed the prescribed standards. During night time the noise levels measured at the boundary of the building shall be restricted to the permissible levels to comply with the prevalent regulations.
- v. Where construction activity is likely to cause noise nuisance to nearby residents, restrict operation hours between 7 am to 6 pm.

V. Energy Conservation measures:

i. Energy conservation measures like installation of LED/CFLs/TFLs for the lighting the areas outside the building should be integral part of the project design and should be in place before project commissioning.

VI. Waste management:

- i. Soil stockpile shall be managed in such a manner that dust emission and sediment runoff are minimized. Ensure that soil stockpiles are designed with no slope greater than 2:1 (horizontal/vertical).
- ii. The project activity shall conform to the Fly Ash notification issued under the E.P. Act of 1986.
- iii. Solid inert waste found on construction sites consists of building rubble, demolition material, concrete; bricks, timber, plastic, glass, metals, bitumen etc. shall be reused/recycled or disposed off as per Solid Waste Management Rules, 2016 and Construction and Demolition Waste Management Rules, 2016.
- iv. Any wastes from construction and demolition activities related thereto shall be managed so as to strictly conform to the Construction and Demolition Waste Management Rules, 2016.
- v. The project proponents shall implement a management plan duly approved by the State Pollution Control Board and obtain its permissions for the safe handling and disposal of:
 - a. Trash collected in flight and disposed at the airport including segregation, collection and disposed.
 - b. Toilet wastes and sewage collected from aircrafts and disposed at the Airport.
 - c. Wastes arising out of maintenance and workshops
 - d. Wastes arising out of eateries and shops situated inside the airport complex.
 - e. Hazardous and other wastes
- vi. The solid wastes shall be segregated as per the norms of the Solid Waste Management Rules, 2016. Recycling of wastes such as paper, glass (produced from terminals and aircraft caterers), metal (at aircraft maintenance site), plastics (from aircrafts, terminals and offices), wood, waste oil and solvents (from maintenance and engineering operations), kitchen wastes and vegetable oils (from caterers) shall be carried out. Solid wastes shall be disposed in accordance to the Solid Waste Management Rules, 2016 as amended.

- vii. A certificate from the competent authority handling municipal solid wastes should be obtained, indicating the existing civic capacities of handling and their adequacy to cater to the M.S.W. generated from project.
- viii. Used CFLs and TFLs should be properly collected and disposed off/sent for recycling as per the prevailing guidelines/ rules of the regulatory authority to avoid mercury contamination.

VII. Green Belt:

- i. Green belt shall be developed in area as provided in project details, with native tree species in accordance with Forest Department. The greenbelt shall inter alia cover the entire periphery of the Air Port.
- ii. Top soil shall be separately stored and used in the development of green belt.

VIII. Public hearing and Human health issues:

- i. Construction site should be adequately barricaded before the construction begins.
- ii. Traffic congestion near the entry and exit points from the roads adjoining the airport shall be avoided. Parking should be fully internalized and no public space should be utilized.
- iii. Provision of Electro-mechanical doors for toilets meant for disabled passengers. Children nursing/feeding room to be located conveniently near arrival and departure gates.
- iv. Emergency preparedness plan based on the Hazard identification and Risk Assessment (HIRA) and Disaster Management Plan shall be implemented.
- v. Provision shall be made for the housing of construction labour within the site with all necessary infrastructure and facilities such as fuel for cooking, mobile toilets, mobile STP, safe drinking water, medical health care, crèche etc. The housing may be in the form of temporary structures to be removed after the completion of the project.
- vi. Occupational health surveillance of the workers shall be done on a regular basis.

IX. Miscellaneous:

- i. The project proponent shall make public the environmental clearance granted for their project along with the environmental conditions and safeguards at their cost by prominently advertising it at least in two local newspapers of the District or State, of which one shall be in the vernacular languagewithin seven days and in addition this shall also be displayed in the project proponent's website permanently.
- ii. The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt.
- iii. The project proponent shall upload the status of compliance of the stipulated environment clearance conditions, including results of monitored data on their website and update the same on half-yearly basis.
- iv. The project proponent shall submit six-monthly reports on the status of the compliance of the stipulated environmental conditions on the website of the ministry of Environment, Forest and Climate Change at environment clearance portal.
- The company shall have a well laid down environmental policy duly approved by the Board of v. Directors. The environmental policy should prescribe for standard operating procedures to proper balances have checks and and to bring into infringements/deviation/violation of the environmental/forest/wildlife norms/conditions. The company shall have defined system of reporting infringements/deviation/violation of the environmental/forest/wildlife norms/conditions and/or shareholder's/stake holders. The copy of the board resolution in this regard shall be submitted to the MoEF&CC as a part of
- vi. A separate Environmental Cell both at the project and company head quarter level, with qualified personnel shall be set up under the control of senior Executive, who will directly report to the head of the organization.
- vii. Action plan for implementing EMP and environmental conditions along with responsibility matrix of the company shall be prepared and shall be duly approved by competent authority. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Year wise progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six Monthly Compliance Report.
- viii. Self-environmental audit shall be conducted annually. Every three years third party environmental audit shall be carried out.
- ix. The project proponent shall submit the environmental statement for each financial year in Form-V to the concerned State Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as amended subsequently and put on the website of the company.
- x. The criteria pollutant levels namely; PM₁₀, PM_{2.5}, SO₂, NOx (ambient levels) shall be monitored and displayed at a convenient location near the main gate of the company in the public domain.
- xi. The project proponent shall inform the Regional Office as well as the Ministry, the date of financial closure and final approval of the project by the concerned authorities, commencing the land development work and start of production operation by the project.

- xviii. The Regional Office of this Ministry shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data/information/monitoring reports.
- xix. The above conditions shall be enforced, inter-alia under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1981, the Environment (Protection) Act, 1986, Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 and the Public Liability Insurance Act, 1991 along with their amendments and Rules and any other orders passed by the Hon'ble Supreme Court of India / High Courts/NGT and any other Court of Law relating to the subject matter.
- xx. Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

Standard EC Conditions for Project/Activity 7(d): Common hazardous waste treatment, storage and disposal facilities (TSDFs)

I. Statutory compliance:

- i. The project proponent shall obtain forest clearance under the provisions of Forest (Conservation) Act, 1980, in case of the diversion of forest land for non-forest purpose involved in the project.
- ii. The project proponent shall obtain clearance from the National Board for Wildlife, if applicable.
- iii. The project proponent shall prepare a Site-Specific Conservation Plan & Wildlife Management Plan and approved by the Chief Wildlife Warden. The recommendations of the approved Site-Specific Conservation Plan/Wildlife Management Plan shall be implemented in consultation with the State Forest Department. The implementation report shall be furnished along with the six-monthly compliance report (in case of the presence of schedule-I species in the study area)
- iv. The project proponent shall obtain Consent to Establish/Operate under the provisions of Air (Prevention & Control of Pollution) Act, 1981 and the Water (Prevention & Control of Pollution) Act, 1974 from the concerned State Pollution Control Board/Committee.
- v. The Project proponent should ensure that the TSDF fulfils all the provisions of Hazardous and other Wastes (Management and Transboundary Movement) Rules, 2016.
- vi. The project proponents shall adhere to all conditions as prescribed in the Protocol for 'Performance Evaluation and Monitoring of the Common Hazardous waste treatment, storage and disposal facilities' published by the CPCB in May, 2010.
- vii. Incinerator shall be designed as per CPCB guidelines. Energy shall be recovered from incinerator.
- viii. The project proponent shall obtain the necessary permission from the Central Ground Water Authority, in case of drawl of ground water/from the competent authority concerned in case of drawl of surface water required for the project.
- ix. A certificate of adequacy of available power from the agency supplying power to the project along with the load allowed for the project should be obtained.
- x. All other statutory clearances such as the approvals for storage of diesel from Chief Controller of Explosives, Fire Department, Civil Aviation Department shall be obtained, as applicable by project proponents from the respective competent authorities

II. Air quality monitoring and preservation:

- i. The project proponent shall install 24x7 continuous emission monitoring system at process stacks to monitor stack emission with respect to standards prescribed in Environment (Protection) Rules 1986 and connected to SPCB and CPCB online servers and calibrate these systems from time to time according to equipment supplier specification through labs recognised under Environment (Protection) Act, 1986 or NABL accredited laboratories.
- ii. The project proponent shall monitor fugitive emissions in the plant premises at least once in every quarter through labs recognised under Environment (Protection) Act, 1986.
- iii. The project proponent shall install system to carryout Ambient Air Quality monitoring for common/criterion parameters relevant to the main pollutants released (e.g., PM₁₀ and PM_{2.5} in reference to PM emission, and SO₂ and NOx in reference to SO₂ and NOx emissions) within and outside the plant area at least at four locations (one within and three outside the plant area at an angle of 120°each), covering upwind and downwind directions.
- iv. Sampling facility at process stacks and at quenching towers shall be provided as per CPCB guidelines for manual monitoring of emissions.
- v. - ii. The project proponent shall obtain clearance from the National Board for Wildlife, if applicable.
- iii. The project proponent shall prepare a Site-Specific Conservation Plan & Wildlife Management Plan and approved by the Chief Wildlife Warden. The recommendations of the approved Site-Specific Conservation Plan/Wildlife Management Plan shall be implemented in consultation with the State Forest Department. The implementation report shall be furnished along with the six-monthly compliance report (in case of the presence of schedule-I species in the study area)
- iv. The project proponent shall obtain Consent to Establish/Operate under the provisions of Air (Prevention & Control of Pollution) Act, 1981 and the Water (Prevention & Control of Pollution) Act, 1974 from the concerned State Pollution Control Board/Committee.
- v. The project proponent shall obtain the necessary permission from the Central Ground Water Authority, in case of drawl of ground water / from the competent authority concerned in case of drawl of surface water required for the project.
- vi. A certificate of adequacy of available power from the agency supplying power to the project along with the load allowed for the project should be obtained.
- vii. All other statutory clearances such as the approvals for storage of diesel from Chief Controller of Explosives, Fire Department, Civil Aviation Department shall be obtained, as applicable by project proponents from the respective competent authorities.

II. Air quality monitoring and preservation:

The project proponent shall install 24x7 continuous emission monitoring system at process stacks to monitor stack emission with respect to standards prescribed in Environment (Protection) Rules 1986 and connected to SPCB and CPCB online servers and calibrate these systems from time to time according to equipment supplier specification through labs recognized under Environment (Protection) Act, 1986 or NABL accredited laboratories. (for projects involving incineration).
- ii. As proposed, air pollution control device viz. gas quencher; treatment with mixture of hydrated lime and activated powder for adsorption of partial acidity and VOCs (if any); bag filter/ESP for removal of particulate matter; venturi scrubber followed by packed bed scrubber with caustic circulation to neutralize the acidic vapours in flue gas; and demister column for arresting water carry over will be provided to the incinerator. Trend analysis of ground water quality shall be carried out each season and information shall be submitted to the SPCB and the Regional Office of MoEF&CC.
- iii. The depth of the land fill site shall be decided based on the ground water table at the site.
- iv. Rain water runoff from the landfill area and other hazardous waste management area shall be

- collected and treated in the effluent treatment plant.
- v. Total fresh water use shall not exceed the proposed requirement as provided in the project details. Prior permission from competent authority shall be obtained for use of fresh water.
- vi. The Company shall ensure proper handling of all spillages by introducing spill control procedures for various chemicals.
- vii. All leachates arising from premises should be collected and treated in the ETP followed by RO. RO rejects shall be evaporated in MEE. Toxicity Characteristic Leaching Procedure (TCLP) test to be performed on leachates.
- viii. Scrubber water, leachate water or wheel wash effluent shall be treated in the effluent treatment plant followed by RO to achieve zero liquid discharge.
- ix. Sewage Treatment Plant shall be provided to treat the wastewater generated from the project.

 Treated water shall be reused within the project.

- iii. Occupational health surveillance of the workers shall be done on a regular basis.

IX. Miscellaneous:

- i. The project proponent shall make public the environmental clearance granted for their project along with the environmental conditions and safeguards at their cost by prominently advertising it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days and in addition this shall also be displayed in the project proponent's website permanently. (for projects involving incineration)
- ii. The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of MoEF&CC/SEIAA website where it is displayed (For projects involving only Landfill without incineration)
