# Mining Projects under Category B projects in Andhra Pradesh – Violations under EIA Notification 2006 – Reg.

The members of the SEAC, A.P Committee initiated the discussions on the processing applications of violation cases of Mining Projects under Category B under EIA Notification 2006 as per the procedure specified in the MoEF&CC, GoI, New Delhi Notification S.O.No.804 (E), dated 14<sup>th</sup> March 2017 and S.O.No.1030 (E), dated 8<sup>th</sup> March 2018.

The Committee after detailed deliberations recommended the following:

The Committee unanimously resolved to consider all the violation cases in to two groups namely Group –Aand Group – B.

**Group** – **A:** The cases for which the credible action completed against the mining projects i.e., for the violations, action taken against the project proponent by the State Government or Andhra Pradesh Pollution Control Board under the provisions of section 19 of the Environment (Protection) Act, 1986. For all these violation cases, the SEAC, A.P., will verifyall documents (ecological damage, remediation plan and natural and community resource augmentation plan) filed by the project proponent through the accredited consultants along with notorised documents and penalty amount paid to the Hon'ble District Court of A.P., and appraise the projects.

**Group** – **B:** All the remaining violation cases including those for which credible action initiated against the project proponent by the State Government or Andhra Pradesh Pollution Control Board under the provisions of section 19 of the Environment (Protection) Act, 1986, but not completed, for all these violation cases, the SEAC (State Level Expert Appraisal Committee), A.P. /APSEIAA will issue TOR for the preparation of assessment of environment damage, remediation plan and natural and community resources augmentation plan. These plans are to be incorporated as independent chapters of the final report, prepared as per the guidelines suggested by MOEF.

### **Decision of SEIAA:**

- **i.** The Authority decided to seek the legal opinion from Standing Counsel of APPCB on the following:
- (a) Whether all the violation projects (Category –B) are to be treated as B1-Category, as the applications under violations cases have to be issued with Terms of Reference (TOR) as per MoEFCC Notification S.O.No.804 (E), dated 14<sup>th</sup> March 2017.

(OR)

Can be treated as B1/B2 Category as per the EIA Notification 2006 and the TOR shall be prescribed only for B1- Category projects.

(b) Whether public hearing is required for all the violation projects of Category –B) or not.

Earlier, the In Principle Permission for the site was issued by APPCB dt: 16.08.2016 based on the earlier feasibility report for issuing of the earlier TOR, the contents in the APPCB letter dt: 16.08.2016 are as follows:

Also the project proponent has to submit the accreditation details of their consultant for this proposed project activity item No.7(da)., for further appraisal.

Further committee noted the TOR was issued to this project on 29.10.2016 and EIA report prepared by their consultant M/s.Team Labs Consultants and the project proponent submitted the application for EC along with this final EIA report on 11.08.2017.

The project proponent and their Consultant M/s. M/s. Pridhvi Envirotech (P) Ltd.,have attended the meeting and presented the case.

The Committee noted that M/s. Andhra Pradesh Granite (Midwest) Private Limited is an existing Black Galaxy Granite Mine (19.425 Ha.) applied for expansion of production capacity from 1026 m³ /annum to 54,643 m³ /annum . The proposal was appraised in the SEAC meeting held on 16.03.2015 and the committee recommended that the proponent has to approach the concerned authority for obtaining Environmental Clearance (EC) for the mine Cluster. The SEIAA in its meeting held on 02.08.2018, requested the SEAC to call the Director and the Asst. Director of Mines & Geology Dept., to assist the Committee and to clarify the issues in question. The SEAC is also requested to go through the directions of Hon'ble High Court of A.P and specifically include them in their minutes.

In one of the judgments, the Mines & Geology Department, it was reported that earlier this Mine had been operated.

"On the above analysis, this Court finds that the complaint in the first writ petition that the issuance of temporary permits is illegal and arbitrary merits consideration. In that view of the matter, this Court finds that both the writ petitions deserve to be allowed.

12. In the result, the Writ Petitions are allowed as prayed for with costs. As a sequel, the temporary permit said to have been granted on 19.12.2017 and which is in force, is set aside directing official respondents not to allow the unofficial respondent to carry out any operations on the basis of the said permit.

13. As a sequel, the officers concerned of the A.P. Pollution Control Board are hereby directed to forthwith cause inspection of the subject area, where the complained operations were thus far done by the unofficial respondent and have the same assessed. It is needless to carried on by the unofficial respondent and also the surrounding areas to find out whether any damage is done to the ecological system, the environment and the properties on account of the operations state that in the event it is noticed on such inspection that any damage is done, the A.P. Pollution Control Board and the concerned shall initiate action against all concerned who are responsible as per law and take further steps for restoration at the cost of the concerned on the basis of the principle 'polluters pay'."

The Asst. Director of Mines & Geology, Palamaneru have attended the meeting and informed that this mine was operated with the temporary permits issued by the Mines & Geology Dept.



The Committee noted that this road metal & building stone mine of M/s. Sri Lakshmi Venkateswara Stone Crushers, was operated without obtaining the Environmental Clearance and hence attracts violation under the provisions of EIA Notification 2006.
