# MINUTES OF THE $9^{th}$ MEETING OF THE RE-CONSTITUTED EXPERT APPRAISAL COMMITTEE (EAC) ON ENVIRONMENTAL IMPACT ASSESSMENT (EIA) OF THERMAL POWER PROJECTS HELD ON $15^{TH}$ APRIL, 2021

The 9<sup>th</sup> Meeting of the re-constituted EAC (Thermal Power) organised by the Ministry of Environment, Forest & Climate Change, Indira Paryavaran Bhawan, Jor Bagh Road, New Delhi was held on 15<sup>th</sup> April, 2021 through video conference under the Chairmanship of Shri Gururaj P. Kundargi. The list of Members present in the meeting is at **Annexure A**.

### Item No.9.1: CONFIRMATION OF THE MINUTES OF THE 8th EAC MEETING

The Minutes of the 8<sup>th</sup> EAC (Thermal Power) meeting held on 01.03.2021 were confirmed in the meeting.

#### Agenda No. 9.2

Amravati Thermal Power Project of 1350 MW (5x270MW) in an area of 1045 acres by M/s Rattan India Power Limited at Additional Amravati Industrial Area Village Nandgaonpeth, District Amravati (Maharashtra) – Reconsideration of Environmental Clearance (EC) Modification –Reg.

#### [Proposal No. IA/MH/THE/188275/2020; F. No. J-13011/49/2008-IA. II (T)]

- **9.2.1** The proposal is for amendment in Environmental Clearance to Amravati Thermal Power Project of 1350 MW (5x270MW) in an area of 1045 acres by M/s Rattan India Power Limited at Additional Amravati Industrial Area Village Nandgaonpeth, District Amravati (Maharashtra).
- **9.2.2** The EAC during deliberations noted the following:

Earlier, Environment Clearance was granted to 1320 MW (2X660 MW) Thermal Power Project in an area of 1045 acres (including 300 acres ash pond and 260 acres greenbelt) at additional Amravati Industrial Area, Nandgaonpeth, District Amravati, Maharashtra by M/s Sophia Power Ltd. was granted on 27<sup>th</sup> February, 2009.

Further, EC Amendment was granted to 1320 (2X 660) MW Stage Coal based TPP of M/s Indiabulls Power Ltd (formerly M/s Sophia Power Ltd) for change in configuration from 2X 660 MW to 5 X 270 (1350 MW) MW on 15th July, 2010. Extension in EC of 5X270 MW was granted on 14<sup>th</sup> October, 2014 to M/s Indiabulls Power Ltd.

Also, Expansion in EC for addition in capacity of 5X 270 MW (Stage II) in an area of 1350 acres

(including 292 ha ash pond) for both Phase I and II was granted on 27<sup>th</sup> May, 2011 to M/s Indiabulls Power Ltd.

Phase I of 1350 MW (5x270 MW) was commissioned in March, 2015 and the plant is under operation supplying power to MSEDCL under long term PPA.

PP submitted that Phase II of the project could not be materialized and construction halted due to various reasons mentioned as in earlier EAC meeting. Phase II Construction has been stalled and the Environment Clearance was valid till 26<sup>th</sup> May, 2018

PP has proposed to revise the Land requirement for Phase-I is as below:

Also, PP has requested to surrender the area of Phase II Environment Clearance of 305 acres i.e. (1350 acres - 1045 acres).

Overall 421 Acres land (305 Acres from Phase II and 116 Acres from Phase I)

**9.2.3** In view of this, PP has requested for amendment of Environment Clearance for Phase I with revised boundary demarcation for the land requirement of 929 Acres as mentioned in table above.

The proposal was earlier considered by reconstituted EAC in its 5th meeting held on 30.12.2020 and

deferred the proposal seeking additional information which is reflected in the Minutes of the  $5^{\rm th}$  Meeting.

Point-wise replies submitted by the PP vide letter dated 3.04.2021 in response to additional details sought (ADS) by EAC in its  $5^{th}$  meeting are as follows:

**9.2.4** During the 9<sup>th</sup> meeting of the EAC examined the replies in response to additional details sought by EAC in its 5<sup>th</sup> meeting and noted that compliance report dated 31.03.2021 received from RO, MoEF&CC has reported certain non-compliance of the conditions in the existing EC. The EAC asked the PP to submit the point-wise implementation status of these non-complied EC conditions. The PP submitted the implementation status as under:

In view of this, we got conducted a feasibility study for harnessing solar power in the plant premises. A report dated 5th May, 2018 in this regard is enclosed as "Annexure B".
			Amravati Thermal Plant has been running at very low Plant Load Factor (PLF) since last 5 years. Average PLF for the last 5 years i.e. from FY 2016-17 to FY 2020-21 is only 28.31% resulting into low cash flow. The establishment of solar harnessing system will require huge capital investment. This year i.e. in FY 2021-2022, we are expecting a good PLF due to increase in load in Maharashtra State. Hence we humbly request to grant us one year's time to submit a detailed action plan in this regard considering all technical and commercial aspects.

Same has also been confirmed in the RO MOEF&CC Nagpur compliance report dated 31st March, 2021. The current survival rate is around 87%. As advised by RO MOEF&CC Nagpur, plantation of about 63,000 saplings will be done in Phases in next 5 years to meet the tree density of more than 25,000 nos. per hectare. Further to maintain 33% area as green belt out of 929 acres, an additional 15 acres of land plantation shall be carried out in the coming monsoon season. An undertaking submitted in this regard

		is enclosed as "Annexure C". Thus with this 33% Green belt requirement shall be fulfilled.  Further the methodology adopted for Green Belt along with list of plants already planted is enclosed as "Annexure D
4.	List of Environment Management Cell	We have a dedicated Environment Management Cell at Amravati looking specifically towards environment safeguard and compliances as per the Conditions of Environment Clearance as well as Consent to Operate granted by Maharashtra Pollution Control Board. Regular monthly meetings are conducted by the team under the leadership of Plant head and preventive measures undertaken towards environment safeguard. Organogram of the Environment Management Cell is enclosed as "Annexure E"
5.	A letter from the MIDC (who has leased the land to the PP for the power project) that MIDC has no-objection to the surrender of surplus land.	In compliance to the EAC observation, we had approached MIDC and submitted letter is this regard. Copy of the letter is enclosed as "Annexure F". MIDC refused to issue such letter but verbally drew our attention to Clause No. 2 v) of the long term Lease Deed for 95 years which says that as per the Lease Deed, we cannot sell whatever land portion is released from EC as the land is under long term lease with MIDC. Further even for the alternate use, specific approval from MIDC will be required. We have also submitted an Undertaking in this regard to MOEFCC saying that that the surplus land available shall not be sold to a third party but shall be

utilized for some other infrastructure project after due permission from MIDC and if required, regulatory clearances like Environment Clearance, Consent to Establish/Operate etc. Copy of the undertaking is enclosed as
"Annexure G".

It was observed that 33% of 929 acre of land for Phase – I is about 306.57 acres; however, PP has completed only 294.38 acres of plantation. EAC directed for 15 acres additional land for plantation and accordingly PP has to develop plantation in an area of 309.38.

It was noted that EC was granted on the name of M/s Indiabulls Power Limited however currently M/s Rattan India Power Limited has submitted the proposal of EC Amendment. The EAC enquired about transfer of Environment Clearance accordingly.

The EAC after detailed deliberations, observed that:

- (i) A concrete action plan for non-complied EC conditions as reported by RO, MoEF&CC regarding Solar Panel should be submitted. PP should submit the plan in terms of award of work and time bound implementation in this regard.
- (ii) Soil Quality Analysis report need to be examined by the EAC as PP using fly ash in soil.
- (iii) Plan for gap plantation every year along with Measures to be taken for increasing the Survival rate of plantation up to 90% be submitted.
- (iv) Data on ground water table w.r.t pre and post installation of the project along rain water harvesting measures be submitted.
- (v) Details of Environment Management Cell with qualification of members be submitted.
- (vi) The EAC observed that the Ministry has granted EC in the year 2009 to Sophia Power Company Ltd. EC amendments were given on 15.07.2010 and 27.05.2011 subsequently in the name of M/s Indiabulls Power Ltd. However, the present proposal has been submitted by M/s Rattan India Power Limited. PP has not submitted the MoEF&CC letter regarding name change from India Bulls Power Ltd. to present name M/s Rattan India Power Limited. The EAC was of the view that it is pre-requisite to ascertain the actual proponent who is going to bear the responsibility of compliance of existing EC condition, before consideration of proposals. Further, the certified compliance report submitted by Ministry's Regional

Office is on the name of M/s Rattan India Power Limited however EC is still on the name of M/s Indiabulls Power Ltd. The PP should first apply/ make application for transfer of EC in the name of Rattan India Power Limited.

The EAC returned the proposal on above lines.

The meeting ended with vote of thanks to the Chair.
