## Proceedings of the 7th Meeting of the SEIAA, Assam held on 19/07/2018

The 7th Meeting of the SEIAA, Assam was held at the SEIAA office on 19/07/2018 at 1 p.m.

Dr. K. G. Bhattacharyya, Chairman, SEIAA presided over the meeting. The Chairman, SEIAA appraised the members about the agenda items of the meeting.

## Agenda Item 1. General Reporting of the Activities

(a) Confirmation of the proceedings of the SEIAA meeting held on 23/03/2018.

### SEIAA Resolution 7/1

The proceedings of the last meeting of the SEIAA held on 23/03/2018 have already been circulated, confirmed and signed by all the members.

(b) Audit Report from 2013-14 to 2016-17

The Audit of SEIAA accounts for the financial years 2013-14, 2014-15, 2015-16 and 2016-17 was carried out by M/S Bhuyan and Associates, Chartered Accountants and the Full Report was placed before the SEIAA. The CA firm has also been engaged for the audit of the accounts of 2017-18, which has not been completed yet.

The SEIAA appreciated the work done by the CA firm and expressed satisfaction with the work. It is resolved that the Audit Report be accepted and a copy may be sent to the Government of Assam.

SEIAA Resolution 7/4

SEIAA Resolution 7/5

The MoEFCC circulars till date are brought to the notice of the SEIAA and it is agreed that all violations of the EIA Notifications 2006 will be strictly dealt with through imposition of penalty, etc., as per MoEFCC guidelines. It is resolved that the SEIAA will write to the PCCF in this matter for stringent action and copies of the relevant MoEFCC guidelines will be sent to the PCCF along with the letter.

(ii) Inclusion of corporate Environment Responsibility (CER) in EC.

SEIAA Resolution 7/6

The SEIAA is apprised of the MoEFCC Guidelines in the matter of CER and it is decided that CER will be imposed with effect from 01/05/2018 on all parties requiring prior EC. Guidelines for utilization of CER will be framed in due course, and the SEIAA member, Dr. D K Baruah is requested to help in framing the guidelines.

(iii) Sitting Allowance to Members

SEIAA Resolution 7/7

It is further resolved that till the above notification is issued by the Government of Assam, the members will continue to receive the sitting fees/TA & DA for attending SEIAA/SEAC meetings at the existing rates.

M/s Berger Paints India (P) Ltd has given a presentation on the project proposal before the SEAC and clarified the points raised by the committee members. The SEAC recommended that the Terms of Reference for carrying out EIA study by the project proponent may be issued.

The reason for request of extension of validity of E.C. for another 1 year is not clear. So, the party may be requested to justify his prayer for extension.

SEAC Resolution 8/10

EC for setting up of 50TPD formaldehyde and 50 TPD Resins Plant at Palasbari Industrial Estate - 1, Mirza-Palasbari Road, Dist. Kamrup, Assam by M/s Century Adhesive.

After discussion and on the basis of inspection report, committee recommends for issuing EC for the project with terms and conditions. Inspection report may be seen before.

SEIAA Resolution 7/20

SEAC Resolution 8/11

EC for Development of the Borsola Beel (Construction of STP (15 MLD), Walkways, Parking, Landscaping, Water Sports, Roads and Bridges) by Managing Director, Guwahati Smart City Ltd.

Members after going through the presentation raised some question, which the proponent replied. After threadbare discussion on the matter committee recommends for issuing EC for STO with terms and conditions as follows:

1. Sludge treatment and disposal facility should be as per norms.

2. Disposal facility should be monitored by appropriate agency.

- 3. Detail analysis of Sludge (heavy metal etc.) may be submitted before & after treatment.
- 4. To ensure that water from peripheral drains should not enter the beel area.

5. To strictly follow the terms as stated in DPR.

6. Sludge disposal and overall proper treatment should be monitored as proper condition.

SEIAA Resolution 7/21

The SEIAA approves the SEAC recommendation and resolves to issue the prior Environmental Clearance with the necessary terms and conditions along with the suggested conditions recommended by the SEAC.

SEAC Resolution 8/12

EC for Tinsukia Water Supply Project under NLCPR by Tinsukia Minicipal Board, Tinisukia, Assam.

The proposal may be considered under 8 (b) Area Development Projects in EIA notification dtd. 14.09.2006. The proponent may be requested to submit necessary processing fees.
