

**MINUTES OF THE 34<sup>TH</sup> MEETING OF STATE LEVEL ENVIRONMENT IMPACT  
ASSESSMENT AUTHORITY (SEIAA) HELD ON 04<sup>TH</sup> JULY, 2018 AT PRANI SAMPAD  
BHAVAN**

The thirty fourth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 04<sup>th</sup> July, 2018 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5<sup>th</sup> Floor, LB - Block, Sector – III, Salt Lake, Kol-106. Following cases were discussed:

**I. Cases for Final Environmental Clearance**

- 1. Application for Environmental Clearance for the proposed residential complex “Deeshari Megacity” at Holding No. 116, Dwarir Road, Mouza – Jagaddal, P.O. South Jagaddal, P.S. Sonarpur, Ward No. 24 of Rajpur-Sonapur Municipality, Dist. South 24 Parganas, West Bengal by M/s. Megacity Apartments Pvt. Ltd.**

The Authority reviewed the recommendation of SEAC and it is found that it was an existing project with built up area less than 20,000 sq.m. and the project proponent applied for EC for further expansion on 28.05.2014. The stipulated conditions were issued on 17.11.2016. No subsequent approved building sanctioned plan from municipality in compliance with the stipulated conditions is made available by the project proponent. The project proponent is requested to submit the approved building plan in compliance with the stipulated conditions.

- 2. Application for Environmental Clearance for the proposed expansion of the residential complex “UDDIPA” at Premises No. 1, Kashinath Dutta Road, Baranagar Municipality, Dag No. 921 to 925, J.L. No. – 8, P.S. Baranagar, Dist. North 24 Parganas, West Bengal by M/s. Square Four Housing & Infrastructure Development Pvt. Ltd. (Previously M/s. Overflow Tradelink Pvt. Ltd.)**

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance in supersession of the earlier EC vide No. 2331/EN/T-II-1/071/2015 dated 21.10.2016.

- 3. Application for Environmental Clearance for the proposed setting up of storage tank terminal of total onsite storage capacity 18,496 KL at budge Budge on Kolkata Port Trust land, District – South 24 Parganas, West Bengal by M/s. IMC Ltd.**

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

- 4. Application for Environmental Clearance for the proposed installation of 4X15 T Induction Furnace along with Rolling Mill at Village : Ghutgoria, Barjora Plasto Steel Park, P.S. Barjora, Dist. Bankura, West Bengal by M/s. Amit Ferro Alloys & Steel Pvt. Ltd.**

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.



**5. Amendment (for usage of domestic coal) in Environmental Clearance for the proposed coal based thermal power plant at Haldia, Purba Medinipur, West Bengal by M/s. Hiranmaye Energy Limited.**

The Authority considered the recommendation of SEAC and approved the amendment of Environmental Clearance in supersession of the earlier EC.

**II. Stipulated Conditions**

**1. Application for Environmental Clearance for the proposed residential cum commercial complex at Ward No. 4 under Bidhannagar Municipal Corporation, P.S. – Airport, Kolkata -700136, J.L. No. 2, Mouza – Gopalpur, District – North 24 Parganas, West Bengal by M/s. BRL Estates LLP.**


The SEIAA approved the stipulated conditions for Environmental Clearance recommended by the SEAC with the following additional condition:

1. Mutation certificate to be obtained from the local body.


**III. Miscellaneous**

**1. Request from project proponent for Change of premises number in stipulated conditions regarding – Application for Environmental Clearance for the proposed residential complex at 112, B.L. Saha Road, Ward No. 117 of KMC, Kolkata – 700 053, West Bengal by M/s. Merlin Projects Ltd.**

The Authority considered the application made by the project proponent dated 31.05.2018 in connection with the change of premises no. from 24 B. L. Saha Road to 112 B. L. Saha Road. It is found that the project proponent applied in the Form 1 as '24 (Old-112) Basantalal Saha Road'. Subsequently two documents from KMC submitted by the project proponent which are 1) Mutation certificate vide Case No. O/117/04-May-16/40766 dated 04.05.2016 2) Letter vide Memo No. AC/SSU/wd-117/1423/2018-19 dated 24.05.2018. Hence the change in premises no. as mentioned above is approved.
