2.0 Draft Terms of Reference (TOR) have been discussed and finalized during 3rd Expert Appraisal Committee (Industry-2) meeting held during 18th-19th January, 2015 for preparation of EIA/EMP report. The Committee prescribed the following Specific and Additional TOR in addition to Generic TOR provided at Annexure-I (refer to Ministry's website) for preparation of EIA-EMP report:

A. Standard TOR

- Details on solvents to be used, measures for solvent recovery and for emissions control.
- 2. Details of process emissions from the proposed unit and its arrangement to control.
- 3. Ambient air quality data should include VOC, other process-specific pollutants* like NH3*, chlorine*, HCI*, HBr*, H2S*, HF*, etc., (* as applicable)
- 4. Work zone monitoring arrangements for hazardous chemicals.
- 5. Detailed effluent treatment scheme including ssegregation of effluent streams for units adopting 'Zero' liquid discharge.
- 6. Action plan for odour control to be submitted.
- 7. A copy of the Memorandum of Understanding signed with cement manufacturers indicating clearly that they co-process organic solid/hazardous waste generated.
- 8. Authorization/Membership for the disposal of liquid effluent in CETP and solid/hazardous waste in TSDF, if any.
- 9. Action plan for utilization of MEE/dryers salts.
- 10. Material Safety Data Sheet for all the Chemicals are being used/will be used.
- 11. Authorization/Membership for the disposal of solid/hazardous waste in TSDF.
- 12. Details of incinerator if to be installed.
- 13. Risk assessment for storage and handling of hazardous chemicals/solvents. Action plan for handling & safety system to be incorporated.

14. Arrangements for ensuring health and safety of workers engaged in handling of toxic materials.

B. Additional TOR

- Public hearing to be conducted and issues raised and commitments made by the project proponent on the same should be included in EIA/EMP Report in the form of tabular chart with financial budget for complying with the commitments made.
- ii. A Copy of certified compliance report to the environmental conditions prescribed in the existing EC. Action taken report/ detailed action plan on the partly/noncompliance conditions reported by the MoEF&CC Regional Office.
- iii. ZLD system to be adopted with reuse-recycling of wastewater.
- 3.0 These 'TORs' should be considered for the preparation of EIA/EMP for expansion of bulk drugs and intermediates manufacturing unit (From 10.5 TPM to 152 TPM) at Sy.No. 501, 506 and 507, Village Koyalagudem, Mandal Choutuppal, District Nalgonda, Telangana by M/s S.V. Labs Pvt. Ltd. in addition to all the relevant information as per the 'General Structure of EIA' given in Appendix III and IIIA in the EIA Notification, 2006. The EIA/EMP as per TORs should be submitted to the Chairman, Telangana Pollution Control Board, for public consultation. The SPCB shall conduct the public hearing/public consultation as per the provisions of EIA notification, 2006.
- 4.0 You are requested to kindly submit the final EIA/EMP prepared as per TORs and incorporating all the issues raised during Public Hearing / Public Consultation to the Ministry for considering the proposal for environmental clearance within 3 years as per the MoEF O.M. No. J-11013/41/2006-IA.II (I) dated 8th October, 2014.
- 5.0 The consultants involved in the preparation of EIA/EMP report after accreditation with Quality Council of India/ National Accreditation Board of Education and Training (QCI/NABET) would need to include a certificate in this regard in the EIA/EMP reports prepared by them and data provided by other Organization(s)/Laboratories including their status of approvals etc.
