Sir,

In exercise of the powers conferred by the Clause (b) of Sub-section (2) of Section 5 of Mines and Minerals (Development and Regulation) Act, 1957 read with Government of India Order no. S.O.1857(E), dated 18/05/2016, I hereby **approve** the above said modification in approved mining plan including progressive mine closure plan of **AMTIPANI CHIRODIH** Bauxite deposit over an area of 130.01 hectares submitted under Rule 17(3) of Minerals (Other than Atomic and Hydrocarbons Energy Minerals) Concession Rules, 2016 by you vide letter under reference dated 01/04/2017. This approval is subject to the following conditions:

- (i) The modification in approved mining plan is approved without prejudice to any other laws applicable to the mine area from time to time whether made by the Central Government, State Government or any other authority and *without prejudice to any order or direction from any court of competent jurisdiction.*
- (ii) The proposals shown on the plates and/or given in the document is based on the lease map/sketch submitted by the applicant/lessee and is applicable from the date of approval.
- (iii) It is clarified that the approval of aforesaid modification in approved mining plan does not, in any way, imply the approval of the Government in terms of any other provision of the Mines & Minerals (Development & Regulation) Act, 1957 or the Minerals (Other than Atomic and Hydrocarbons Energy Minerals) Concession Rules, 2016 and any other laws including Forest (Conservation) Act, 1980, Environment (Protection) Act, 1986 or the rules made thereunder, *Mines Act, 1952 and Rules & Regulations made thereunder.*



- (iv) Indian Bureau of Mines has not undertaken verification of the mining lease boundary on the ground and *does not undertake any responsibility regarding correctness of boundaries of the leasehold shown on the ground with reference to lease map & other plans furnished by the applicant/lessee.*
- (v) At any stage, if it is observed that the information furnished, data incorporated in the document are incorrect or misrepresent facts, the approval of the document shall be revoked with immediate effect.
- (vi) The approval of modification in approved mining plan is subject to compliance of CCOM's Circular No. 2/2010 within 3(three) month.
- (vii) Next Financial Assurance shall be due for submission on **31/03/2022.**
- (viii) If the approval conflicts with any other law or court order/direction under any statute, it shall be revoked immediately.
