The proposal was placed in the 127th SEAC Meeting held on 15.03.2019. The project proponent gave detailed presentation. The salient features of the project and the environmental impact assessment as presented by the proponent are as follows:

1. Government order/ Lease details:

The Quarry lease was applied in the name of Thiru. A. Dhakshnamurthy, Cuddalore District, Precise Area Compunction was issued by the District Collector, Cuddalore vide Rc.No. 242/Mines/2018, Dated: 07.09.2018 for a period of 3 years. It is a Fresh lease for Gravel Quarry from over an Extent of 4.45.50ha in S.F.No: 232/1A1A1 (P) of Sri Athivaraganallur village, SrimushnamTaluk, Cuddalore District.

2. Mining Plan/Scheme of Mining approval details:

Mining plan was prepared for the period of 3 years. The Mining Plan was got approval from the Deputy Director, Department of Geology and Mining, Cuddalore vide Rc. No. 242/Mines/2018, Dated: 14.09.2018.

3. As per the Department of Geology and Mining, Cuddalore District, Mining plan approved for the 3 years, the production schedule for 3 years states that the total quantity of Gravel should not exceed 108901m³ upto a depth of 5m (3.0m below ground level and 2.0m below ground level).

For First year - 35081m³

For Second year - 36712 m³

For Third year - 37108 m³

4. There is no wastage is anticipated during the quarrying operation the entire Gravel will be directly loaded into tippers for filling and levelling of low lying areas for Road Projects and other infrastructure development work and around the district.

5. Quarrying operation will be by Opencast Semi Mechanized Method with excavator without drilling and blasting.

6. Gravel is to be transported by tippers of 10/20T capacity.
