Agenda Item No.-1

Government Medical College and Hospital at JP University Site, in Chapra, District - Saran, Bihar by Department of Health, Government of Bihar, Total Plot Area:- 1,01,171.41 m². (25 Acres) Total Built-up Area:- 1,19,581.72 m² (Proposal No. - SIA/8(a)/568/18, Online Proposal No.:- SIA/BR/NCP/75202/2018).

The SEAC had considered this proposal in meeting of 28th December 2018, when the Project Proponent was directed to revise report on certain relevant points which is stated in the concerned minutes of the meeting at page no. 6 to 7. Again on 9th February, 2018 the proposal was appraised and reports of the Project proponent were considered. The project proponent complied furnishing the required documents. SEAC recommended the proposal for Environmental Clearance with conditions attached therein with its proceedings. SEAC also observed during appraisal that a detailed storm water drainage system will be required in the proposal to manage water logging in the premises.

SEIAA after due consideration agreed with the recommendations of the SEAC and resolved to grant Environmental Clearance with all necessary condition stipulated by SEAC however EC letter shall be issued after submission of said storm water drainage plan by the Project Proponent.

Agenda Item No.-2

Proposed Construction of Govt. Medical College and Hospital Block at Govt. Sadar Hospital Complex, Line Bazar, Purnia town, Tehsil - Purnia East, District - Purnia, State:- Bihar, Total Plot Area:- 93,364.29 m² (9.34 ha.) Total Built-up Area:- 1,21,727.97 m². (Proposal No. - SIA/8(a)/600/18, Online Proposal No.:- SIA/BR/NCP/78262/2018).

The SEAC had considered this proposal in meeting of 28th December 2018, when the Project Proponent was directed to revise report on certain relevant points which is stated in the concerned minutes of the meeting at page no. 7 to 8. Again on 9th February, 2019 the proposal was appraised and reports of the Project proponent were considered. The project proponent complied furnishing the required documents except non submission of revised affidavit to leave vacant space in the premises as such i.e. no construction shall take place in future in available vacant spaces. SEAC recommended the proposal for Environmental Clearance with conditions attached therein with its proceedings.

SEIAA after due consideration agreed with the recommendations of the SEAC and resolved to grant Environmental Clearance with all necessary condition stipulated by SEAC however EC letter shall be issued after submission of the revised affidavit to SEIAA, Bihar regarding no construction to take place in the available vacant space.

Agenda Item No.-3

Proposed Govt. Dental College and Hospital, Village - Paithna, Taluka -Rahui, District - Nalanda, State:- Bihar, Total Plot Area:- 77,804.58 m² (9.34 Acres)Total Built-up Area:- 1,09,806.51 m² (Proposal No. - SIA/8(a)/601/18, Online Proposal No.SIA/BR/NCP/79747/2018).

The SEAC had considered this proposal in meeting of 28th December 2018, when the Project Proponent was directed to revise report on certain relevant points which is stated in the concerned minutes of the meeting at page no. 8 to 9. Again on 9th February, 2018 the proposal was appraised and reports of the Project proponent were considered. The project proponent complied furnishing the required documents. SEAC recommended the proposal for Environmental Clearance with conditions attached therein with its proceedings.

SEIAA after due consideration agreed with the recommendations of the SEAC and resolved to grant Environmental Clearance with all necessary condition stipulated by SEAC.

Agenda Item No.-4

JayprabhaMedanta Super Speciality Hospital (A Project by Global Health Patliputra Pvt. Ltd.) (Amendment in EC)(Proposal No. - SIA/8(a)/538/18) Online Proposal No.:- SIA/BR/MIS/27949/2016).

Earlier, in the meeting dated 24th January 2019 SEIAA resolved to return the proposal to SEAC for reconsideration and imposition of conditions holistically in the light of standard conditions framed recently by MoEF&CC, GoI. Accordingly SEAC has consider the matter and decided to accord its concern as sought by SEIAA. The SEIAA also noted the followings:-

1. A minimum of 1 tree for every 80 m² of land should be planted or 20 % of total plot area, shall be kept under green cover within project site.

Taking these facts into consideration and recommendation of SEAC, SEIAA resolves to grant EC with all usual as well as above additional condition.

Agenda Item No.-5

Indira Paper Mill Pvt. Ltd., Village - Dhawalpura, Tehsil- Patna Rural, District - Patna, State - Bihar, Total Capacity Writing Paper:- 50 Ton/day. (Proposal No. - SIA/5(i)/605/19) Online Proposal No.:-SIA/BR/IND/29688/2017).

The proposal has been appraised by the SEAC and after discussing the proposal in its sitting of 25th January 2019 and 9th February 2019 has finally recommended for Term of Reference with all usual terms and condition. The SEIAA resolved to Grant Terms of Reference after receipt of self contained and complete information regarding location of the industry with respect to actual "zone" under Master plan of Patna 2016.



The SEIAA observed that:-

- (1) The cases of transfer of EC has been received from Supaul(06 Nos.) and East Champaran(07 Nos.).

- (2) The original lease to lease-holder., (here transferor of EC) has been cancelled by the competent authority for various irregularities made by original lease holder by the concerned Department of Mines before transfer of EC.
- (3) The transferer is also a violator of conditions of EC granted to him, as he did not submit any periodic Compliance Report to the Authority.
- (4) New Letter of Intent for fresh settlement of Riverbed mining for whole district has been awarded to new lessee (here transferee).
- (5) Department of Mines and Geology, Government of Bihar has approved "New Mining Plan" for new lease holder for remaining period of about 1 year.


Taking note of all above observation the members found that this is not truly a case of "lease-transfer" rather a fresh auction/settlement to new lessees, accordingly the clause of transferability as provided in EIA-Notification 2006 of GoI, MoEF&CC is not applicable in these cases; hence the SEIAA resolved to reject the application of EC-transfer received.
