## 1. SEAC proceedings held on 27.04.2019 regarding carrying capacity study of impact on Gangua Nallah.

The SEAC observed that waste water of Bhubaneswar city is discharged to Gangua Nallah and contaminating the water of Gangua Nallah. There is need to carry out a study on impact on Gangua Nallah due to discharge of this waste water.

After detailed discussion, the SEAC recommended that the SEIAA, Odisha may consider to request the appropriate authority in the Govt. to carry out a study of impact on Gangua Nallah due to huge quantity of discharge of waste water of Bhubaneswar City.
