The Authority after detailed discussion and deliberation decided the following:

1. **Serial No. 1:** This proposal was deferred in 5.86<sup>th</sup> meeting of SEIAA as *"there was discrepancy with khasra numbers mentioned in Form I, Patta dated 18/04/2012, amalgamation letter dt 25/07/2016 and building plan. PP was asked for clarification on khasra number and justification for proposal to cut trees submitted to forest depart letter dated 01/06/2023"*.

Now, PP has submitted the clarification along with requisite documents. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to **grant EC** to this proposal, with the added conditions that the tress would be cut only after permission from the competent authority, i.e. the revenue authority, and that the EC is also subject to the plantation of the additional 1000 tress in the compound, as per the undertaking given, within the first year of the commencement of work and that parking of at least 460 ECU shall be provided as per the revised proposal submitted in this regard.

2. **Serial No. 2:** This proposal was deferred in 5.86<sup>th</sup> meeting of SEIAA for *"submission of authenticated DSR of proposed mineral and safety measures to be taken regarding habitation and kaccha rasta."*

Now, PP has submitted the requisite documents and **stated that 128 trees will be planted on both sides of Kaccha Road and blasting will be done based on requirement.** Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to **grant EC** to this proposal.

3. **Serial No. 3:** Proposal was deferred in 5.87<sup>th</sup> meeting of SEIAA and "PP was asked to submit certificate from Mining Department regarding 3 closed mining leases, otherwise to give the current status of the other 3 leases if they are in operation."

However, the queries raised by SEAC and SEIAA in regard to the operational/non-operational mines in this cluster has not been satisfactorily replied through any communication from Mining Department, as was sought. Accordingly, PP is afforded an opportunity of personal hearing to explain the case along with submission of the required information. Hence, the Authority decided to defer this proposal for personal hearing.

4. **Serial No. 4:** Proposal was deferred in 5.90<sup>th</sup> meeting of SEIAA for "submission of Affidavit regarding implementation of Cluster EMP".

Now, PP has submitted the affidavit regarding implementation of Cluster EMP. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

5. **Serial No. 5:** Proposal was deferred in 5.90<sup>th</sup> meeting of SEIAA as "in this proposal Affidavit & lease documents are signed by POA but Power of Attorney letter has not been submitted."

Now, PP has submitted the power of Attorney document. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to this proposal.

6. **Serial No. 6:** Proposal was deferred in the 5.87<sup>th</sup> meeting of SEIAA as in this proposal SEAC abstract has mentioned that "The EC was granted by SEIAA, Rajasthan for mineral Feldspar over an area of 4.09 ha., in favor of Smt. Radha Devi W/o Shri Hansraj Patel vide letter dated 12.08.2022 under violation of EIA notification 2006 and B.G was submitted for remediation as well as penalty amount and resolved that SEIAA may ask the PP to submit a penalty of Violation period earlier which was submitted in form of B.G in State Board."

The Authority was of the view that PP must provide the submission receipt of Penalty and B.G. given by the PP earlier to the RSPCB. And if no penalty was



deposited earlier, then the PP is directed to submit the CA-certified turnover figures and incurred cost for calculation of penalty now.

Moreover, Statutory Condition no. 1 (26), 4 (1), 5 (3), 10 (3) and General Condition no. 3, 16 are mentioned as NOT COMPLIED in the Certified Compliance Report of the conditions of earlier issued EC, for which an ATR is required".

Now, PP has submitted the CA certificate for turnover and ATR for non-compliances in Certified Compliance Report for the conditions as mentioned in earlier EC. However, PP has not submitted any documentary proof regarding submission of Bank Guarantee earlier. The Authority would like to examine the earlier case when EC was granted in August, 2022 to ascertain whether the penalty for violation was imposed or not, and if imposed, how was EC issued and released without confirmation received in writing from RSPCB that the amount has been deposited (not Bank Guarantee). The same may be done and all details in this regard may be put up in the next meeting. Hence, the Authority decided to defer this proposal for such internal examination.

7. **Serial No. 7:** Proposal was deferred in the 5.89<sup>th</sup> meeting of SEIAA because "DSR was submitted for Granite whereas the proposal is for Quartz & Feldspar."

Now, PP has submitted the correct DSR. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to this proposal.

8. **Serial No. 8:** Proposal was deferred in 5.86<sup>th</sup> meeting of SEIAA on account of the following discrepancies:

- Khasra number in DCF dated 26/06/2019 is 2800/4131 but in lease sanction order it is 2800/413.
- Production capacity of the cluster is different in proposal (7,24,158.38 TPA) from Cluster Mining Plan (471129.1 TPA).
- Production capacity of the lease area in the TOR Letter is mentioned as 336955 TPA but in the proposal and Mining Plan it is 352833 TPA.
- Affidavit regarding implementation of cluster EMP is not submitted.

Now, PP has submitted the reply for above queries. On examination it came into the notice that for query no. 2 PP has submitted a table with cluster production capacity which is not in line with the Cluster Mining Plan and no other revised





documents has been submitted. Hence, the Authority decided to defer this proposal for additional information which is to be submitted in next 45 days.

9. **Serial No. 9:** Proposal was deferred in 5.87<sup>th</sup> meeting of SEIAA for "*submission of Affidavit regarding implementation of Cluster EMP*".

Now, PP has submitted the affidavit regarding implementation of Cluster EMP. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

10. **Serial No. 10:** In this proposal, the Consultant is M/s. Macrocosm Environmental Solutions but Affidavit has been submitted by some other consultant i.e., Superintendence Company of India (P) Limited. Also, DCF certificate of some other proposal was submitted at the time of presentation before SEAC. This is gross negligence on the part of the Consultant, whose prime duty is to ensure and submit proper documentation on behalf of the PP. Hence, the Authority decided to impose a fine of Rs. 10,000/- on the Consultant for this irresponsibility and to defer this proposal for submission of correct affidavit from the correct consultant.

11. **Serial No. 11, 12, 13, 16, 17, 18, 19, 20, 21, 23, 28, 29, 30, 31, 33:** The Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to these proposals.

12. **Serial No. 14, 24, 25, 41, 42, 43, 44, 45:** The Authority accepted the recommendations of SEAC and decided to close and delist these proposals.

13. **Serial No. 15:** The Application of the PP for Amendment in TOR w.r.t. change of cluster area i.e., 11.88 ha is accepted. In regard to the recommendation of SEAC that PP may advised to prepare the TOR through Group of Project Proponents (New LOI holders) is desirable but cannot be mandatory. However, the Authority will send a letter to Mining Department to direct the fresh LOI holders to align with the PP in preparation of a common EIA/EMP report.

14. **Serial No. 22, 26, 27, 36:** The Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to these proposals with the condition that PP shall also ensure to raise a dense







- plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
15. **Serial No. 32:** The Authority accepted the recommendations of SEAC and decided to grant Modification in TOR to this proposal.
16. **Serial No. 34 & 35:** In these proposals, Mukundra Hills Tiger Reserve and Ramgarh vishdhari tiger buffer area falls in 10 km periphery of applied area, for which conservation plan is required. Hence, the Authority decided to defer this proposal for additional information i.e., submission of conservation plan within next 45 days.
17. **Serial No. 37:** The Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to these proposals with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects. Also, PP shall do the mining after leaving 45 m from the village road.
18. **Serial No. 38:** In this proposal, certified past production figures has not been submitted after FY 2018-19. Hence, The Authority decided to defer this proposal for additional information i.e., submission of latest past production certificate duly authenticated by Mining Department within next 45 days.
19. **Serial No. 39:** In this proposal, affidavit regarding implementation of Cluster EMP has not been enclosed. Hence, the Authority decided to grant EC to this proposal subject to the submission of above-said affidavit.
20. **Serial No. 40:** The Authority decided to refer back this proposal to the SEAC with the following queries:
- In Mining Plan, Production capacity is given as 35553 TPA then why production capacity of 35555 TPA, as mentioned by the PP in the proposal, was approved by SEAC?
  - When in lease documents, mining scheme and proposal, mineral is sandstone then why past production certificate is issued for sandstone and masonry stone from the Mining Department. Is it a violation case. Why were these issues not examined by SEAC?
  - Forest Clearance is not in the name of Shri Gurbhej Singh and also no validity is mentioned on the document.



- Forest Clearance is only issued for total broken up area i.e., 14.4006 ha for 3 different leases with no bifurcation for individual leases while the lease area of the proposal is 19.87 ha.
  - If NBWL clearance was recommended by MoEF in its meeting dated 13/08/2014, then why there is no document related to it?
  - SEAC has considered it as a case of violation but PP has mentioned "No violation" in his affidavit and consultant does not speak of violation or no violation in its affidavit.
  - Why SEAC has considered the violation for 1994-1995, 1995-1996, 2003 to 2008 only for sanstone and not for masonry stone. Also, why Bank Guarantee in Remediation/Damage Assessment report is calculated for 2006-2007 and 2007-2008 and Penalty is calculated for 2005-06, 2006-07, 2007-08 & 2008-09. (Sandstone & Masonry Stone)?
21. Serial No. 46 & 47: The Authority decided to grant Transfer EC to these proposals.
22. Serial No. 48,49,50,51,52,53: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
