Proceedings of SEIAA meeting held on 08th September, 2016

A meeting of SEIAA was held on 08th September, 2016 at 4.00 P.M. in the Chairman's Chamber, Beltron Bhawan, Shastri Nagar, Patna-23.

Resolved the following:

1. Duratech Cement India Ltd. , At- Tajpur, Dist- Samastipur-

The proponent had prepared the monitoring report prior to the issuance of ToRs and as such the proponent was directed to submit the monitoring report after the ToR was issued i.e. from October-December, 2016. The Proponent shall inform the SEIAA office the exact date of monitoring so that some person from SEIAA office may be deputed. Thereafter, the grant of E.C. would be considered.

2. Matohkhar & Surdaspur Stone mine Project, Block No.- 04, Area- 5.06 Ha, Sheikhpura-

Similarly, the above unit had prepared the monitoring report before the issuance of ToRs and as such, the proponent was directed to prepare the monitoring report after the issue of ToR i.e. from October-December, 2016. The Proponent shall inform the SEIAA office the exact date of monitoring so that some person from SEIAA office may be deputed. Thereafter the grant of E.C. would be considered.

3. ToRs recommended by SEAC for the following units were approved by SEIAA:

- a. M/s Hindustan Petroleum Corporation, Tehsil-Maranga, Dist. - Purnia .
- b. Proposal Clinker Grinding unit, Muzaffarpur. (Shree Cement)

4. Ganga Path, Patna-

EC was granted to BSRDC, Patna for the construction of Ganga Path along with the construction of high capacity drain for the collection of untreated sewage discharged into the Ganges but the drain had not been constructed or say not even yet started which was observed during inspection when it was a composite scheme of Ganga Path. After several show causes,



the proponent has been trying to evade the issue of the said construction. Hence, SEIAA decided to suspend the E.C. granted (Ref. no. 20, dated 22.02.2013).

SEIAA resolved to send the pending files of clay mining to the respective District Magistrates for the grant of E.C. as per 15th January, 2016 Notification (S.O. 141(E).)
