The Authority after detailed discussion and deliberation decided the following:

1. Serial No. 1: Proposal was deferred in the 5.87th meeting of the Authority as "PP has requested to exempt the Public Hearing but SEAC has recommended grant of ToR with Public Hearing. However, the Authority considered it appropriate to afford an opportunity to make a presentation why SEAC's recommendations shouldn't be considered. PP should also clarify with justifications for exempting from public hearing based on OMs or notifications, if any, that may apply to the specific situations in the proposal".

The Authority heard the Project Proponent/ Consultant and accepted the recommendations of SEAC and decided to grant ToR with Public Consultation.

- 2. Serial No. 2: Proposal was deferred in 5.72nd meeting of the Authority for submission of latest Certified Compliance Report. Now, PP has submitted Certified Compliance Report dated 15.6.23 and ATR for the non-complied conditions in the same. Hence, the Authority decided to grant EC to this proposal.
- 3. Serial No. 3: Proposal was deferred in 5.76th meeting of the Authority for submission of valid LoI, Cluster Certificate and latest Certified Compliance Report. Now, PP has submitted valid LoI dated 5.4.23, cluster certificate dated 19.5.23 and latest CCR for one mining lease i.e. ML No. 229/1998 only. Since, this proposal is for amalgamation and expansion, Certified Compliance Reports for both mining leases were sought. Since, PP has not submitted latest CCR for ML No. 205/1998, hence the Authority decided to defer this proposal for submission of latest CCR of ML No. 205/1998 within 45 days.
- 4. Serial No. 4: Proposal was deferred in 5.85th meeting of the Authority for clarification on Khasra no. 438/276, being not included in Aravali and Cluster certificate. PP has submitted a letter from the Mining Department stating that as per the revenue Khasra

map superimposition, demarcated lease area falls in Khasra no. 435/288, 436/288 and 291. Hence, the Authority decided to **grant EC** to this proposal for Khasra No. 435/288, 436/288 and 291.

- 5. Serial No. 5: Proposal was deferred in 5.85th meeting of the Authority for authenticated DSR of the Alwar district. Now, PP has submitted the required document. Hence, the Authority decided to grant EC to this proposal.
- 6. Serial No. 6: Proposal was deferred in 5.86th meeting of the Authority for submission of DSR of the proposed mineral and affidavit of PP regarding implementation of cluster EMP. Now, PP has submitted an affidavit for implementation of cluster EMP and DSR of the proposed mineral. Hence, the Authority decided to approve EIA/ EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.
- 7. Serial No. 7: Proposal was deferred in 5.76th meeting of the Authority for submission of valid LoI and Cluster Certificate. Now, PP has submitted a copy of lease registration document dated 7.6.23 and demarcation survey report. Hence, the Authority decided to approve EIA/ EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.
- 8. Serial No. 8: Proposal was deferred in 5.59th meeting of the Authority for "PP has not submitted the recent Certified Compliance Report of EC". Now PP has submitted a CCR dated 11.07.2023 in which General Conditions 10 & 13 are mentioned as NOT Complied.

SEAC has recommended to approve EIA/EMP and grant EC under violation to this proposal along with Bank Guarantee of **Rs. 1609850**/- for remediation plan, natural resource augmentation plan & community augmentation plan and a penalty of **Rs. 230440**/-. However, as per the CA certificate dated 29.11.22, the penalty amounts to be 237500/-.

Hence, the Authority decided to approve EIA/EMP and grant EC to this proposal with the condition that the PP shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 237500/- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 1609850/- towards Remediation Plan with RSPCB within 15 days of the receipt of the letter in this

- regard, failing which action shall be initiated to stop this project. Along with submission of penalty, the PP is also directed to submit ATR for non-compliance of Condition no. 10 & 13 in submitted Certified Compliance Report.
- Serial No. 9: Proposal was deferred in 5.80th meeting of the Authority for authenticated DSR. Now, PP has submitted the required document. Hence, the Authority decided to grant EC to this proposal.
- 10. Serial No. 10: Proposal was deferred in 5.83rd meeting of the Authority for clarification on production capacity 112260 TPA in form -1 being different from that in Mining Plan and Affidavit of Consultant (172260 TPA). Now, PP has admitted his mistake and submitted corrected production capacity which is 172260 TPA. Hence, the Authority decided to approve EIA/ EMP and grant EC to this proposal with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 11. Serial No. 11: Proposal was deferred in 5.78th meeting of the Authority for submission of ATR on conditions in CCR not complied and production certificate after 31.3.2020. PP has submitted production figures from 2020-31.3.22 where production has not been done beyond granted capacity. In response to ATR, PP has submitted Certified Compliance Report dated 11.6.20 and stated to submit Six month compliance. Hence, the Authority decided to grant EC (Expansion) to this proposal.
- 12. Serial No. 12: Proposal was deferred in 5.83rd meeting of the Authority for submission of revised parking details. However, the revised parking provisions are still inadequate keeping in view the number and category of apartments proposed as well as parking required for visitors coming to the complex. The revised figures of parking also need to be explained, in terms of changes in the plan. Hence, PP may be called **for personal hearing along with** increased provisions for parking.
- 13. Serial No. 13: Proposal was deferred in 5.86th meeting of the Authority for certified production figures from March 2021 March 2023 and ATR on condition no. 10 and 15 of Certified Compliance Report. Now, PP has submitted verified production certificates from March 2021- July 2023 along with Six Month Compliance and a copy of CTO in reply to ATR on non-complied conditions. Hence, the Authority decided to approve EIA/ EMP and grant EC (Expansion & Inclusion) to this proposal with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

- 14. Serial No. 14: Proposal was deferred in 5.86th meeting of the Authority "for presentation with special emphasis on parking since the building is located at a particular place where parking of vehicles on the road on account of public offices located in the vicinity, has already become a nuisance. Hence the building has to make provisions to provide parking for residents, staff and visitors to the complex." Now, PP has submitted revised parking details in the presentation which were found adequate by the Authority. Hence, the Authority decided to grant EC to this proposal.
- 15. Serial No. 15, 16, 17, 18, 20, 21, 22, 23, 24, 29, 52: The Authority accepted the recommendations of SEAC and decided to approve EIA/EMP and grant EC to these proposals with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 16. Serial No. 19: The Authority accepted the recommendations of SEAC and decided to approve EIA/EMP and grant EC to this proposal subject to submission of revised affidavit for plantation of 1500 trees as advised in public hearing with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 17. Serial No. 25: During examination of this proposal, it came to notice that subsequently one more LoI was issued in the name of Shri Surendra Choudhary for an area of 1.4921 ha. Accordingly, Mining Department has issued a revised Cluster Certificate for 430.7636 Ha, which also includes this mine. Meanwhile, SEAC-1 had evaluated the cluster EIA/ EMP, EC based on previous Cluster Certificate of 429.2715 ha and has recommended for approval of EIA/ EMP, EC. In view of the revised Cluster Certificate that has been received prior to the grant of EC and the fact that inclusion of 1.4921 ha would not cause any impact on the previously prepared EIA/ EMP. Accordingly, the Authority decided that the EIA/ EMP shall also be applicable to additional LoI of 1.4921 ha and the EC and EMP shall be applicable for the entire cluster. Hence, the Authority decided to accept the recommendations of SEAC and decided to approve EIA/EMP and grant EC to this proposal as per the revised cluster certificate vide letter of Mining Department dated 11.7.23.
- 18. Serial No. 26: In this proposal, Khasra No. 32 and 877/31 is mentioned in Form –I and Cluster EMP Implementation Affidavit instead of Khasra No. 32 and 874/31 as mentioned in rest of the documents. Hence, the Authority decided to defer this proposal for clarification on Khasra no. and receipt of conservation plan submitted.

- 19. Serial No. 27: The Authority decided to defer this proposal to SEAC for correction and removal of the following short comings:-
 - I. In this proposal, DCF Mandsaur's certificate dated 11.4.22 mentions that the lease area is at a distance of 8 kms from Gandhi Sagar WLS but it does not mention distance from ESZ.
 - A copy of conservation plan is submitted to DCF Kota doesn't have receiving II. and it is not submitted to DCF Mandsaur.
- 20. Serial No. 28: The Authority decided to defer this proposal and seek clarification from PP on the following shortcomings, to be submitted within 45 days -
 - In Form 6 (Form for ML), ML No. is mentioned as 13/2019 (No date given on agreement or form 6); but in EIA, Note sheet, Aravali Certificate, it is mentioned as 73/2018.
 - ToR letter is for 12.64327 ha (issued on 22.7.2020), but on 29.12.2020 cluster П. certificate was revised as per which cluster area is 11.59327 ha. Accordingly, cluster EMP and EIA have been prepared on 11.59327 ha.
- 21. Serial No. 30: In this proposal, Reference number is 20211000042958 mentioned in Aravali certificate and Cluster Certificate instead of 20211000042727 mentioned in LoI. Hence, the Authority decided to defer this proposal for additional information of revised Aravali certificate, to be submitted within 45 days.
- 22. Serial No. 31, 32, 33, 34, 35, 49: The Authority accepted the recommendations and additional conditions laid down by SEAC and decided to grant EC to these proposals.
- 23. Serial No. 36, 38, 39, 42, 43, 45, 46, 47: The Authority accepted the recommendations of SEAC and decided to close & delist these proposals.
- 24. Serial No. 37: The Authority accepted the recommendations of SEAC and decided to close & delist this proposal with a direction to PP/ Consultant to apply afresh for ToR under Violation. The PPs concerned shall apply for TOR under violation within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- 25. Serial No. 40: The Authority accepted the recommendations of SEAC and decided to close & delist this proposal with a direction to the PP concerned shall apply for ToR under violation within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.

- 26. Serial No. 41: In this proposal, certified Compliance Report is more than one year old but PP has submitted a letter dated 17.7.23 stating that certification of compliance report is under process with IRO, Jaipur. Hence, the Authority decided to defer this proposal for additional information of Latest Certified Compliance Report and ATR, to be submitted within 45 days.
- 27. Serial No. 44: SEAC has recommended to close & Delist this proposal as reply submitted by PP dated 16.6.2023 was found inadequate. Meanwhile, PP has submitted a reply to the same query of SEAC in SEIAA office on 14.7.23. Hence, The Authority decided to refer back this proposal to SEAC for Technical Evaluation.
- 28. Serial No. 48: SEAC has recommended to close & Delist this proposal. Meanwhile, PP has submitted a revised DCF Certificate in SEIAA office. Hence, the Authority decided to refer back this proposal to SEAC for Technical Evaluation.
- 29. Serial No. 50: The Authority decided to refer back to SEAC-1 to re-examine this proposal in light of the revised WRD certificate dated 26.04.2023 submitted by PP vide his letter dated 16.5.23. In case of any disagreement, SEAC may specifically point out exactly what is lacking.
- 30. Serial No. 51: The Authority decided to refer back to SEAC-1 to re-examine these two proposals in light of the revised WRD certificate dated 01.05.2023 submitted by PP vide his letter dated 3.5.23. In case of any disagreement, SEAC may specifically point out exactly what is lacking.
- 31. Serial No. 53: In this proposal, the objections of SEAC are not appropriate in light of certificate dated DCF Certificate 26.5.23 as well as existential location of the proposed lease area, which very apparently, is not within the vicinity of any WLS/ NP in the region. Therefore, the Authority decided to refer back this proposal to SEAC to evaluate & submit its recommendations.
- 32. Serial No. 54: In this proposal, ML Reference No. is mentioned as 20211000052410 in Form II, 202111000052410 in Aravali certificate, Cluster certificate, Demarcation survey report and in Form 1, Affidavit, DCF Certificate, LoI, Mining Plan, it is mentioned as 20221000052410. Hence, the Authority decided to defer this proposal for additional information of clarification on reference no. which is to be submitted within 45 days and PP is also directed to submit revised cluster certificate along with this.
- 33. Serial No. 55, 56, 57: The Authority decided to grant Transfer EC to these proposals.

- 34. Serial No. 58: The Authority decided to grant Transfer EC to this proposal with the condition that the PPs concerned shall apply for TOR under violation within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- 35. Serial No. 59, 60: The Authority decided to grant Transfer EC to these proposals with a direction that since the ECs were issued by DEIAA, the concerned PP shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.

36. Serial No. 61, 62: The Authority decided to grant Transfer of ToR to these Proposals.
