Ensure no encroachment of common facilities / infrastructure created for local communities/public purpose, Submit details about green belt development plan including name and number of species planted, Submit the type of land with copy of khatiyani, land possession certificate and present land use pattern of proposed project site, Submit a Contour map of the proposed project site, Detailed report on alternative site analysis, Create a water body (pond) of suitable dimension within the campus of the proposed project, Detailed

report of soil testing, profile, moisture, etc., Detailed report on birds, insects, mammals, flora and fauna with their conservation plan with special condition as imposed by the SEAC in its MoM (Ref. No. 100, dated 11.03.2022).


