	The Committee noted that as per cluster letter issued by the Asst. Director of Mines & Geology, Guntur, vide Lr. No.2526/Q/2019, dated: 27.12.2021 there are eight existing quarry lease within the radius of 500 m. out of 8 quarry leases 2 mine leases are under application stage and 3 mine leases were granted before 09.09.2013 & remaining 3 mine leases were granted after 09.09.2013. Hence, the total cluster area is <5.0 Ha	
	The Committee noted that the extent of proposed mine lease area is 0.991 Ha, the project comes under B2. Mine life is 10 years. Appraised in 176.75 of SEAC meeting. In 173rd SEIAA meeting, decision of SEIAA is Refer to SEAC to appraise with the revised approved mining plan.	
	The committee directed the proponent to get the revised mining plan to maintaining 20 mtrs as non-mining zone on northern side so that the total 200mtrs buffer is maintained from the railway track.	
	The Committee after examining the project proposals, presentations, MoEF&CC' Notifications & OMs and detailed deliberations, recommended to raise ADS for want of subject to upload the revised approved mining plan with non- mining zone of 20 mtrs on Northern side.
