The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No.1: Proposal was deferred in 5.67th meeting of the Authority for noncompliance of specific conditions 21 & 34 and general conditions 11 & 18 of the CCR. Now, PP has submitted a letter assuring to comply with the conditions of EC and assured to provide a detailed clarification on the conditions (which were not complied before) with the final EIA/EMP report. The Authority accepted the recommendations and conditions of SEAC and decided to grant ToR to this proposal. However, ToR approved is subject to fulfilment of the assurance given in respect of CCR/ATR.
- 2. Serial No. 2: Proposal was deferred in 5.76th meeting of the Authority for revised WRD certificate. In response to the query, PP has submitted the same WRD certificate. In the proposal submitted there appears to be a lack of clarity in respect of meeting the water requirements. It is a big project having several components. PP may be <u>called for presentation</u> in which, he may explain all components of the project along with water, waste water and solid waste management aspects of the project.
- 3. Serial No. 3: Proposal was deferred in 5.79th meeting of the Authority for submission of latest certified compliance report. Now, PP has submitted the same along with Action Taken Report in compliance with condition 16 of CCR. Hence, the Authority decided to grant EC to this proposal.
- 4. Serial No. 4: Proposal was deferred in 5.80th meeting of the Authority as earlier DSR submitted, was not authenticated from Mining department. Now, PP has submitted an approved DSR. Hence, the Authority decided to grant EC to this proposal.
- 5. Serial No. 5, 9: These proposals were deferred in 5.81st meeting of the Authority for submission of an affidavit of cluster EMP implementation and valid LoI. Now, PP has submitted the same. Hence, the Authority decided to to approve EIA/ EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.
- 6. Serial No. 6: Proposal was deferred in the 5.81st meeting of the Authority for WRD certificate regarding canal at 5m. - 7. Serial No. 7: Proposal was deferred in 5.77th meeting of the Authority for latest CCR and clarification on proposed area falling in TTZ. Now, PP has submitted the latest CCR and revised form-1 mentioning that TTZ is 7.6 km away from the lease area.

Hence, the Authority decided to accept the recommendations of SEAC to <u>approve</u> <u>EIA/EMP and grant EC (expansion) to this proposal subject to deposition</u> of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 92,329/- by online/Demand Draft mode and also submit the Bank Guarantee of Rs. 10,24,000/- towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project. - proposal, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
- 12. Serial No. 15: The proposal was deferred in 5.80th meeting of the Authority for valid cluster certificate. Now, PP has submitted the required valid certificate. Hence, the Authority decided to grant EC to this proposal.
- 13. Serial No. 17: This proposal was deferred in the 5.74th meeting of the Authority for Action Taken Report on conditions serial no. 3, 8, 16 of CCR, not being complied. PP in reply to the same, has ensured timely submission of six monthly compliance on a regular basis, submitted a copy of newspaper advertisement of EC accordance and ESR to the Regional office. Hence, the Authority decided to grant EC to this proposal.
- 14. Serial No. 18: Proposal was deferred in the 5.80th meeting of the Authority for non-compliance of serial no. 10 and 15 of CCR. Now, PP has submitted the requisite documents i.e. receipt of submission regarding six monthly compliance report to IRO and advertisement of EC accordance in the newspaper. Hence, the Authority accepted the recommendations of SEAC and decided to approve EIA/ EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.
- 15. Serial No. 19: In this proposal, cluster certificate has expired on 28.1.2023. Hence, the Authority accepted the recommendations of SEAC and decided to grant ToR to this proposal subject to submission of valid cluster certificate at the time of submission of ToR compliance.
- 16. Serial No. 20, 25: The Authority accepted the recommendations of SEAC and decided to grant ToR under violation to these proposals.
- 17. Serial No. 21: In this proposal, cluster certificate has expired on 7.6.2023. Hence, the Authority accepted the recommendations of SEAC and decided to grant ToR to this proposal subject to submission of valid cluster certificate at the time of submission of ToR compliance.
- 18. Serial No. 22: In this proposal, a letter dated 9.06.2022 from Mining department is enclosed mentioning revoking of mining lease. Hence, the Authority decided to <u>refer back</u> this proposal to SEAC to ascertain the matter in respect of mining lease from Mining Department, in context of letter issued dated 9.06.2022. Also, the production figures for 2021-22 and 2022-23 may be examined to ascertain violation during this period.
- 19. Serial No. 23: In this proposal, cluster certificate has expired on 11.6.2023. Hence, the Authority accepted the recommendations of SEAC and decided to grant ToR to this proposal subject to submission of valid cluster certificate at the time of submission of ToR compliance.
- 20. Serial No. 24: The Authority accepted the recommendations of SEAC and decided to <u>grant</u> ToR to this proposal.
- 21. Serial No. 26, 27, 28, 33, 34, 37, 38, 44, 46, 50, 54, 55, 56, 57, 58, 60: The Authority accepted the recommendations and additional conditions laid down by SEAC and decided to grant EC to these proposals.



- 22. Serial No. 29, 30: PP has withdrawn his proposal vide letter dated 12.5.23. Hence, the Authority decided to close & delist this proposal.
- 23. Serial No. 31: The Authority accepted the recommendations of SEAC and decided to grant Corrigendum in ToR to this proposal.
- 24. Serial No. 32: The Authority accepted the recommendations of SEAC and decided to grant ToR to this proposal.
- 25. Serial No. 35: In this proposal, as per the certificate from DCF (Jaisalmer), project falls in Great Indian Bustard Arc. Hence, the Authority <u>decided to defer</u> this proposal for closer examination in detail whether mining activity is permitted in Great Indian Bustard Arc or not
- 26. Serial No. 36, 47: The Authority accepted the recommendations of SEAC and decided to close & delist these proposals.
- 27. Serial No. 39, 40, 41, 42, 45: The Authority accepted the recommendations and additional conditions of SEAC and decided to <u>approve EIA/ EMP and grant EC</u> to these proposals and PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.
- 28. Serial No. 43: The Authority accepted the recommendations of SEAC and decided to grant ToR under violation to this proposal.
- 29. Serial No. 48, 49: The Authority accepted the recommendations of SEAC and decided to grant Amendment in ToR to these proposals.
- 30. Serial No. 51: The Authority decided to <u>refer back</u> this proposal to SEAC to examine the NV study enclosed as this is of another project. Similarly, submission of affidavit by PP and consultant are mandatory requirements. SEAC to confirm whether the original affidavit is enclosed. Also, ATR may be sought from PP in respect of those items which have not been complied in the CCR.
- 31. Serial No. 52: In this proposal, DSR was submitted for marble whereas the application is for Granite, Quartz & Feldspar. Hence, the Authority decided to <u>defer</u> this proposal for additional information to be submitted within 45 days.
- 32. Serial No. 53: The Authority decided to <u>refer back</u> this proposal to SEAC. The decision of SEAC to close & delist the case based on its verification of KML, seems arbitrary. The competent authority in respect of safeguarding existing water bodies as well as ensuring the implementation of the orders of the Hon'ble HC in respect of Abdul Rehaman case, is the Water Resource Department (WRD) of the state government.
 - In the present case, WRD has stated that the proposed lease doesn't infringe with the directions of Hon'ble HC in the matter of Abdul Rehman and has given its consent subject to certain conditions vide its letter dated 14.2.23. Moreover, the proposed lease area lies within a previously approved cluster of area 20.5208 ha where mines are already operating.



There is no WRD expert in SEAC. In these circumstances, there appears no justification for SEAC to ignore/ reject, the conditional consent given by WRD. In addition, this particular case has already been examined by SEAC and SEIAA earlier where ToR was granted. Public Hearing has also been held for the project and no objections have been received from either the public or any official.

In view of above, the Authority decided to <u>refer back</u> this proposal to SEAC to examine the case and EIA/EMP from point of view of granting EC while keeping into consideration the conditions of WRD and Mining Department (as stated in the approved mining plan from) in view.

- 33. Serial No. 59: The Authority decide to <u>refer back</u> to SEAC to re-examine from the point of view of violation, keeping in view the increased production in the year 2022- 2023.
- 34. Serial No. 61: The Authority accepted the recommendations of SEAC and decided to grant corrigendum in EC to this proposal.
- 35. Serial No. 62 to 64: The Authority decided to grant Transfer of EC to these proposals.
- 36. Serial No. 65: The Authority decided to grant Transfer EC to this proposal with a direction to apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
