The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No. 1: Proposal was deferred in 5.78<sup>th</sup> meeting of the Authority for submission of complete DSR as the earlier submitted DSR was found incomplete. Now, PP has submitted the correct DSR. Hence, the Authority decided to approve EIA/ EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.
- 2. Serial No. 2: Proposal was deferred in the 5.86<sup>th</sup> meeting of the Authority for ATR on non-complied conditions of Certified Compliance Report, valid Mining Plan and certified production figures for 2022-23. Now, PP has submitted all the requisite documents. Hence the Authority decided to grant EC (Expansion) to this proposal.
- 3. Serial No. 3: The Authority had deferred the proposal in its 5.86<sup>th</sup> meeting for a detailed presentation by the PP in respect of various parameters that impact the environmental sensitivity of the project, particularly on water sources, solid and waste water management, parking provisions and open spaces and justification for the need to cut trees with remedial actions proposed for the same.

The proposed project is a large project wherein the buildings are proposed to be made in a concentrated manner i.e. 26 + 1 EWS + 1 LIG towers each with G+14 stories and expected population of 33,360 with additional 10% visitors on an average. In the 5.90<sup>th</sup> meeting of the Authority, PP was represented by the Consultants and legal representative of the Company. The Consultants were unable to reply to the queries satisfactorily. It was also informed to the Authority that the district UIT/ PHED have refused to supply water for this complex and hence ground water extraction remains the only source for meeting the water requirements of the project. They have also applied to CGWA for a smaller quantity of the proposed total water requirement as the

project will be built in phases. The EC being sought now is for the one time for whole project. No ground water study was put forward that could justify that this mini township of more than 33000 people, will be assured of a sustainable water supply in the years to come from the ground water extraction. No proper solid waste management plan was put forward including the methodology and procedures for segregation of solid waste and subsequent disposal nor has any land been earmarked for this purpose. Three commercial buildings are also proposed to be part of complex but no one present on behalf of the PP was able to explain the very nature of the commercial building proposed as well as the plan to meet the parking requirement commensurate with the same.

Being a mini township of kind project and having residential population of more than 33000 plus, it is very important to understand the environmental impact and proposed measures for environment sustainability, as well as keeping the interests of the people in mind who would be purchasing the property and residing here long after the PP and the company have left.

The proposal is therefore **referred back to SEAC** for detailed examination on the specific concerns identified by the Authority stated above. If considered appropriate, SEAC may also induct a technical expert to assist in its appraisal particularly in context of ground water extraction and reserves as well as solid waste management.

- 4. Serial No. 4: Proposal was deferred in 5.76<sup>th</sup> meeting for shortcomings, in 5.84<sup>th</sup> meeting for personal hearing and in 5.87<sup>th</sup> meeting for resubmitting documents regarding:-
  - Decentralized STPs with appropriate technology and capacity as per norms.
  - II. Plot earmarked for segregation of solid waste with an undertaking that required equipment for the same shall also be installed.
  - III. An earmarked plot of appropriate size as per norms for dumping of non-biodegradable solid waste.

Now, PP has submitted a reply vide letter dated (20.7.23) in which PP has submitted an undertaking regarding designated plot for SWM (Segregation, Collection & dumping) with necessary equipment. A STP will be installed based on MBBR/SBR/other latest technologies to meet the standards by MoEF & CPCB and a

map showing plot for SWM and location of STP. Hence, the Authority decided to grant EC to with these conditions as listed above in this proposal.

- 5. Serial No. 5: Proposal was deferred in 5.87<sup>th</sup> meeting of the Authority for affidavit regarding implementation of cluster EMP. Now, PP has submitted the required document. Hence, the Authority decided to approve EIA/EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.
- 6. Serial No. 6: Proposal was deferred in 5.87th meeting of the Authority for personal hearing "as parking provisions in the proposal were inadequate in light of the nature of the accommodation being constructed". Now PP has submitted revised parking provisions. Accordingly, PP was heard in the 5.90th meeting of the Authority and the documents given in support of the arguments put forth were examined. The Authority found the revised parking details inadequate. PP in this personal hearing informed the Authority that turnover has incurred in the project from sale of dwelling units which was not accounted for in the CA certified turnover certificate submitted earlier with the proposal. Hence, the Authority decided to defer this proposal for additional information of revised CA certified turnover, to be submitted within 45 days.

PP shall also apply for and make payment to the Govt. for PHED connection since ground water is not a sustainable source for the project and non-compliance of this will be considered a breach of the EC condition. Also, as agreed by the PP, the builder shall provide for two level mechanical parking in the basement as and when the parking requirements increase in the future. No vehicle belonging to the residents and staff, visitors coming to the complex shall be parked outside on the road. A violation of this condition will also be considered a breach of the EC condition. PP is **directed to submit an undertaking** for the two conditions mentioned herewith within 30 days.

7. Serial No. 7: Proposal was closed and delisted in 5.65<sup>th</sup> meeting of the Authority due to non-submission of documents in 45 days. PP has requested to relist this proposal vide his letter dated 3.7.23 along with submission of DCF Jaipur certificate, CA Certificate, WRD Certificate, Remediation Plan, NRAP and CRAP. The proposal has been relisted vide letter 7.8.2023. Hence, the Authority decided to refer back this proposal to SEAC for technical examination of the proposal.

8. Serial No. 8: Proposal was closed & delisted in 5.71<sup>st</sup> meeting of the Authority. PP has requested for relisting of the proposal vide his letter dated 10.5.23 along with submission of old documents. Hence, the Authority in 5.76<sup>th</sup> meeting, decided not to relist this proposal.

Now, PP has again requested to relist the proposal with his two representations. PP vide his letter dated 6.7.23, has submitted a revised mining plan dated 14.7.23 and in his second representation dated 14.7.23, PP has submitted WRD Certificate, Blasting & Vibration report, Annexure G, Form I and Report on prevention of Water Pollution. This proposal has been relisted vide letter dated 7.8.23. Hence, the Authority decided to **refer back** this proposal to SEAC for technical appraisal.

- 9. Serial No. 9: Proposal was deferred in closed & delisted in 5.79<sup>th</sup> meeting of the Authority as recommended by SEAC. PP has requested relisting of the proposal and submitted NOC for Plantation vide his letter dated 23.5.23 and LoI with validity extension vide letter dated 17.7.23. Proposal has been relisted vide letter dated 7.8.23. Now, the Authority decided to refer back this proposal to SEAC for examination on technical grounds.
- 10. Serial No. 10: Proposal was deferred in 5.81<sup>st</sup> meeting of the Authority for submission of authenticated DSR. Now, PP has submitted the required document. Hence, the Authority decided to grant EC to this proposal.
- 11. Serial No. 11: Proposal was deferred in the 5.74<sup>th</sup> meeting of the Authority as SEAC has sent a letter regarding some new facts. Thereafter, PP has submitted a request letter for personal hearing. Proposal was again considered in the 5.86<sup>th</sup> meeting of SEIAA and proposal was deferred till reply from SEAC is received. A letter was sent to SEAC mentioning that their reply is still awaited in reference to seeking return of case. - 14. Serial No. 14, 15, 17, 18, 19, 20, 21, 22, 23, 25, 27, 31, 32, 42, 47, 49, 50, 51, 55, 56:
  The Authority accepted the recommendations and additional conditions laid down by
  SEAC and decided to grant EC to these proposals.

- 18. Serial No. 35: In this proposal, as per the authenticated list of flora & fauna provided by DCF Bhilwara, presence of schedule I species is marked in 10 km radius of the applied area. PP has not submitted conservation plan for all species and also the submitted conservation plan is only for Peafowl. Apparently, SEAC has not examined this issue. In addition to this, discrepancy in production capacity has been sighted as follows on note sheet and in the presentation provided production capacity is 5, 99,206 TPA (ROM), in EIA it is 6, 00,026 TPA, Mining Plan is of capacity 16,39,340 TPA (ROM) {Mineral: 5,99,206 TPA}. Hence, the Authority decided to refer back this proposal to SEAC to examine the same and provide recommendations accordingly.
- 19. Serial No. 36: SEAC has recommended to approve EIA/EMP and grant EC to this proposal along with bank guarantee of Rs. 5,50,000/- for remediation plan, natural resource augmentation plan & community augmentation plan and a penalty of Rs. 1,87,756/-.

- 20. Serial No. 37: Affidavit of PP for implementation of cluster EMP is not enclosed in this proposal. Hence, the Authority decided to defer this proposal for additional information of affidavit regarding cluster EMP implementation, to be submitted within 45 days.
- 21. Serial No. 38: ML No. 182/2008 is mentioned instead of 182/2008 in the DCF Ajmer certificate enclosed. Hence, the Authority decided to defer this proposal for revised DCF Certificate to be submitted within 45 days.
- 22. Serial No. 39: In this proposal, following shortcomings have been observed -
  - In Certified Compliance report (18.5.22), specific condition no 10, operational phase condition no 1, condition no 23 and general condition no 2 are noncomplied.
  - II. No change in proposed waste water generation and management, population and power requirement in the modification sought.
  - III. Distance of nearest forest is not mentioned in DCF Certificate.

Hence, the Authority decided **to defer** this proposal for additional information of ATR on non-complied conditions of Certified Compliance Report, Revised DCF Certificate which is to be submitted within 45 days. PP **may be called for presentation** to explain details of wastewater treatment, no change in population after the modification and other aspects leading to environmental sensitivity of the proposal.

- 23. Serial No. 40: In this proposal, following shortcomings have been observed
  - PP stated in his report that turnover is NIL but the same is not certified by CA.
  - DCF Alwar certificate is not submitted, only certificate from DCF Sariska is available.
  - III. In the DCF Certificate and approved maps, the building name is given as Mahalaxmi Complex but the proposal is given with the name as Manbhavan Apartments.

Hence, the Authority decided **to defer** this proposal for additional information of CA certified turnover figures, DCF Alwar certificate and clarification on ambiguity in name, to be submitted within 45 days. With this, **PP may be called for presentation** to explain environmental aspects of this proposal.

- 24. Serial No. 41: The Authority decided to defer this proposal as parking provided is inadequate looking into the nature of the proposed commercial complex. PP shall revise the parking provisions and also provide an undertaking that no vehicle of those working in the commercial complex (and visiting the commercial complex) shall be parked on the roads on account of insufficient parking space. With this, PP may be called for personal hearing with revised parking details.
- 25. Serial No. 43, 53: The Authority accepted the recommendations of SEAC and decided to grant ToR under violation to these proposals.

In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- 36. Serial No. 73, 74, 75, 76, 77, 78, 79, 80, 81, 82, 83, 84, 85: The Authority decided to grant Transfer EC to these proposals with a direction that since the ECs were issued by DEIAA, the concerned PP shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
