The Authority after detailed discussion and deliberation decided the following:

- Serial No. 1, 2, 3, 4, 7, 9, 10, 19, 20, 26, 35: The Authority accepted the recommendations of SEAC and decided to grant ToR to these proposals subject to condition of submission of revised DCF Certificate at the time of EC application.
- Serial No. 5, 8, 12, 16, 23, 24, 27: The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals.
- 3. Serial No. 6: SEAC had recommended to reject the proposal. However, the PP/Consultant submitted an application to SEIAA for personal hearing. The Authority accepted the request of the Project Proponent and heard the PP/Consultant. The Authority is of the view that the application is faulty as pointed out by SEAC, since there is no prior EC for Silica Sand. The application has to be for mineral inclusion of silica sand and masonry stone along with expansion in the quantity of Quartz.

SEIAA does not agree with the comments of SEAC in regard to violation since they pertain to the initial period after which EC was granted by MoEF&CC and, therefore, such period was in the domain of MoEF&CC. No violation has been pointed out by SEAC subsequent to issuance of EC by MoEF&CC.

In view of the above, this application is rejected and PP may re-apply after rectification of defects as pointed above and any other points made by SEAC in this regard.

The matter regarding the project being covered under the order of the Hon'ble Supreme Court regarding the mining activity in Aravalli Hills shall be decided by

- SEIAA when the revised application is next received for consideration along with comments of SEAC on all other aspects.
- 4. - Serial No. 18, 33, 34, 38, 40: The Authority accepted the recommendations of SEAC and decided to grant ToR to these proposals.
- Serial No. 21: The Authority decided to defer this proposal on account of Additional Information i.e, Submission of Lease Documents/LOIs of Existing as well as applied mines and Land documents (Jamabandi).
- 10. Serial No. 28: In this proposal a hospital is there in the nearby area. The Authority was of the view that since this proposal will involve public hearing, the matter regarding the hospital falling at 300 m from the lease area should be specifically discussed during the public hearing, so that no related issues are raised later. The public hearing report should specifically mention the findings on this issue. With these observations the Authority decided to grant ToR, as recommended by SEAC subject to submission of revised DCF certificate at the time EC presentation.

- 14. Serial No. 39: The Authority accepted the recommendations of SEAC and decided to grant ToR to this proposal subject to condition of submission of Land Documents (Jamabandi) at the time of EC application.

    Hence, the Authority decided to refer back these proposals to SEAC with directions to ask the PP to provide above-mentioned requisite information, and SEAC's comments thereon.
- 16. Serial No. 43: This proposal was considered in 5.32<sup>nd</sup> meeting of the Authority and was deferred, as the LoI of the applied area had expired. Now, the PP has submitted the revised LoI. Hence, the Authority decided to grant EC to this proposal.
- Serial No. 44, 45, 46: The Authority decided to grant Transfer of EC to these proposals.
