The members present declared that there are no conflicts of interest with the projects being considered in this meeting. After general introductory remarks by the Chairman, SEAC, the Committee took up items agenda-wise. The decisions of the SEAC on each case are recorded below.

Minutes of the SEAC Meeting held on 20.03.2023

Agenda Item No. 01	Vihaan Heights by M/s. Vaibhavi Infraa Projects, Plot Nos. 1,2,3,4,5,6,7,8,9 & 10, Survey No - 477/Part, Manmole, Ramachandrapuram Mandal, Sanga Reddy District. - Environmental Clearance - Reg.
Proposal No.	SIA/TG/INFRA2/418527/2023 (EC)

The representative of the project proponent Sri R.K Ravi Varma and Sri G.V. Reddy of M/s. Team Labs & Consultants, Hyderabad attended and made a presentation before the SEAC.

The project is proposed with in 10 km radius of Himayat Sagar and Osman Sagar Lakes. But, **Ramachandrapuram (V)** is not included in the list of 84 villages in the 10km catchment of above lakes as mentioned in the G.O.Ms. No: 111, MA, dt. 08.03.1996.

During presentation, the SEAC observed that few trees exists in the site. In this regard, the proponent informed that the intervening trees will be translocated to the boundaries of the site.

The SEAC noted that total plot area is 9,453.4 Sq.m., Out of which green area is 954.7 Sq.m. (10.1%).

It was informed that the total built up area of the project is 55,767.7 Sq.m. The project consists of Residential Apartments Construction Project to accommodate total no. of 220 units. Maximum No. of floors proposed in the project are Residential Apartments with 2 Blocks (2B + S + 10 Floors) and Amenities Block (2B + S + 4 Floors).

It is also noted that Parking area to be provided is 15,798.6 Sq.m. (39.5% against required 22%)

The total cost of the project is Rs. 34.30 Crores. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 135.6 Lakhs during construction phase and Rs. 4.1 lakhs during occupation phase, Recurring cost: Rs. 14.8 lakhs/annum during construction phase and Rs. 38.9 lakhs/annum during occupation phase.

After detailed discussions, the SEAC recommended for issue of EC.

Agenda Item No. 02	4.95 Ha. Stone & Metal Quarry of Smt M Lakshmi Sri, Sy. No.89 (Govt Land) of Ammapur Village, Chinna Chinthakunta Mandal, Mahabubnagar District. - Environmental Clearance - Reg.
Proposal No.	SIA/TG/MIN/417653/2023 (TOR)

The representative of the project proponent Smt. M. Lakshmi Sri and Smt. T. Rajini of M/s. EHS360 Labs Private Limited, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted the lease was granted (in-principle) on 31.01.2022 in favour of the proponent for a period of 20 years. It may be noted that the Mine Lease is granted after 09.09.2013. The proponent also submitted a copy of lr. dt.18.08.2022 of ADMG, Mahabubnagar District informing that there are two other quarry leases of Sri.M. Bhanuprakash (1.0 Ha. - lease granted after 09.09.2013) and Sri. N. Naveen Kumar (2.0 Ha - lease granted after 09.09.2013) falling within 500m from proposed quarry lease. The project proponent informed that the projects with mine lease areas 4.95 Ha in Agenda No. 02 & 4.95 Ha. in Agenda no.10 are within 500m from each other. The other mine was not mentioned in the cluster letter as it is not existing mine and its lease is granted in-principle similar to the present mine lease area.Hence, it was reported to consider them in cluster so as to have cluster EIA and common PH and SEAC agreed for the same. The SEAC noted that the Mine Lease Area is 4.95 Ha. It is further noted that the total Cluster area is 12.90 Ha. and Net cluster area is 12.90 Ha. which is more than 5.0 Ha. Thus, the project is considered under B1 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent informed that the production capacity of the project is to mine 90,970.0 m³/annum of Stone and Metal.

Nearest human habitation is Ammapur (V) @ 1.9 km (W) and Nearest water body exists at 962 mts (W) from the mine lease area.

The proponent informed that they are collecting the baseline data from February – April 2023 and requested to consider the same for preparation of EIA report based on the Standard Terms of Reference for proposed Stone and Metal. The SEAC considered the request of the proponent for utilizing the baseline data from February – April 2023 for preparation of EIA report.

After detailed discussions, the proponent is directed to prepare cluster EIA report considering the baseline data from February – April 2023, as per the Standard Terms of Reference (TORs) issued by the MoEF&CC, GoI for “Mining of Minerals” and undergo the process of Public Hearing (common) in consultation with TSPCB and submit final EIA report along with minutes of public hearing & response of the proponent to the issues emerged in the public hearing to the SEAC for appraisal.

The SEAC deferred the project, as the proponent did not attend the meeting.

Hence, the SEAC decided to inform the proponent to submit a letter stating willingness to consider their proposal in the SEAC meeting.

Agenda Item No. 04	0.670 Ha. Quartz and Feldspar Quarry of M/s. G.Laxmaiah, Sy.No. 71/EE1 & 119/E Patta Land of Chennaram (P.G) Village, Balmoor Mandal, Nagarkarnool District. - Environmental Clearance - Reg.

The representative of the project proponent Sri P. Mallesh and Smt. Lochana of M/s. Pridhvi Envirotech (P) Limited, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that the lease was granted (in-principle) on 05.01.2023 in favour of the proponent for a period of 20 years. It may be noted that the Mine Lease is granted after 09.09.2013. The proponent submitted a copy of lr. dt. 17.01.2023 of ADMG, Nagarkurnool District informing that there are no existing quarry leases falling within 500m from proposed quarry lease. The SEAC noted that the mine lease area is 0.670 Ha. which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The nearest village is Chennaram (P.G) exists at a distance of 0.81 km (NSW); nearest water body exists at a distance of 692 mts (W); Nearest RF is Gumadavelli RF exists at 1.93 km from the mine lease area.

It is proposed to mine 16,980.00 TPA of Quartz and 4,245.00 TPA of Feldspar and the life of mine is reported as 5.0 years @ 13,356 TPA.

The total cost of the project is Rs. 30.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 3.4 lakhs and recurring cost: Rs. 1.8 Lakhs/annum.

After detailed discussions, the SEAC recommended for issue of EC.

Proposal No.	SIA/TG/MIN/417488/2023 (EC)

The representative of the project proponent Sri Ajay R. Wadiyar and Smt. Lochana of M/s. Pridhvi Enviro Tech Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

The SEAC noted the lease was initially granted on 28.11.2000 in favour of the proponent for a period of 20 years. Subsequently, renewal of lease was granted (In-principle) on 28.05.2022 for a period of 20 years. It may be noted that the Mine Lease was granted before 09.09.2013. Hence, cluster is not applicable to the project. The SEAC noted that the Mine Lease Area is 1.65 Ha. which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The nearest village to the proposed site is Mallakpally (V) which is existing at a distance of 850 mts (SE); nearest water body exists at 650 mts (SSE) from the mine lease sarea.

It is proposed to mine 3,066.0 m³/annum (Peak Production) and an average production of 1,766.62 m³/annum of Black Granite and the life of mine is reported as 20 years @1,766.62 m³/annum.

The total cost of the project is Rs. 30.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 3.9 lakhs and recurring cost: Rs. 1.8 Lakhs/annum.

The proponent submitted a copy of lr. dt. 08.12.2022 of ADMG, Hanumakonda District furnishing the details of production and dispatch particulars during the period 2006-07 to 2022-2023 (upto September 2022). It is observed from the letter that production and dispatch permits were issued during the period from 2006-07 to 2008-09; 2013-14 to 2015-16 & during 2018-19; 2021-22 and Nil during the period from 2009-10 to 2012-13; 2016-17; 2017-18; 2019-20; 2020-21 & 2022-23 (upto September 2022); and production was carried out during 2006-07 to 2008-09; 2013-14 to 2015-16 & 2018-19 and nil during 2009-10 to 2012-13, 2016-17, 2017-18 & 2019-20 to 2022-23 (upto September 2022).

The proponent submitted a copy of Certificate dt.15.02.2023 issued by the Sarpanch of Grama Panchayath, Mallakpally village, Dharmasagar Mandal, Hanumakonda District stating that the proponent has donated material of worth Rs. 50,000 /- for various developmental activities of the village.

After detailed discussions, the SEAC recommended for issue of EC.

Agenda Item No. 06	1.69 Ha. Colour Granite Mine of M/s. Srinivasa Granites, Sy.No: 90 & 91, Odyaram Village, Gangadhara Mandal, Karimnagar District. - Extention of Environmental Clearance - Reg.
Proposal No.	SIA/TG/MIN/297214/2023 (Extention of EC)

The representative of the project proponent Sri G.Hari Krishna and Smt. Lochana of M/s. Pridhvi Enviro Tech Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

Earlier, the SEIAA, TS issued EC vide order dt.26.02.2013 with a production capacity of 10,575 m³/annum of Colour Granite and the life of mine was reported as 9.5 years (@6,840 m³/year as per old approval mining plan) i.e upto 25.08.2022. The proponent obtained CFO vide order dt.09.05.2022 which is valid up to 31.08.2022.

The proponent informed that in the MoEF&CC Notification S.O.221(E), dt. 18.01.2021, it was mentioned that "9A. Notwithstanding anything contained in this notification, the period from the

1st April, 2020 to the 31st March, 2021 shall not be considered for the purpose of calculation of the period of validity of prior Environmental Clearances granted under the provisions of this notification in view of outbreak of Corona Virus (COVID-19) and subsequent lockdowns (total or partial) declared for its control, however, all activities undertaken during this period in respect of the Environmental Clearance granted shall be treated as valid". With this notification, EC validity is extended up to one year i.e., upto 25.08.2023, as informed by the proponent.

The SEAC noted the lease was initially granted on 24.01.2007 in favour of the proponent for a period of 20 years i.e upto 28.01.2027.

Now, the proponent applied for Extension of EC with same production capacity and applied within the validity period of earlier EC. Hence, it was requested to issue the extension of EC.

The nearest village Odyaram (V) exists at a distance of 601 mts (SW); nearest water body at a distance of 584 mts (E) from the mine lease area.

It is proposed to mine 10,575 m³/annum of Colour Granite, the life of mine is reported as 22 years.

The total cost of the project is Rs. 50.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 5.2 lakhs and recurring cost: Rs. 2.0 Lakhs/annum.

The proponent submitted a copy of lr. dt. 20.01.2023 of ADMG, Karimnagar District furnishing the details of dispatch particulars during the period 2012-13 to 2022-23 (upto 31.12.2022). It is observed from the letter that dispatch permits were issued during the period 2012-13 & from 2014-15 to 2022-23 (upto 31.12.2022) and Nil during the period 2013-14.

The proponent submitted a copy of Certificate dt.20.06.2022 issued by the Head Master, MPPS Odyaram (V), Gangadhara (M), Karimnagar District stating that the proponent has spent about Rs. 30,000/- for ROR plant and benches for student of school.

After detailed discussions, the SEAC observed that the proponent submitted only dispatch details upto 31.12.2022 and hence, the SEAC informed the proponent to submit earlier production details, till date duly certified by the Mining Department. The SEAC also informed the project proponent to submit duly signed self certified compliance report on earlier EC conditions with supporting documents.

In view of the above, the SEAC deferred the project for consideration after submission of above mentioned information by the proponent.

Agenda Item No. 07	1.0 Ha. Building Stone & Road Metal Quarry of M/s. Sri Srinivasa Stone Crusher, Sy.No 35/A, Kothagattu village, Athmakur Mandal, Hanumakonda District. - Environmental Clearance - Reg.
Proposal No.	SIA/TG/MIN/418095/2023 (EC)

The representative of the project proponent Sri Ch. Mahender Reddy and Smt. Lochana of M/s. Pridhvi Enviro Tech Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

The SEAC noted the lease was initially granted on 22.10.2009 in favour of the proponent for a period of 10 years i.e upto 21.10.2019. Subsequently, the renewal of lease was granted (in-principle) on 06.09.2022 for period of 20 years. It may be noted that the Mine Lease was granted before 09.09.2013. Hence, cluster is not applicable to the project. The SEAC noted that the mine lease area is 1.0 Ha. which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

Minutes of the SEAC Meeting held on 20.03.2023

The nearest village to the proposed site is Sivanagar (V) which is existing at a distance of 0.74 km (SE); nearest water body exists at 59 mts (as per KML file) from the mine lease area.

It is proposed to mine an average production of 50,124.00 m³/annum of Building Stone & Road Metal and the life of mine is reported as 10 years.

The total cost of the project is Rs. 30.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 3.80 lakhs and recurring cost: Rs. 1.80 Lakhs/annum.

The proponent informed that mine is not in operation since more than 3 years and hence, no CSR activities were undertaken by the project proponent. The project proponent informed that they will do CSR activities after the commencement of quarry operations.

The proponent submitted a copy of lr. dt.19.12.2022 of ADMG, Hanumakonda District furnishing the details of dispatch particulars during the period 2009-10 to 2022-23 (upto 19.12.2022). It is observed from the letter that dispatch permits were issued during the period 2009-10 to 2014-15; & during 2018-19 and Nil during the period from 2015-16 to 2017-18 & 2019-20 to 2022-23 (upto 19.12.2022).

After detailed discussions, the SEAC observed that the proponent submitted only dispatch details upto 19.12.2022 and hence, the SEAC informed the proponent to submit earlier production details, till date duly certified by the Mining Department.

In view of the above, the SEAC deferred the project for consideration after submission of above mentioned information by the proponent.

Agenda Item No. 08	2.50 Ha. Rough Stone and Road Metal Mine of M/s. Narasimha Stone Crusher., Sy. No. 994/2 of Peddamallareddy Village, Bhiknoor Mandal, Kamareddy District. - Environmental Clearance - Reg.
Proposal No.	SIA/TG/MIN/418018/2023 (EC)

The representative of the project proponent Sri A. Ram Reddy and Sri Vishnu Sharma of M/s. Ampl Environ Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

The proponent informed that the lease was granted (in-principle) on 09.03.2016 in favour of the proponent for a period of 15 years i.e upto 08.03.2031. It may be noted that the Mine Lease is granted after 09.09.2013. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.


The Proponent also submitted a copy of Lr.dt. 04.06.2022 of ADMG, Kamareddy District informing that there are three other quarry leases of M/s. Narsimha Stone Crusher (1.0 Ha. – quarry is non-working from 06.12.2018); M/s. Trimex Industries (3.20 – lease granted before 09.09.2013) and Smt. P.Lalitha (1.70 Ha. – lease granted after 09.09.2013) existing within 500m from proposed mine lease area. The SEAC noted that the mine lease area is 2.50 Ha. It is further noted that the total Cluster area is 8.4 Ha. and Net cluster area is 4.2 Ha. which is less than 5.0 Ha. The project has to be considered under B2 Category, but since it is a violation case, the project is considered under B1 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT.

The SEAC noted that, the SEIAA, TS has issued TORs (Violation) dt.27.06.2022 exempting Public hearing. Accordingly, the proponent uploaded final EIA report on 13.02.2023.

The nearest human habitation is Thanda @ 1.6 km (W); Nearest water body i.e., unnamed pond near project site exists at a distance of 0.56 km (SE); Nearest RF i.e., Komatipalli RF exists at a distance of 6.84 km (S) from the mine lease area.

It is proposed to mine 37,551.60 m³/annum of Building stone and Road Metal and the life of mine is reported as 12 years.

The proponent informed that credible action has been initiated against them vide CC No. 32/2023 filed in the court of the Additional Junior Civil Judge-Cum-Judicial Magistrate of First Class,

Kamareddy District. The Honble Court vide order dt.11.02.2023 directed to pay fine of Rs.30,000/- and the project proponent informed that they have payed the fine to the Hon'ble court.

The total cost of the project is Rs. 25.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 2.5 lakhs and recurring cost: Rs. 1.25 Lakhs/annum.

The proponent submitted a copy of Certificate dt.02.02.2023 issued by the Sarpanch of Grama Panchayath, Issannapally Village, Bhiknoor Mandal, Kamareddy District stating that the proponent has donated Rs.50,000 /- for repairing of the roads in the village.

The project proponent submitted a copy of lr.dt.16.03.2023 of ADMG: Kamareddy District furnishing details of dispatch permits during the period 2016-17 to 2022-23 (upto February 2023). It is observed from the letter that dispatch permits were issued during the period 2016-17 to 2022-23 (upto February 2023). It is also observed from the document that the proponent has paid Seigniorage fee of Rs. 18,59,185/- and dispatched 26,529 m3/year of Building stone and Road metal.

Accordingly, the proponent submitted Compliance of criteria mentioned for processing violation proposals w.r.t. mining projects. The SEAC examined the same and found that the level of damage for the present project is Low. Accordingly, the amount of Bank Guarantee to be submitted for Implementation of Remediation plan; Natural Resource Augmentation Plan; and Community Resource Augmentation Plan is worked out to be Rs. 1.25 Lakhs and the details are as following:

The SEAC considered the project as per the S.O.No.804 (E) dt.14.03.2017; S.O.1030 (E), dt.08.03.2018 & O.M. dt: 07.07.2021 & O.M. dt: 28.01.2022 issued by the MoEF&CC, GoI w.r.t. Standard Operating Procedure (SOP) for identification and handling of violation cases under EIA Notification., 2006. The SEAC noted that as per SOP, the total Penalty (where operations have commenced without EC) is 1% of the total project cost incurred up to the date of filing of application along with EIA/EMP report **PLUS** 0.25 % of the total turnover during the period of violation. Further, the percentage rates, as above, shall be halved if the project proponent *suo-moto* reports such violations without such violations coming to the knowledge of the Government either on inquiry or complaint.

The SEAC noted that the mine lease area is 2.5 Ha and the rationalized project cost is Rs. 25.0 Lakhs (higher of project cost in application of Rs. 25.0 lakhs & project cost calculated as Rs.25.0 Lakhs considering Rs. 10.0 Lakhs/Ha. for Rough Stone and Road Metal Mine, as per Methodology for calculating Penalty). Further, the SEAC considered total turnover as 2 times the Seigniorage fee and hence, the turnover is Rs.37,18,370/-.

Since, the proponent suo-moto reported violations, the above pcentage rates are halved and therefore the **Total Penalty is worked out to be Rs. 17,148/-**

After details discussions, the SEAC recommended for issue of EC Clearance subject to approval by the SEIAA for submission of Bank Guarantee for an amount of Rs. 1.25 lakhs and Penalty of Rs. 17,148/-

The representative of the project proponent Sri A. Ram Reddy and Sri Vishnu Sharma of M/s. Ampl Environ Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

The proponent informed that the lease was initially granted on 30.10.2003 in favour of the proponent for a period of 15 years i.e upto 07.12.2018. Subsequently, the Mining Department issued notice dt.06.12.2019 granting renewal of lease (in-principle). It may be noted that the Mine Lease is granted before 09.09.2013. The SEAC noted that the mine lease area is 1.0 Ha. which is less than 5.0 Ha. The nearest human habitation is Thanda @ 1.6 km (W); Nearest water body i.e., unnamed pond near project site exists at a distance of 0.56 km (SE); Nearest RF i.e., Komatipalli RF exists at a distance of 6.84 km (S) from the mine lease area.

It is proposed to mine 24,046 m³/annum of Rough stone and Road Metal and the life of mine is reported as 8 years.

The proponent submitted a copy of Certificate dt.02.02.2023 issued by the Sarpanch of Grama Panchayath, Issannapally Village, Bhiknoor Mandal, Kamareddy District stating that the proponent has donated Rs.30,000 /- for water supply motor in the village.

Accordingly, the proponent submitted Compliance of criteria mentioned for processing violation proposals w.r.t. mining projects. The SEAC examined the same and found that the level of damage for the present project is Low. 

The proponent informed: Assured that latest technology would be suggested and implement control air and noise pollution including introduction of latest blasting techniques to contain the intensity of vibrations, implement all pollution control measures as suggested by MoEF and TSPCB to ensure least negative impact, I&C (Mines-I) department, Government of telangana permission orders to TSMDC, this area is allocated vaddera communities, Greenbelt will be developed in an area of 0.075 Ha and avenue plantation along the connecting roads will be proposed (Rs. 2.05 lakhs), have allocated Rs. 1.4 Lakhs under CSR activities.

The nearest village to the proposed site is Saddupalli (V) which is existing at a distance of 920 mts (W); nearest water body i.e., a small water pond exists at 400 mts and nearest RF is Bacharam RF exists at a distance of 2.1 km from the mine lease area.

It is proposed to mine 5,80,431.6 m³/annum of Stone & Metal and the life of mine is reported as 9 years.

The total cost of the project is Rs.100.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 15.45 lakhs and recurring cost: Rs. 5.63 Lakhs/annum.

The proponent informed that the Industries and Commerce (Mines -I) Department, Government of Telangana vide G.O.Ms.No.39 dt.05.06.2018 accorded permission to TSMDC and subsequently the area is allocated to Vaddera Communities.

The project proponent informed that no mining was done in the mine lease area. In this regard, the SEAC informed the project proponent to submit earlier production details from 14.11.2008 to till date duly certified by the Mining Department. The SEAC also informed the project proponent to submit CSR activities under taking by the project proponent with evidence.

After detailed discussions, the SEAC deferred the project for consideration after submission of above information by the project proponent.
