The Chairman, SEAC, Assam Sri S. K. Seal Sarma, presided over the meeting. Welcoming all the members the Chairman stated the objective of the meeting and informing that 22 no. of project proposals is included in the agenda for deliberation inclusive of presentation by two project proponents. The Chairman declares business of the meeting open for deliberation as per agenda note.

Agenda item- 1: Confirmation of the resolutions adopted the 43th meeting of SEAC, Assam. Resolution 44/1:

Minutes of the 43rd SEAC meeting held on 6th August, 2022 is placed before the Hon'ble Members for their perusal and necessary discussion. The minutes of the 43th SEAC meeting is approved unanimously after a brief discussion.

Agenda item- 2:

1. Proposal for amendment of EC for mining of Sand from the "Jingiram River Mining Contract Area for Sand" under Goalpara Forest Division proposed by the D.F.O. Goalpara Division. SEIAA.3092/2022, (SIA/AS/MIN/285886/2022).

Resolution 44/2:

The proposal requesting ammendment of EC for mimning of sand from the "Jingiram River Mining Contract Area for Sand" under Goalpara Forest Division proposed by the D.F.O. Goalpara Division is placed before the SEAC for appraisal and discussion. Scrutinized the required document submitted by the proponent. It is implied that the MCA is operating without valid EC, and on the basis of the Minutes of the Meeting held on 30th March 2017 by DEIAA, Goalpara.

Sri Arup Das, the existing contract holder clearly stated in his letter dt. 20th Aug. 2022 that he has not received any EC for operating of the MCA in question. Record speaks that the contract perod was for seven years and the MCA is under operation w.e.f. 3rd April, 2017. As per AMMC Rule 2013, the DEIAA might have allowed five years period expiring validity on 1st April, 2022. Further, office record says that the existing proponent Sri Arup Das has not applied for extension of validity of his EC for another two years till date, and it implies that the validity of the EC (*if it was at all issued by the DEIAA*) has already been expired on 1st April, 2022. Detailed deliberation is held and the committee requires the following information for consideration of the project proposal:

- Copy of the previous EC granted in the name of Sri Arup Das as per minutes of the Meeting held on 30th March 2017 and issued on 2nd April 2017 by the DEIAA, Goalpara.
- 2. Current status report on the MCA in question needs to be furnished by the DFO, Goalpara.
- 3. The NOC given by the existing proponent Sri Arup Das on 10th Aug, 2021 shall have to be certified by the DFO, Goalpara
- 4. Half Yearly Compliance Report of the MCA shall have to be submitted by the existing Proponent with certification of the DFO Goalpara Division.
- 5. Clarification is required from the DFO, Goalpara whether the MCA is presently under operation and if so under what authority.

- 3. The submitted EDS reply under "Project Report" the location of the project site is written as "Behind Royal Global University".
- 4. The rainwater harvesting plan, percolation pit structure and dimension, harvested rainwater as a part of water balance is required.
- 5. The EDS reply is not appropriate and distinct is some cases.
- 6. Source of water supply, grand total of water and water balance are not given.
