

The members present declared that there are no conflicts of interest with the projects being considered in this meeting. After general introductory remarks by the Chairman, SEAC, the Committee took up items agenda-wise. The decisions of the SEAC on each case are recorded below.

Agenda Item No. 01	0.556 Ha. Fullers Earth (White) of Sri Vadde Ananthaiah, Survey No. 384/25A (Patta Land), Tharigopul Village, Dharur Mandal, Vikarabad District Environmental Clearance - Reg.
Proposal No.	SIA/TG/MIN/423679/2023 (EC)

The representative of the project proponent Sri G. Satish and Sri G.V. Reddy of M/s. Team Labs & Consultants, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that the lease was granted (in-principle) on 23.02.2023 in favour of the proponent for a period of 20 years. It may be noted that the Mine Lease is granted after 09.09.2013. The proponent submitted a copy of lr.dt.10.03.2023 issued by ADMG, Vikarabad District informing that there are no quarry leases existing within 500mts from the proposed mine lease area. The SEAC noted that the mine lease area is 0.556 Ha. which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The nearest village is Kondapur (V) exists at a distance of 950 m (NE); nearest water body i.e Water pond exists at a distance of 510 mts (NE); Nearest RF i.e., Ghatkondapur RF exists at a distance of 1.4 km (E) from the mine lease area.

It is proposed to mine 12,798.3 TPA of Fullers earth (white) and the life of mine is reported as 5.2 years.

The total cost of the project is Rs. 10.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 1.65 lakhs and recurring cost: Rs. 1.19 Lakhs/annum.

After detailed discussions, the SEAC recommended for issue of EC.

The representative of the project proponent Sri P.Upendar and Sri D. Sreekanth of M/s. Sri Sai Manasa Nature Tech Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

The SEAC noted the initial lease was granted on 14.11.2008 in favour of the proponent (Erstwhile APMDC) for a period of 15 years i.e upto 13.11.2023. However, the area was mentioned as Acres 66.43 Gts in Sy. No. 268 of Bandaravirala, whereas the proposed mine lease area is 13.44 (Ac. 33.21½ Gts.). The SEAC noted that the mine lease area is 13.44 Ha. which is more than 5.0 Ha. Thus, the project is considered under B1 Category as per provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan.

The SEAC noted that earlier the SEIAA issued TORs (Auto Generated) on 31.12.2019 for preparation of EIA Report. Accordingly, the proponent undergone the process of public hearing on 29.11.2022 and submitted Final EIA Report along with minutes of public hearing and issues emerged during public hearing. The SEAC noted the contents of Final EIA report. It is observed from the public hearing issues that: Compensation for lost land, Issue of land to local vaddera community, Implement dust control equipment, the farmers were protesting for justice since 106 days, employment to local people. The proponent informed: Implement all pollution control, training will provided to skilled and unskilled workers, Conduct skill development programme, provide plantation, employment will be provided to 150 members, they have allocated Rs. 12 Lakhs under CER activities.

The nearest village to the proposed site is Pillaipalli (V) which is existing at a distance of 2.17 km (NE); nearest water body i.e., Musi River exists at 3.5 km and nearest RF is Bacharam RF exists at a distance of 3.0 km from the mine lease area.

It is proposed to mine 6,03,196 m<sup>3</sup>/annum of Stone & Metal and the life of mine is reported as 8 years.

The total cost of the project is Rs.50.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 4.80 lakhs and recurring cost: Rs. 5.60 Lakhs/annum.

The proponent informed that the Industries and Commerce (Mines –I) Department, Government of Telangana vide G.O.Ms.No.39 dt.05.06.2018 accorded permission to TSMDC and subsequently the area will be allocated to Vaddera Communities.

The SEAC informed the project proponent to submit the following:

- 1. Initial lease document with a proposed area of Acres 33.21 Gts.
- 2. Earlier production details duly certified by the Mining Department and present status of mining operations.
- 3. CSR activities undertaken by the project proponent with evidence.

After detailed discussions, the SEAC deferred the project for consideration after submission of above information by the project proponent.

The representative of the project proponent Sri G. Satish and Sri G.V. Reddy of M/s. Team Labs & Consultants, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that the lease was granted (in-principle) on 07.03.2023 in favour of the proponent for a period of 20 years. It may be noted that the Mine Lease is granted after 09.09.2013. The proponent submitted a copy of lr.dt.20.03.2023 issued by ADMG, Vikarabad District informing that there are no quarry leases existing within 500mts from the proposed mine lease area. The SEAC noted that the mine lease area is 0.500 Ha. which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The nearest village is Kondapur (V) exists at a distance of 1.1 km (NE); nearest water body i.e Water pond exists at a distance of 675 mts (NE); Nearest RF i.e., Ghatkondapur RF exists at a distance of 1.6 km (E) from the mine lease area.

It is proposed to mine 9,693 TPA of Fullers earth (white) and the life of mine is reported as 5.1 years.

The total cost of the project is Rs. 10.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 1.59 lakhs and recurring cost: Rs. 1.16 Lakhs/annum.

After detailed discussions, the SEAC recommended for issue of EC.

The representative of the project proponent Sri Ram Reddy and Sri D. Sreekanth of M/s. Sri Sai Manasa Nature Tech Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that the lease was granted on 31.07.2007 in favour of Sri Chinda Venkata Ramesh Raju over an extent of 5.67 Ha for a period of 20 years. Subsequently, the lease was transferred on 01.11.2016 in favour of proponent for un-expired period upto 18.12.2027.

The proponent submitted a copy of lr.dt. 03.03.2023 of part surrender of quarry lease area over 1.39 Ha and retained quarry lease extent of 4.28 Ha. It may be noted that the Mine Lease is granted before 09.09.2013. Hence, cluster is not applicable to the project. The SEAC noted that the mine lease area is 4.28 Ha. which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The nearest village is Parlapalle (V) exists at a distance of 0.84 km (SW); nearest water body is existing at a distance of 77.57 mts (SW) from the mine lease area.

It is proposed to mine maximum production of 1,00,000.0 m<sup>3</sup>/annum of Colour Granite and the life of mine is reported as 20 years.

The total cost of the project is Rs. 50.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 5.0 lakhs and recurring cost: Rs. 2.5 Lakhs/annum.

The proponent submitted a copy of lr.dt. 21.03.2023 of ADMG, Karimnagar District furnishing the details of year-wise dispatch permits for the period from 2007-08 to 2022-23 and it is observed from the letter that the dispatch permits were issued during 2011-12; 2012-13 and during 2014-15 and Nil during the period from 2007-08 to 2010-11, 2013-14, and 2015-16 to 2022-23.

The proponent informed that they have done CSR activities in the nearest village and submitted a copy of Certificate dt.15.04.2023 issued by the Sarpanch, Gram Panchayath, Parlapalle Village, Timmapur Mandal, Karimnagar District informing that the proponent has donated Rs. 4,45,000/for Benches at Panchayat office, Plantation, Drinking water & sports items, Community hall development in the village.

During presentation, the SEAC observed that part of the mine lease area is covered with vegetation towards North direction. In this regard, the proponent submitted a copy of land document informing that they will develop greenbelt in Sy.No 186/B/B in an area of about Acres 1.20 Gts as compensatory land for greenbelt development.

After detailed discussions, the SEAC recommended for issue of EC.

The representative of the project proponent Sri G. Satish and Sri G.V. Reddy of M/s. Team Labs & Consultants, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that the lease was granted (in-principle) on 02.01.2023 in favour of the proponent for a period of 20 years. It may be noted that the Mine Lease is granted after 09.09.2013. The proponent submitted a copy of lr.dt.10.03.2023 issued by ADMG, Vikarabad District informing that there are two quarry leases of Sri Sudarshan Reddy (Acres 3.32 Gts. (1.34 Ha.) - lease granted after 09.09.2013) and Smt.K. Veena (Acres 2.20 Gts. (0.89 Ha.) - lease granted after 09.09.2013) existing within 500mts from the proposed mine lease area. The SEAC noted that the mine lease area is 1.74 Ha. Total cluster area and Net cluster area is 3.97 Ha which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The nearest village is Marepally (V) exists at a distance of 580 m (SW); nearest water body i.e Water pond (cheruvu) exists at a distance of 1.95 km (NW); Nearest RF i.e., Allapur RF exists at a distance of 2.0 km (SE) from the mine lease area.

It is proposed to mine 20,520 TPA of Fullers earth (white) and the life of mine is reported as 7 years.

The total cost of the project is Rs. 15.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 1.96 lakhs and recurring cost: Rs. 1.33 Lakhs/annum.

After detailed discussions, the SEAC recommended for issue of EC.

Agenda Item No. 06	2.0 Ha. Road Metal and Building Stone Quarry of Sri Venkateshwara Stone, Survey No. 393, Ghanpur Village, Toopran Mandal, Medak District Environmental Clearance - Reg.
Proposal No.	SIA/TG/MIN/423900/2023 (EC)

The representative of the project proponent Sri Y.Sudhakar Reddy and Sri G.V. Reddy of M/s. Team Labs & Consultants, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that the intial lease was granted on dt.12.10.2009 in favour of the proponent for a period of 10 years i.e.upto 11.10.2019. Later, 1<sup>st</sup> renewal was granted on 08.09.2022 for a period of 20 years. It may be noted that the Mine Lease is granted before 09.09.2013. Hence cluster is not applicable. The Proponent also submitted a copy of Lr.dt. 21.03.2023 of ADMG, Medak District informing that there are seven other quarry leases (all the leases were granted before 09.09.2013) within 500mts from the proposed quarry lease area. The SEAC noted that the mine lease area is 2.0 Ha. which is less than 5.0 Ha. Hence, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report. The proponent further informed that the mining operations are not started.

The nearest village is Venkatapur Agraharam (V) exists at a distance 0.97 km (NE); nearest water body i.e., Cheruvu exists at a distance of 0.55 km (E) and Nearest RF i.e. Minajipet RF exists at a distance of 1.0 km (NE) from the mine lease area.

It is proposed to mine maximum production of 64,320.0 m<sup>3</sup>/annum of Road metal and Building stone and the life of mine is reported as 9.34 years.

The proponent submitted a copy of lr.dt.27.04.2023 of ADMG, Medak District stating that there is no working or production from the date of expiry of the quarry lease i.e 11.10.2019 to till date.

The proponent informed that they have done CSR activities in the nearest village and submitted a copy of Certificate dt.12.01.2019 issued by the Sarpanch, Gram Panchayath, Ghanpur Village, Toopran Mandal, Medak District informing that the proponent has donated Rs. 60,000/- worth material for development of village.

The total cost of the project is Rs. 20.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 4.51 lakhs and recurring cost: Rs. 2.55 Lakhs/annum.

The proponent submitted undertaking letter with a commitment that they will develop greenbelt with an area of Acres 3.04 and also along the connecting roads to the mine lease area.

After detailed discussions, the SEAC recommended for issue of EC.

The representative of the project proponent Sri Santhoshi and Sri G.V. Reddy of M/s. Team Labs & Consultants, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that earlier, the SEIAA, TS issued TORs (auto-generated) dt.02.03.2023 for preparation of EIA Repor. Accordingly, the proponent prepared the EIA report and uploaded online.

The SEAC noted that total plot area is 34,306.4 Sq.m., Out of which green area is 3,523.0 Sq.m. (10.3%).

It was informed that the total built up area of the project is 2,41,156.3 Sq.m. The project consists of Residential Apartments Construction Project to accommodate total no. of 1088 units. Maximum No. of floors proposed in the project are Residential Apartments with 8 Towers (2B+S +17 Floors) and Amenities (2B+G+ 5 Floors).

It is also noted that Parking area to be provided is 72,755.8 Sq.m. (43.2% against required 22%)

The total cost of the project is Rs. 538.51 Crores. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 600.3 Lakhs during construction phase and Rs. 17.8 lakhs during occupation phase, Recurring cost: Rs. 78.6 lakhs/annum during construction phase and Rs. 182.9 lakhs/annum during occupation phase.

During presentation, the proponent submitted an undertaking for development of greenbelt stating that they will undertake about 100 no. of trees will be planted in the project site.

Earlier, the SEIAA, TS issued EC vide order dt. 03.07.2021 for construction of Residential Apatments with total built up area of 31,127.3 Sq.m. The proponent informed that they have obtained CFE dt.16.01.2023.

Now, the proponent informed that there is increase in built-up area and no. of units due to which there are changes w.r.t built-up area, No. of units, parking area, Water requirement, Wastewater generation, Solid waste, STP capacity, Capital Cost & EMP Cost. It was also informed that construction was started. The SEAC noted that the proponent submitted EIA report. Hence, it was requested to issue amendment to EC with the following changes:

The proponent submitted Structural stability certicate dt.03.05.2022 stating that the strucutal designs for the proposed Residential Apartment Project comprises of 5 Residnetial Towers i.e A,B,C, D & E with amenities within the tower. Residential buildings comprises of Cellar + Ground Floor + 5 Upper floors and for club house Ground floor + 3 upper Floors of M/s. Sahiti Suharika Estates Private Limited, Survey No. 691/1, Gundlapochampally, Gundlapochampally Municipality, Medchal Mandal, Medchal – Malkajgiri District. The structure is a reinforced concrete framed structure with RCC wall and slab system for its residential floors and is complying with the Bureau of Indian Standard norms and design is safe and suitable for the purpose for which it is intended. It has been designed in accordance with IS: 456 and IS: 875 and the structure falls under seismic zone II as per Seismic code IS: 1893 (part 1) 2016. The design is done for the same and shall be detailed accordingly as per relevant Indian standard codes.

The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report. The proponent further informed that the mining operations are not started.

Ch. Qed of CHAIRMAN, SEAC

The proponent submitted Structural stability certicate stating that the proposed Commercial IT Building consisting on 3 Cellar + 1 Ground + 14 Upper Floors in Sy.No. 158 situated at Narsingi (V), Gandipet (M), Rangareddy District belongs to M/s. Vamsiram Builders and Developers Private Limited Rep by Sri. B.Subba Reddy, S/o. Sri. B. Gopal Reddy. The structure are consisting of 3 Cellar + 1 Ground + 14 Upper Floors 1 Block and at the initial approval stage the structures are submitted for 3 Cellar + 1 Ground + 13 Upper Floors and during the construction stage the structures revised 3 Cellar + 1 Ground + 14 Upper Floors. However, the foundations were designed for an initial stage itself for 3 Cellar + 1 Ground + 14 Upper Floors in view of the future expansion. Hence, the foundations were capable of taking the load of 3 Cellar + 1 Ground + 14 Upper Floors proposed floor plans are suitable for RCC structure. The foundation are being designed or SBC of IS 1498 as per the Geotechnical Report. The design are as per IS 456, IS 875 & IS 1893 (part-01) – 2016 for loading.

During presentation, the proponent informed that they have obtained NOC dt.24.03.2021 for height clearance from Airports Authority of India w.r.t. the proposed project and submitted a copy of the same. It is observed from the NOC that the site elevation is 531.3 mts AMSL and the permissible top elevation is restricted to 681.3 mts AMSL. The SEAC noted that the height of the building is within the permissible top elevation restricted by the AAI. The proponent submitted the Risk Assessment report & Disaster Management Plan.

After detailed discussions, the SEAC recommended for issue of Amendment to EC.

The representative of the project proponent Sri B.Srinivasa Raju and Sri G.V. Reddy of M/s. Team Labs & Consultants, Hyd erabad attended and made a presentation before the SEAC.

The SEAC noted that earlier the SEIAA, TS issued TORs on 31.12.2019 for preparation of EIA Report. Accordingly, the proponent undergone the process of public hearing on 19.08.2022 and submitted Final EIA Report along with minutes of public hearing and issues emerged during public hearing. The SEAC noted the contents of Final EIA report. The SEAC observed from the minutes of Public Hearing that the issues are: air pollution, dust pollution, ground water contamination, no employment to local people, damage to agricultural crops. The SEAC observed that almost all the speakers opposed the project and only NGOs proposed the project. The SEAC noted that the project proponent uploaded EIA Report on 17.02.2023.

The SEAC noted the initial lease was granted on 28.08.2018 in favour of proponent for a period of 20 years. It may be noted that the Mine Lease was granted after 09.09.2013. The proponent submitted lt.dt.27.09.2018 issued by ADMG, Sangareddy informing that there are no quarry leases within the radius of 500mts. The SEAC noted that the mine lease area is 10.117 Ha. which is more than 5.0 Ha. and thus the project has to be considered under B1 Category as per provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT.

The nearest human habitation is Govindapur village @ 0.5 km (N); Nearest water body i.e unidentified water body exsits at 1.2 km (NE) and Nearest RF i.e. Anigunta RF exists at a distance of 2.8 km (S) from the mine lease area.

It is proposed to mine 3,93,642.5 TPA of Laterite and the life of mine is reported as 5 years.

The total cost of the project is Rs. 100.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 6.75 lakhs and recurring cost: Rs. 2.48 Lakhs/annum.

The SEAC informed the proponent to submit clarification on the issues raised by the participant in the Public hearing as most of the participants opposed the project.

The SEAC deferred the project for consideration after submission of above mentioned information by the proponent.

Accordingly, the proponent submitted a copy of lr.dt.18.04.2023 of ADMG, Rangareddy, stated that they have not commenced quarrying operations and not obtained any dispatch permits from the date of execution to till date, hence the production may be treated as nil.

After detailed discussions, the SEAC recommended for issue of EC.
