The Authority after detailed discussion and deliberation decided the following:

- Serial No. 1, 2, 3, 4, 5, 20, 21, 23, 24, 26, 27: The Authority accepted the recommendations of SEAC and decided to grant EC these proposals.
- Serial No. 6, 10, 12, 13, 14: The Authority accepted the recommendation of SEAC and decided to grant ToR to these proposals.
- 3. Serial No. 7: In this proposal, the shape of uploaded KML is different from Mining Maps owing to which mining is visible outside the lease area. Also, Nimbol Kharadi road is passing through the lease area, for which no safety zone is proposed. SEAC in its recommendations considered it a case of violation stating "the production of minerals were commenced during 1997-2003 without obtaining prior EC".

Since, the Mining is visible outside the lease area and PP has also admitted violation in affidavit submitted. Hence, the Authority decided to grant ToR under Violation to this proposal with the direction to submit correct KML & clarification on above mentioned facts at the time of final application.

- 4. Serial No. 8: The Authority accepted the recommendations of SEAC and decided to grant ToR to this proposal with the direction to submit DSR for the proposed mineral at the time of final application.
- Serial No. 9, 15, 16, 17, 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, 41: The Authority accepted the recommendations of SEAC and decided to close & delist these proposals.
- 6. Serial No. 11: In this proposal, Earlier EC was granted by DEIAA on 10.03.2016. But, according to the AME Certificate the production of mineral was increased from the base year. The PP and the consultant in their affidavit has also

stated that the mining activity has been undertaken in violation. Hence, the Authority accepted the recommendations of SEAC and decided to **grant ToR** under violation to this proposal, with the direction to submit DSR of the same district at the time of final application.

- 7. Serial No. 18: The Authority accepted the recommendation of SEAC and decided to grant EC to this proposal subject to the condition mentioned in LoI and WRD condition regarding natural flow of nallah shall be adhered to.
- 8. Serial No. 19, 25: The Authority accepted the recommendations of SEAC and decided to approve EIA/ EMP and grant EC to these proposals with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- Serial No. 22: As per KML, the proposed project is located in the submerged area of Karni Sagar talab. Hence, the Authority accepted the recommendation of SEAC and decided to reject this proposal.
- 10. Serial No. 28: The Authority accepted the recommendations of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that issues raised in public hearing are to be implemented by all the lease holders of the cluster and they shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 11. Serial No. 42: The proposal was deferred in the 5.58th meeting and the Authority had decided to call PP/ Consultant for Personal Hearing for clarification on the parking required and parking provided. Now, the PP and Consultant have clarified the same in the personal hearing which was found satisfactory. Hence, the Authority decided to grant EC to this proposal.

- 13. Serial No. 44: The proposal was deferred in the 5.58th meeting and the Authority had decided to call PP/ Consultant for Personal Hearing for clarification on non-compliance of CSR expenditure in Certified Compliance Report. PP/ Consultant agreed the non-compliance of the same in personal hearing. Hence, the Authority decided to defer the proposal with the direction to submit Clarification Report of the same with expenditure incurred duly certified by Charted Accountant.
- 14. Serial No. 45: The proposal was deferred in 5.58th meeting for the details of BG and PP/ Consultant was called for Personal Hearing. Now, the MS SEAC has clarified the details of BG and penalty to be imposed, stating that the earlier indicated amount of BG was a typing error.

The PP/ Consultant has submitted the revised plan which on examination was not found appropriate. - 17. Serial No. 49: The proposal was deferred in 5.54th meeting of the Authority for submission of DSR of the proposed mineral. Now, the PP/ Consultant has submitted the same. Hence, the Authority has decided to grant EC to this proposal.
