The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No. 1: The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal subject to condition that the applied area is at a distance of more than 50 meters but less than 100 meters from the boundary of the closest forest area, therefore the project proponent shall raise a pakka wall on the lease boundary facing the forest area.
- 2. Serial No. 2, 3: The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals subject to the condition that the EC shall be effective only after valid CTO has been obtained.

- 7. Serial No. 26: Considering the decision of SEAC, if the mention of TTZ had been omitted in Form 1 and PFR, the issue should have been resolved by SEACwith the PP. The formalities required for the projects in TTZ area, should have been followed. This has been done in earlier cases also, which were received from this area. Hence, the current recommendation of SEAC is in contradiction to the recommendations made earlier by SEAC for the similar situation and same area. Therefore, the Authority decided to refer back this proposal to SEAC-1.
- 8. Serial No. 22: The Authority accepted the recommendation of SEAC and decided to grant ToR subject to submission of distance of forest by concerned DCF and to provide the details of CTO at the time of submission of ToR compliance.
