The representative of the project proponent Sri Buddha Giridha and Sri G.V. Reddy of M/s. Team Labs & Consultants, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that total site area is 90,792. Sq.m. Out of which green area is 9,899 Sq.m. (10.9 %). The total built-up area of the project is 77,808.3 Sq.m. The project consists of residential villas to accommodate 147 units. The project consists of villas (G+2 floors) and

amenities (G+3 floors). It is also noted that each villa will be provided with 2 parking spaces each. The total cost of the project is Rs.129.69 Crores. The proponent is proposing budget for environmental protection towards capital cost: Rs.194.2 lakhs during construction phase and Rs. 4.8 lakhs during occupation phase, recurring cost: Rs. 11.9 lakhs/annum during construction phase and Rs. 53.5 lakhs/annum during occupation phase. The proponent submitted land documents.

After detailed discussions, the SEAC recommended for EC with the following additional conditions in addition to the Specific/Standard/General conditions applicable to the project:

- 1. The proponent shall make an arrangement for a maintenance contract with any operator of the STP for a minimum period of 10 years and shall be extended from time to time.
- 2. The proponent /Builder shall ensure that the environmental issues (Sewage treatment, Solid waste management) shall be addressed even after handing over the building to the association members. The proponent shall make an agreement with the residential Associations members.
- 3. The proponent shall ensure that the Sewage generated is properly treated and shall be reused at the maximum extent.
- 4. The proponent shall not discharge waste water outside the premises.
- 5. The proponent shall provide LED lights in the project to the maximum extent.
- 6. The proponent shall provide rain water harvesting pits.
- 7. The proponent shall use fly-ash bricks during construction of villas as committed during the meeting.
- 8. The proponent shall dispose concrete waste as per C&D waste Rules, 2016.

#### **Deliberations:**

The representative of the project proponent Sri Rahul Veeravalli and Sri G.V. Reddy of M/s. Team Labs & Consultants, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that total plot area is 9,461.0 Sq.m. Out of which green area is 954.4 Sq.m. (10.1 %). The total built up area of the project is 83,888.7 Sq.m. The project consists of residential apartments to accommodate total No. of 326 units. The project consists of 2 blocks with (3B + S + 33 Floors) and amenities with (3B + G + 4 floors). It is also noted that parking area is 22,499.5 Sq.m. (36.7% against required 33%). The total cost of the project is Rs. 180.0 Crores. The proponent is proposing budget for environmental protection towards capital cost: Rs.211.0 lakhs during construction phase and Rs. 5.7 lakhs during occupation phase, recurring cost: Rs.39.5 lakhs/annum during construction phase and Rs.54.4 lakhs/annum during occupation phase.

During presentation, the proponent informed that they have obtained NOC dt.04.07.2023 for height clearance from Airports Authority of India w.r.t. the proposed project and submitted a copy of the same. It is observed from the NOC that the site elevation is 471.69 mts AMSL and the permissible top elevation is restricted to 691.69 mts AMSL.

The proponent submitted land documents. The proponent shall submit Mechanical Ventilators for Air circulation as they have proposed 3 basements.

After detailed discussions, the SEAC deferred the proposal and directed to address a letter to irrigation department copy mark to GHMC with a request to provide whether the proposed site is falling under musi river catehment or not and the distance from the musi river boundary to site boundary.

### **Deliberations:**

The representative of the project proponent D. Srinivas Raju and Sri G.V. Reddy of M/s. Team Labs & Consultants, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that total plot area is 1,33,620.0 Sq.m. Out of which green area is 13,461.0 Sq.m. (10.07%). The total built up area of the project is 94,182.6 Sq.m. The project consists of Data center building construction project consisting of 2 blocks – 1 & 2 each with (G + 3 floors); Gateway (Ground floor), Guard block (Ground floor), HSD tank (Ground floor), UG tank (Ground floor) & Sub-station (G+1 floor). It is also noted that parking area is 30,823 Sq.m. (33.8% against required 33%). The total cost of the project is Rs. 2000.0 Crores. The proponent is proposing budget for environmental protection towards capital cost: Rs.401.5 lakhs during construction phase and Rs. 4.0 lakhs during occupation phase, recurring cost: Rs.58.0 lakhs/annum during construction phase and Rs.86.3 lakhs/annum during occupation phase. The proponent submitted land documents.

After detailed discussions, the SEAC deferred the proposal with ADS for the following:

As per G.O.Ms.No.105, dt.28.06.2023, the proposed site Sy.Nos. 468/part, 469 & 470/part are designated as manufacturing use zone for setting up of raw agarbathi (bamboo stick, saw dust, wood charcoal powder) under green category. Whereas, the proposed activity i.e., data center with more than 5 MW DG sets falls under Red category. Hence, the proponent is directed to submit the clarification on the above point.

# **Deliberations:**

The representative of the project proponent Sri G. Bharadwaj and Sri Vishnu Sharma of M/s. Ampl Environ Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

The SEAC noted the lease was initially granted on 27.02.2001 in favour of Sri Md. Sardar khan to an extent of 0.75 ha. for a period of 10 years i.e upto 26.02.2011. Later, the execution of transfer lease deed was granted on 05.09.2012 in favour of M/s. Sri Anjaneya Metal Suppliers to an extent of 0.75 ha. for a period upto 26.02.2021. Then, again the execution of transfer lease deed was granted on 12.04.2018 in favour of the proponent to an extent of 0.75 ha. for un-expired period of lease i.e., upto 26.02.2021. As per the Proceedings dt.22.02.2022 issued by the DMG, Warangal district, it is stated that out of total extent of 0.75 Ha. an area of only 0.25 Ha. is falling within the safety distance radius of proposed pump house and hence, requested for considering of balance available extent of 0.50 Ha. which is falling outside the safety distance. The LOI was granted on 31.05,2022 to an extent of 0.50 Ha. for a period of 20 years. It may be noted that the Mine Lease was

granted before 09.09.2013. Hence, cluster is not applicable to the project. The SEAC noted that the mine lease area is 0.50 Ha. which is less than 5.0 Ha. Thus, the project is considered under 'B2' Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The SEAC noted that the ADMG vide letter dt.02.05.2023 mentioned that the quarry lease is non-working since expiry of the lease period and the 1<sup>st</sup> renewal of quarry lease application is under process. Hence, violation does not attracts.

The representative of the project proponent Sri B. Srinivas Reddy and Sri Vishnu Sharma of M/s. Ampl Environ Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.
