Agenda item- 1. Conformation of the resolutions adopted the 2nd meeting of SEAC, Assam

Resolution 3/1: The Chairman SEAC, Assam read out the minutes of the 2nd meeting of SEAC, Assam held on 29th July, 2020 and the resolutions have been approved.

Agenda item- 2.

1. Proposal for New Umrangshu limestone Dima Hasao (TOR) by M/s NECEM Cements. (SEIAA. 1145/2020)

Resolution 2/2:

The proposal is for Plan Period 2015-16 to 2019-2020 for extraction of 80,000 tones of line stone per year. After due deliberation on the project Proposal, the Committee **recommended** for issuance of **TOR** to prepare detail EIA.

3. EC for Ordinary Earth from "Solengi River bed MPA" under Sonitpur East Division by ECI Engineering & Construction Co. Ltd. (SEIAA.1190/2020)

Resolution 2/4:

On scrutiny of documents and after due discussion, the committee recommended the project for two years for extraction of 60,000 cum of ordinary earth per annum / year ensuring that the depth of extraction should not be more than 1.0 mts (One mts) and extraction is permitted minimum 50 mt distance from the high bank. The DFO, Sonitpur East Division should ensure extraction / operation of the project as per above noted conditions.
