At the outset the Chairman, SEAC welcomed the Members of the SEAC and advised the Secretary to give brief background of this meeting.

It was informed to the Committee that the tenure of SEIAA/SEAC, Haryana was completed on 20.08.2018 and 142 cases were transferred to Ministry of Environment, Forests & Climate Change (MoEF&CC) on 14.09.2018. After the constitution of new Committee on 30.01.2019, the MoEF&CC is requested to send back the cases to the SEIAA but still cases have not been received in the SEIAA and thereafter, in view of delay of cases in receiving from MoEF&CC, presently, in this meeting 15 number projects received from SEIAA are taken up for scoping, appraisal and grading as per agenda circulated.

176.01 Environment Clearance for expansion of warehouse for storage of Non agriculture produce (Logistic), at Village Jhamuwas & Gudhi, District-Mewat, Haryana by M/s Gokaldas Warehousing Corporation

Project Proponent : Mr Rajender J. Hinduja

Consultant : M/s Grass Root Consultancy

The Project Proponent (PP) informed that ToR was granted by SEIAA Haryana vide letter no.SEIAA/HR/2018/858, dated 07.8.2018. Thereafter, the tenure of SEIAA/SEAC, Haryana was completed on 20.08.2018 and further EIA/EMP report was submitted to (MoEF&CC), GoI, New Delhi on 02.11.2018 following which the project was appraised during 15th EAC Meeting held on 29.11.2018 and further the project was considered during the 19th EAC Meeting held on 25.02.2019 for which the Minutes are still awaited. As per the MoEF&CC order dated 23.10.2017, Para 3

"In case the proposal is appraised by the EAC due to non-existence of SEIAA/SEAC, then irrespective of whether recommended, deferred, or additional information sought, it continued to be appraised and decided at the central level even SEIAA/SEAC is constituted later on".

The PP informed in writing that in the last meeting of MoEF&CC held on 25.02.2019 the project has been considered for grant of environment clearance and requested that the project be removed from the Agenda and accordingly Committee accepted the request and allowed to file the case.

176.02 Environment Clearance under violation notification dated 14.03.2017 for Commercial Building Project at plot no.M-1, Village- Samaspur, Bindapur, Sector-51, Mayfield Garden, Gurgaon, Haryana by M/s Sunvision Builders Pvt .Ltd.

Project Proponent : Mr P. K.Gupta

Consultant : M/s Grass Root Consultancy

The project was submitted to the SEIAA and the Project Proponent (PP) informed that ToR was granted by SEIAA Haryana vide letter no.SEIAA/HR/2018/848, dated 07.08.2018. Thereafter, the tenure of SEIAA/SEAC, Haryana was completed and further EIA/EMP report was submitted to Ministry of Environment, Forests & Climate Change (MoEF&CC), GoI, New Delhi on 02.11.2018 following which the project was appraised during 15th EAC Meeting held on 29.11.2018 and further the project was considered during the 19th EAC Meeting held on 26.02.2019 for which the Minutes are still awaited. As per the MoEF&CC order dated 23.10.2017, Para 3

"In case the proposal is appraised by the EAC due to non-existence of SEIAA/SEAC, then irrespective of whether recommended, deferred, or additional information sought, it continued to be appraised and decided at the central level even SEIAA/SEAC is constituted later on".

The PP informed in writing that in the last meeting of MoEF&CC held on 26.02.2019 the project has been considered for grant of environment clearance and requested that the project be removed from the Agenda and accordingly Committee accepted the request and allowed to file the case.

176.03 Environment Clearance for IT Office Complex Project at Village Sarai Khwaja, Faridabad by M/s SFG Exports (INDIA) Pvt. Ltd.

Project Proponent : Mr Narinderjeet Singh

Consultant : M/s Grass Root Consultancy

The project was submitted to the Environment Appraisal Committee (EAC), MoEF & CC, Government of India, vide proposal number IA/HR/NCP/ 63612/2017 dated 11.04.2017. The project proponent has submitted the Form -1 and Form-1A to the SEIAA with reference to the Notification No. S.O.804(E), dated the 14th March, 2017 and subsequent Notification No. S.O.1030(E) dated 08th March, 2018, issued by the Ministry of Environment, Forest and Climate Change. The MoEF&CC has prescribed the process for appraisal of projects for grant of Terms of Reference and Environmental Clearance, which have started the work on site, expanded the production beyond the limit of environmental clearance or changed the product mix without obtaining prior environmental clearance as mandated under the Environment Impact Assessment Notification, 2006 [S.O.1533 (E), dated the 14th September, 2006; The Ministry of Environment, Forest and Climate Change in the Notification dated 08.03.2018 inter alia, directed vide sub-paragraph (2) of paragraph 13, that in case the projects or activities requiring prior environmental clearance under Environment Impact Assessment Notification, 2006 from the concerned Regulatory Authority, are brought for environmental clearance after starting the construction work, or have undertaken expansion, modernization, and change in product-mix without prior environmental clearance, these projects shall be treated as cases of violations and in such cases, even Category B projects which are granted Environmental Clearance by the State Environment Impact Assessment Authority constituted under sub -section (3) section 3 of the Environment (Protection) Act, 1986 shall be appraised for grant of environmental clearance only by the State Expert Appraisal Committee and Environmental Clearance will be granted at the State level by State Environment Impact Assessment Authority constituted under sub -section (3) section 3 of the Environment (Protection) Act, 1986.

The Terms of Reference were approved by the EAC, MoEF&CC, Gol in its 04th meeting held on 19th-21st Feb., 2018 vide letter No. 23-1/2018-1A.III dated 09th March, 2018 for built up area of 28331 Sq. Meters in total plot area of 10218.22 Sq. Meters. The PP submitted the EIA/EMP on dated 19.05.2018. Thereafter the proposal was considered by the State Expert Appraisal Committee, Haryana in its 172nd meeting held on 03.07.2018 for appraisal under violation Notification dated 14.03.2017 and 08.03.2018 respectively.

During discussions, it was pointed out that the PP had submitted the incomplete remediation plan and natural and community resource augmentation plan from which the BG could be assessed. The committee is of the view that the PP should submit detailed ecological damage assessment, remediation plan, physical & community level augmentation plan so that the case could be heard for further appraisal.

The observations of 172nd meeting were conveyed to the PP vide letter No. 2922 dated 11.07.2018. The PP submitted the reply vide letter dated 18.07.2018. Thereafter, the case was taken up in the 174th meeting of the SEAC held on 08.08.2018.

The project proponent had submitted remediation plan twice but it was found deficient. The Committee is of a unanimous view that PP should submit revised remediation plan alongwith cost assessment, natural and community resource augmentation plan corresponding to ecological damage assessed and economic benefits derived due to violation to be prepared from reputed Government Institution.

Project proponent requested for deferment of their case for the next meeting to be held on 13.07.2018. The Committee unanimously accepted the request of the PP and made clear that no separate letter shall be issued for attending the meeting. Thereafter, the case was taken up in the 175th meeting of the SEAC held on 13.08.2018.

The case was heard at length. The Committee was of the unanimous view that the PP has failed to submit the required documents as asked earlier. PP is again requested to submit the revised remediation plan alongwith cost assessment, natural and community resource augmentation plan corresponding to ecological damage assessed and economic benefits derived due to violation duly vetted from the reputed Government Technical Institution.

Thereafter, the Committee's tenure was expired on 20.08.2018 and case was transferred to MoEF&CC on 14.09.2018. Whereas after the constitution of new SEIAA/SEAC, the case file is not received in SEIAA/SEAC, Haryana and on request of PP the case was heard in the meeting.

After deliberation, the following shortcomings were observed:

- i) The PP will submit Solid Waste Management Plan as per the Notification
- ii) The PP shall submit Ground Water Analysis Report
- iii) The PP shall submit NOC issued from Wildlife Department that the project does not fall within the Eco Sensitive Area as notified under Section 3 of Environment Protection Act, 1986
- iv) The PP shall submit Green Plantation Plan

- v) The PP shall submit revised details for dispersion Modeling Analysis
- vi) The PP shall submit Rain Water Harvesting plan of the project without any ambiguity
- vii) The PP shall submit the mitigation plan for improving noise quality of the project
- viii) The PP shall submit energy saving details for the project and detailed ECBC compliance in project.
- ix) The PP shall submit details of Green Building Plan.
- x) The PP shall submit sun path simulation study for building orientation.
- xi) The PP shall submit incremental load statement for expansion project.
- xii) PP shall submit detailed remedial plan alongwith costs assessment.

It was decided by the Committee that the case will be taken up in next meeting and PP is advised to submit the required signed documents. In case of non-receipt of information, in time, the case shall be recommended for rejection/filing.

176.04 Environment Clearance for IT Park 'Gateway Tower' at Village Sarai Anangpur, District Faridabad (Haryana) by M/s Dove Infrastructure Pvt. Ltd.

Consultant : M/s Grass Root Consultancy

The project was submitted to the SEIAA and was informed by the Project Proponent (PP) that ToR was granted by MoEF&CC vide File no.23-63/2018-IA-III, dated 16.04.2018. Thereafter, the tenure of SEIAA/SEAC, Haryana was completed and further EIA/EMP report was submitted to Ministry of Environment, Forests & Climate Change (MoEF&CC), GoI, New Delhi on 02.11.2018 following which the project was appraised during 17th EAC Meeting held on 29.01.2019. As per the MoEF&CC order dated 23.10.2017, Para 3

"In case the proposal is appraised by the EAC due to non-existence of SEIAA/SEAC, then irrespective of whether recommended, deferred, or additional information sought, it continued to be appraised and decided at the central level even SEIAA/SEAC is constituted later on".

The PP informed in writing that in the last meeting of MoEF&CC held on 29.01.2019 the project has been considered for grant of environment clearance and requested that the project be removed from the Agenda and accordingly Committee accepted the request and allowed to file the case.

176.05 Environment Clearance for Group Housing Colony Village Badshahpur, Sector- 68, Gurgaon by M/s Golden Glow Estate.

Consultant : M/s Grass Root Consultancy

The Project Proponent informed that ToR was granted by SEIAA Haryana vide letter no.SEIAA/HR/2018/847, dated 07.8.2018. Thereafter, the tenure of SEIAA/SEAC, Haryana was completed and still the file from the MoEF&CC has not been received after the constitution of new Authority. However, EIA/EMP report is to be submitted by the PP and still the public hearing is also to be conducted and PP submitted in writing and requested that the project be removed from the Agenda. The Committee accepted the request and allowed to file the case.

176.06 Environment Clearance for Stone Mining Project (13579949 TPA Stone & 1508883 TPA mineral reject), Khasra No.-132, Total Area 48.87 ha., Near Village: Dadam, Tehsil Tosham, District Bhiwani (Haryana) by M/s Govardhan Mines & Minerals.- Reg. ToR

Project Proponent : Absent Consultant : Absent

The Project Proponent submitted online application for approval of ToR for the said project but the PP has not submitted the approved mining plan from the Mines & Geology Department, Haryana. The mining permission was granted on the basis of previous environment clearance by the Mining Department as the case was pending before the Hon'ble NGT. As per orders, the EC shall be granted by SEIAA in two months. The project was taken up in the 176th meeting but no project proponent/consultant/coordinator was present. Therefore, the Committee decided that the case be deferred. The PP be advised to submit the required documents within 15 days and it was made clear to the PP that the project will be considered as received only after the receipt of complete information. In case of non-receipt of information, in time, the case shall be recommended for rejection/filing.

176.07 Environment Clearance for proposed Common Bio Medical Waste Treatment Facility (CBWTF) located at Khatoni No. 157, Village Bazida Jatan, near railway crossing, Tehsil & District-Karnal, Haryana by M/s Haat Supreme Wastech Pvt. Ltd.

Project Proponent : Mr Dinesh Rana

Consultant : M/s Gaurang Consultancy

The project was granted ToR by SEIAA on 15.03.2017 and after the completion of term of SEIAA on 20.08.2018 the case file was transferred to MoEF&CC on 14.09.2018. Whereas after the constitution of new SEIAA/SEAC, the case file was not received in SEIAA/SEAC, Haryana and on request of PP the case was not taken in the meeting and it was decided by the Committee that the case will be taken up after receipt of the case file from MoEF&CC.

176.08 Environment Clearance for Revision cum Expansion of Residential Plotted Colony "Vatika City Central" at Village Sarai Mahdood, Sonda, Kanwali, District Ambala, Haryana by M/s Vatika Limited.

Project Proponent : Mr. Virendhar Consultant : M/s Vardan Enviro

The ToR was approved by MoEF&CC, GoI on 22.06.2015 and the case was taken up in the 158th Meeting of the SEAC on 28.09.2017. After the completion of the term of SEIAA the case file was transferred to MoEF&CC on 14.09.2018. Whereas after the constitution of new SEIAA/SEAC, the case file was not received in SEIAA/SEAC, Haryana and it was decided by the Committee that the PP shall get extend the EC granted in 2009 which has already been expired in 2016. The Committee decided that the project will be taken up after receipt of the case file from MoEF&CC.

176.09 Environment Clearance for Revision in Environmental Clearance (No increase in Pollution load) of Group Housing by M/s Godrej Properties I td.

Project Proponent : Mr. Rahul Soni

Consultant : M/s Perfact Enviro Solutions Pvt. Ltd.

The PP appeared before the Committee and given in writing that the proposed project by the M/s Godrej Properties Ltd. listed in 176th Agenda for appraisal on 28.02.2019, is not proposed under the company name and hence, the PP requested to withdraw the project proposal. The Committee accepted the request of PP for withdrawal of the project and the case was filed.

176.10 Revision in Environmental Clearance of Group Housing at Sec-88A &89A, Village Harsaru, Tehsil Gurgaon, Gurgaon, Haryana by M/S Oasis Landmarks LLP.

Project Proponent : Mr. Rahul Soni

Consultant : M/s Perfact Enviro Solutions Pvt. Ltd

As the tenure of Haryana, SEAC was completed the project was applied in MoEF&CC for revision in environmental clearance on 15.10.2018. Later on case was transferred to SEIAA/SEAC, Haryana after formation of Committee and case was considered by Haryana SEAC in 176th Meeting held on 28.02.2019.

The project proponent presented the case for grant of Terms of Reference. During presentation, the Committee was informed that it is proposed project is the Revision in Environmental Clearance of Group Housing Complex shall be located at Village Harsaru, Sector 88A & 89A, Gurgaon, Haryana being developed by M/s Oasis Landmark LLP.

The Project has already been granted Environmental Clearance vide letter no.SEIAA/HR/2017/616 dated 14.09.2017 for the plot area 59423.98 m² and built up area 157089.09 m² under the name of M/s Oasis Buildhome Pvt. Ltd. Later on developers of the project has been changed to M/s Oasis Landmark LLP.

Permission for change of developer was obtained by Directorate of Town and Country Planning, Haryana and the same was submitted with application.

The estimated cost of the project is Rs.450 Crores. The total Plot area is 14.684 Acres i.e. 59423.98 sqm Total built up area after revision will be 162273.564 sqm. Basement area of 42315.58 sqm has been proposed. The project will comprise of 747 number of Dwelling units, 135 number of EWS units, 76 numbers of servant units, Community Building/Club, Convenient Shopping and Nursery School. The maximum height of the building is approximately94.52 meters. It was also informed that the green area development has been kept as 17440.62 (35.27% of net plot area), 8511.69 sqm of the total plot area would be earmarked by plantation in the form of shelter belt around the periphery of the project area and in the form of avenue line on either side of the roads 8928.935 sqm of the total plot area under herb/shurbs/climbers/lawns, parks. The total water requirement for the project will be 496.9 KLD (i.e. 280.1 KLD of fresh water and 217 KLD of recycled treated water will be reused). The waste water generation will be 361.2 KLD which will be treated upto tertiary level in 4 STPs of 310 KLD for Parcel A, 250 KLD for Parcel B and 8 KLD for Parcel C & 75 KLD for Parcel D. The STP treated water will be used for flushing, gardening, wet scrubber and other miscellaneous purposes.

Ultra low Sulphur Diesel (5ppm) would be used as fuel in DG Sets, Stack height of DG sets of 5x1010 KVA and 1x750 KVA would be as per CPCB norms. These measures would minimize the impact on air environment.

It was informed by the project proponent that the power requirement for the project will be 4618 KW. Parking requirement for the project as per Haryana

Bye Laws is 1290 ECS. There will be total solid water generation of 2133 kg/day. Out of this, the bio-degradable waste 1493 Kg/day will be composted in 2 numbers of Organic Waste Convertor provided within the project premises and the manure produced will be used for horticulture and green development. The calculations of the same are in accordance with the prescribed norms. It was pointed out that the required water for the project will be provided through HUDA.

After deliberations, it was decided by the Committee that the project proponent will prepare the EIA report by using Model terms of reference of MoEF&CC with following additional terms of reference:

Standard ToR

- Examine details of land use as per Master Plan and land use around 10 km radius of the project site. Analysis should be made based on latest satellite imagery for land use with raw images. Check on flood plain of any river.
- 2) Submit details of environmentally sensitive places, land acquisition status, rehabilitation of communities/villages and present status of such activities.
- 3) Examine baseline environmental quality along with projected incremental load due to the project.
- 4) Environmental data to be considered in relation to the project development would be (a) land, (b) groundwater, (c) surface water, (d) air, (e) bio-diversity, (f) noise and vibrations, (g) socio economic and health.
- 5) Submit a copy of the contour plan with slopes, drainage pattern of the site and surrounding area. Any obstruction of the same by the project
- 6) Submit the details of the trees to be felled for the project.
- 7) Submit the present land use and permission required for any conversion such as forest, agriculture etc.
- 8) Submit Roles and responsibility of the developer etc for compliance of environmental regulations under the provisions of EP Act.
- 9) Ground water classification as per the Central Ground Water Authority.
- 10) Examine the details of Source of water, water requirement, use of treated waste water and prepare a water balance chart.
- 11) Rain water harvesting proposals should be made with due safeguards for ground water quality. Maximize recycling of water and utilization of rain water. Examine details.
- 12) Examine soil characteristics and depth of ground water table for rainwater harvesting.
- 13) Examine details of solid waste generation treatment and its disposal.
- 14) Examine and submit details of use of solar energy and alternative source of energy to reduce the fossil energy consumption, energy conservation and energy efficiency.
- 15) DG sets are likely to be used during construction and operational phase of the project. Emissions from DG sets must be taken into consideration while estimating the impacts on air environment. Examine and submit details.
- 16) Examine road/rail connectivity to the project site and impact on the traffic due to the proposed project. Present and future traffic and transport facilities for the region should be analyzed with measures for preventing traffic congestion and providing faster trouble free system to reach different destinations in the city.
- 17) A detailed traffic and transportation study should be made for existing and projected passenger and cargo traffic.
- 18) Examine the details of transport of materials for construction which should include source and availability.

- 19) Examine separately the details for construction and operation phases both for Environmental Management Plan and Environmental Monitoring Plan with cost and parameters.
- 20) Submit details of a comprehensive Disaster Management Plan including emergency evacuation during natural and man-made disaster.
- 21) Details of litigation pending against the project, if any, with direction /order passed by any Court of Law against the Project should be given.
- 22) The cost of the Project (capital cost and recurring cost) as well as the cost towards implementation of EMP should be clearly spelt out.
- Any further clarification on carrying out the above studies including anticipated impacts due to the project and mitigative measure, project proponent can refer to the model ToR available on Ministry website "http://moef.nic.in/Manual/Townships".

176.11 Environment Clearance for expansion of Group Housing Project located at located at Village Baselwa, Sector-87, Faridabad by M/s Shiv Sai Infrastructure Pvt. Ltd.

Project Proponent : Mr Sandeep Gupta

Consultant : M/s Grass Root Consultancy

The PP requested in written to the Committee that due to unavoidable circumstances, they are unable to present the project in 176th meeting and requested to defer the case. The Committee considered the request of PP and, hence, the project was deferred and will be taken up only after submission of detailed required documents of the project.

176.12 Environment Clearance for Group Housing complex at Village- Nangli Umarpur, Sector-62 by M/s Emaar MGF Land Ltd.

Project Proponent : Mr. Shishir Lal

Consultant : M/s Vardan EnviroNet

The project was submitted for approval of ToR in the MoEF&CC on 07.12.2018. But the case is not listed in the MoEF&CC for the approval of ToR. After the constitution of SEIAA/SEAC, Haryana on 30.01.2019, the case is listed in the present Agenda but the case file has not been received from MoEF&CC yet. The PP is advised to submit the approval of Zoning Plan for the said licence alongwith complete land related papers. The Committee decided to defer the case till the file is received from MoEF&CC. The Committee decided that PP can collect the baseline data on his own risk and behest.

176.13 Environment Clearance for proposed Expansion of Mixed Land Use (Residential & Commercial) Colony measuring 14.4125 Acres in Revenue Estate of Maidawas and Badshahpur, Sector 65 of GMUC, Gurugram by M/S Mangalam Multiplex Pvt. Ltd.

Project Proponent : Mr. Amar Nath Icchpunjani Consultant : M/s Ind Tech House Consultancy

The project was granted Environment Clearance earlier under category 8(b) for $58,325.22\,$ M 2 plot area and $3,47,194.85\,$ M 2 built up area vide file no.21-167/2017-1A-III dated 06.11.2017. The previous EC was granted on conceptual plan.

The EAC, MoEF&CC during deliberation informed to the project proponent that the project proposal was based on conceptual scheme and now the project has been sanctioned by local body and there are some minor changes in sanctioned plan. However, the Committee noted that there was an increased built-up area by 12,745.61 m² alongwith other factors/components.

The Committee in its meeting dated 28.11.2018 also recommended that there is no need for ToR application and the project proponent can submit updated EIA/EMP Report based on the earlier ToR granted for EC letter F.No.21167/2017-IA-III dated 06.11.2017. In the Meeting dated 28.11.2018, the Committee also directed that the proposal may be considered as expansion proposal and not amendment in the Environment Clearance, and accordingly, the project proponent should apply in the appropriate category. The case was taken up in 176th meeting held on 01.03.2019 wherein after presentation the PP/Consultant submitted some duly signed documents i.e. previous ToR, previous EC Letter, Authorization Letter, Aravali NOC, Forest NOC, Consent to Establish, NOC of Height Clearance, ECBC Compliance Report.

After deliberation, the following shortcomings were observed:

- i) The PP shall submit the incremental load statement of expansion
- ii) The PP shall submit the Energy conservation measures including detailed energy requirements
- iii) The PP shall submit the Hydrological Study Plan

- iv) The PP shall submit the EMP
- v) The PP shall submit the in-depth Soil Analysis Report
- vi) The PP shall submit the Green Belt Plantation Plan
- vii) The PP shall submit the CER details
- viii) The PP shall submit the certificate from Wildlife Warden
- ix) The project proponent should submit revised air dispersion modeling giving input data and results
- x) The PP shall submit sun simulation path study for building orientation
