The Chairman, SEAC, Assam presided the meeting and welcoming all the members started the proceedings.

The meeting opened for discussion on the agenda items:

Agenda item- 1.Conformation of the resolutions adopted the 10th meeting of SEAC, Assam

Resolution 10/1: The minutes of the 10th meeting of SEAC, Assam held on 21st Nov, 2020 was placed on the table for perusal and discussion.In the process the following points were discussed and necessary corrections made accordingly.

1. In the list of Members Present in the 9th SEAC meeting the name of the Prof. P.K Saikia was not listed by oversight which has been corrected and entered in the list of 9th SEAC minutes.
2. In the resolution 10/5 under point no. 2&3, the land use map as well as relief maps asked from the P.P in 1:50000 scale. The scale should have been 1:5000 instated of 1:50000 in both the cases.
3. In the resolution 9/1, it is mentioned 8th meeting of SEAC which should have been 9th meeting of the SEAC, Assam.
4. In the resolution no.10/7 under point No.1&2 both the relief and land use map were asked in 1:50000 scale, which should have been 1:5000 scale instated of 1:50000.
