The Authority after detailed discussion and deliberation decided the following:

- Serial No. 1 & 2: These proposals were deferred in 5.57th meeting of SEIAA as LOI of these proposals had expired. Now, PPs have submitted the latest LOI with validity extension. Hence, the Authority accepted the recommendations of SEAC & decided to grant EC to these proposals.
- 2. Serial No. 3: It has been brought into notice of the Authority that the PP has not complied with GC no. 10 & 15 as per the CCR submitted by the Project Proponent. Under these circumstances of non-compliance of conditions of EC issued earlier, it would not be possible to accord the EC for expansion. Hence, the Authority decided to defer this proposal.

The Authority decided to direct the PP to submit the ATR on the Non-Compliance pointed out so that the proposals may be considered. In addition the Authority directed that the PP may submit the Penalty of Rs: 4,50,268.95 and Bank Guarantee of Rs. 11,00,000 /-, failing which action shall be initiated.

3. Serial No. 4: It has been brought into notice of the Authority that the PP has not complied with SC no. 21 & 34 and GC no. 11 & 18 as per the CCR submitted by the Project Proponent. Under these circumstances of non-compliance of conditions of EC

- issued earlier, it would not be possible to accord the ToR for expansion. Hence, the Authority decided to defer this proposal.
- 4. Serial No. 5: This proposal was deferred in 5.62 meeting of SEIAA as DSR was submitted sandstone but the proposal was for soapstone. Now, PP has submitted the correct DSR. Hence, the Authority accepted the recommendations of SEAC & decided to grant EC to this proposal.
- 5. Serial No. 6: This proposal was deferred in 5.58 meeting of SEIAA as CCR was more than one year old. Now, PP has submitted the latest CCR. Hence, The Authority accepted the recommendations of SEAC and decided to approve EIA/EMP and grant EC to this proposal and PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects, subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 5,24,282/- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 10,05,000/- towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.
- 6. Serial No. 7 to 32: The Authority accepted the recommendations of SEAC and decided to **grant ToR to these proposals** subject to the conditions laid down by SEAC.
- 7. Serial No. 33 to 35: These proposals were Close and Delisted on the recommendations of SEAC in 5.63 meeting of SEIAA. However, the Project Proponents have submitted a request to relist the cases citing the reasons for delay in submission of the ADS. The Authority discussed the issue and <u>decided to relist these proposals.</u>
