Kamper Concast Ltd. (Expansion Project), Village:- Mahadeopur Phulari, Tehsil:- Bihta, District:- Patna, State:- Bihar, Existing Capacity:- MS Ingot :- 29,600 MT/Annum Proposed :- MS Ingot:- 53,600 MT/ Annum, Total Capacity:- MS Ingot:- 83,200 MT/Annum. # Recommendation of SEAC:-

# Additional conditions imposed -

- 1. The Committee noted that the industrial unit is situated near a very busy highway where air pollution due to dust is a huge problem. The CER proposal of Project Proponent was modified in the light of above and it was decided that a stretch of 1 km length of the highway each on both sides of main entry gate shall be sprinkled with water atleast twice a day as per requirement to ensure dust suppression on highway together with Balajee Mini Steel and Re-Rolling Pvt. Ltd. situated adjacent to the relevant industrial unit. Committee decided to issue this additional condition to both the units.
- 2. "M/s Balajee Mini Steel and Re-Rolling Pvt. Ltd. shall also contribute in the matter of water sprinkling on the highway 1 km on each side of the their main entry gate. Both the

industrial units shall prepare a Scheme of dust suppression by water sprinkling on highway" and submit it to SEIAA, Bihar with a copy to Bihar State Pollution Control Board, Patna.

# Resolve of the SEIAA:-

- The SEIAA observed few conditions in ToR (Sub-clause (ix) & (x) of Clause 3) have not been dealt / replied by the Project Proponent.
- 2. Representative of Project Proponent and their consultant requested for time for furnishing the same, which was allowed.
- 3. The Project Proponent has provided the required information later on and the same has been noted.

# Additional Condition and Special recommendation common for all proposals of River Sand Mining (Agenda Item No. 02 to 41)

#### Additional conditions imposed -

1. The Project Proponent to prepare cumulative EMP of respective river-stretch in the district along which Mining blocks are situated.

### Special recommendation

The Committee discussed the grant of LoI by Deptt. of Mines and Geology, Govt. of Bihar for whole district to one "settlee" (bandobastidhari) whereas applications for Environmental Clearance coming separately for each Sand Ghats from the same settlee for the concerned district.

The Committee felt that as mentioned in Schedule 1(a) of EIA Notification 2006, separate lease should be granted for individual mine blocks and accordingly Committee directed Project Proponents to endeavour to procure a lease / an assurance from the Deptt. of Mines and Geology, Govt. of Bihar to enter into a separate lease agreement "Mining Block-Wise" before issuance of work permit to the proponents. The SEAC made its above decision applicable on ToR already granted / issued earlier vide their Ref. No. 71 dated 11.03.2019 and Ref. No. 84 dated 10.04.2019.

The SEAC also decided that a letter communicating above decisions to Deptt. of Mines and Geology Govt. of Bihar, be sent by SEIAA, Bihar.

Regarding the issues raised about multiple applications and grant of Environmental Clearances / ToRs, said direction to Project Proponents by the SEAC to endeavour / get assurance for separate leases for each mine plot / application from Deptt. of Mines and Geology, Govt. of Bihar, preparation of cumulative EMP etc, the SEIAA resolved to request SLEAC to discuss the matter threadbare and come up with reasons / logics / basis / necessity for such suggestion comprehensively which can be communicated to the Deptt. of Mines and Geology, Govt. of Bihar. The SEIAA also resolved to request the SLEAC to make available a draft for communicating their views to Government for further consideration.



# Recommendation of SEAC:-

- The proposal was considered in the meeting of the SEAC on 26.02.2019 for ToR. The MoM of the said SEAC meeting was circulated vide ref. no. 71, dated 11.03.2019 of which a copy was sent by email to the Project Proponent.
- Vide SEIAA MoM dated 28.03.2019 (Ref. No. 83, dated 03.04.2019) it was brought to the notice of the SEAC (dated 25.04.2019) that the proposal be reconsidered in the light of its physical situation vis-a-vis Kaimur Wildlife Sanctuary.
- 3. The Project Proponent (via their consultant) submitted an application for having provided inadequate information in the matter with the original proposal for ToR.
- 4. They have submitted that as a result of Hon'ble NGT order the Proposal so submitted originally attracted the provision of General Conditions as being situated within 5 km radius of Kaimur Wildlife Sanctuary and Eco Sensitive Zone notified therefor.
- 5. They have apologized for their mistake of not bringing it on records earlier while calling it an inadvertent mistake.
- 6. The Consultant submitted in the meeting and appealed to allow him to withdraw this proposal for submission to the MoEF&CC, GoI which was accepted. As such the ToR decided in the meeting dated 26.02.2019 stands withdrawn and cancelled.

#### Resolve of the SEIAA:-

SEIAA resolved to agree with the SEAC and allow withdrawal of application for Environmental Clearance by the Project Proponent and cancelled the ToR.
