Condition No.1 of the EC granted to the Lakshmipur Graphite Beneficiation plant stipulated that the said project can only source semi-processed graphite from the Bandhamandi Graphite Mining lease of the PP and that the said EC granted to the project was subject to EC granted to the Bandhamandi Graphite Mining lease. The Bandhamandi Graphite Mines was non-operational for 9 years for renewal of lease deed post submission of EC, FC, etc. Thus, the PP could not have started plant construction activities till the said Bandhamandi Graphite Mining was operationalised.
