The Authority after detailed discussion and deliberation decided the following:

1. Serial No. 1: In this proposal, ownership documents given are defective, this holds both for the office order issued by AME, Jaisalmer dated 20.3.2012 (in which transfer to Mrs. Shraddha Jain is written at one place and transfer to Smt. Rashi Raman stated in next line) and the supposed lease transfer tripartite document is undated and in which Smt. Rashi Raman is recorded as a transferee but signatory is Mrs. Shraddha Jain without any explanation or supporting documents for justifying of signing on behalf of Smt. Rashi Raman.

These defective lease transfer documents raise serious question on authenticity of the lease transfer. PP is directed to submit a detailed clarification along with all necessary supporting documents at that point of time, from the office of Additional Director Mines & Geology (ADMG), Jodhpur. ADMG Jodhpur may also explain why registered lease transfer agreements do not embody the date of the agreement so signed, which is a mandatory requirement of all agreements.

PP shall provide a copy of the letter issued by the Authority in this regard to the ADMG. Jodhpur and submit a receipt from the said office. The letter of ADMG, Jodhpur shall be addressed to MS SEIAA in response to this particular letter.

Hence, the Authority decided to <u>defer</u> this proposal for additional information to be submitted within 45 days.

- 2. Serial No. 2: This proposal was deferred in 5.77 meeting of SEIAA for "personal presence to explain the legal procedure of transfer of lease". Same has been explained by PP which was found satisfactory. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
- 3. Serial No. 3: This proposal was deferred in 5.76 meeting of SEIAA for "show cause notice be issued to PP to explain as to why the application should not be rejected and a legal action be initiated for submission of a false affidavit. Similarly, a show cause notice be issued to consultant to explain as to why the proposal for blacklisting may not be initiated for such gross negligence"

During the personal hearing, PP and consultant admitted the mistake and also submitted an apology letter to the Authority along with the revised correct

affidavits on behalf of PP as well as consultant. Considering the same, the Authority decided to drop the show cause notice and accept the recommendations of SEAC thereby deciding to grant EC to this proposal, subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 175477/- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 360000/- towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

4. Serial No. 4: PP submitted the photographs and during the course of hearing showed the video of the site as well as live on Google Earth which made the position very clear. The portion of habitation in the lease area is of temporary structure of the labour. This entire area has been excluded from mining by PP. Besides this, there is habitation in close proximity to the lease area. PP has assured that there will be no blasting in the lease area and extraction of masonry stone shall be done through mechanized and manual means during day time only.

These shall be incorporated in the conditions of EC along with the condition that PP shall be responsible for taking all measures and precautions required for the safety of the people and children residing in the nearby habitation including to and fro transportation of mineral & to and fro movement of vehicles. To prevent dust pollution a green belt in width of 10m on either side of road shall be created through plantation of trees of minimum 6 feet height.

With the above mentioned conditions, the Authority accepted the recommendations of SEAC and decided to **grant EC** to this proposal.

 Serial No. 5: This proposal was deferred in 5.76 meeting of SEIAA for "submission of CCR and CA certificate with correct figures of turnover". Now, PP has submitted the requisite clarification/documents.

Hence, the Authority decided to accept the recommendations of SEAC and decided to grant EC to this proposal, subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 112966/- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 3 lakh towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

- 6. Serial No. 6: This proposal was deferred in 5.76 meeting of SEIAA for "approved DSR and valid cluster certificate". Now, PP has submitted the approved DSR and valid cluster certificate dated 18.05.2023. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
- 7. Serial No. 7 & 8: These proposals were deferred in 5.70 meeting of SEIAA for "Approved Mining Scheme in the name present lessee and revised Aravali Certificate as the Khasra Number was wrongly mentioned". In the 5.76 meeting of the Authority, PP has submitted the revised mining plan but revised Aravali certificate was not submitted. Therefore, the proposals were deferred in 5.76th meeting for submission of Aravali certificate with correct khasra no. mentioned. Now, PP has submitted the same. Hence, the Authority decided to grant EC to these proposals.
- 8. Serial No. 9: This proposal was deferred in 5.77 meeting of SEIAA for "DSR is submitted for granite and application is for Quartz & Feldspar". Now, PP has submitted the correct DSR. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to this proposal.
- Serial No. 10: Proposal was deferred in 5.72 meeting of SEIAA for "submission of ATR w.r.t non-compliance of GC 10 and 15". Now, PP has submitted the ATR. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
- 10. Serial No. 11, 12, 14, 15, 16, 20, 26, 27, 28, 31, 34: The Authority accepted the recommendations of SEAC and decided to <u>approve EIA/EMP and grant EC</u> to these proposals with the additional conditions imposed by SEAC and that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 11. Serial No. 13: In this proposal, LOI was expired. Hence, the Authority decided to <u>defer</u> this proposal for additional information to be submitted within 45 days.
- 12. Serial No. 17 & 18: The Authority observed that EIA/EMP for the cluster of 101.4467 ha in which the PP's area is also included, has already been approved by the Authority while according EC to M/s. Banas Builders & Developers LLP (Proposal No. 406711). PP has already enclosed a copy of that EC issued. In this situation there is no need to approve another EIA/EMP for the same cluster area.

Accordingly, the Authority decided to grant EC to this proposal on the condition that the PP should adhere to the conditions laid down earlier in the already approved EIA/EMP and the relevant parts of the EMP submitted by the PP in respect of issues raised during Public Hearing of this proposal.

- 13. Serial No. 19: In this proposal, Affidavit from consultant w.r.t no violation, affidavit regarding implementation of cluster EMP from PP and certificate from DCF Pratapgarh were not submitted. Hence, the Authority decided to <u>defer</u> this proposal for additional information to be submitted within 45 days.
- 14. Serial No. 21: In this proposal, affidavit regarding implementation of cluster EMP from PP was not submitted. Hence, the Authority decided to <u>defer</u> this proposal for additional information to be submitted within 45 days.
- 15. Serial No. 22, 25: In these proposals, Affidavit from consultant w.r.t no violation and affidavit regarding implementation of cluster EMP from PP were not submitted. Hence, the Authority decided to <u>defer</u> these proposals for additional information to be submitted within 45 days.
- 16. Serial No. 23, 46: In these proposals, LOI has expired and affidavit regarding implementation of cluster EMP from PP was not submitted. Hence, the Authority decided to <u>defer</u> these proposals for additional information to be submitted within 45 days.
- 17. Serial No. 24: In this proposal, CA certificate w.r.t turnover figure was not submitted. Hence, the Authority decided to <u>defer</u> this proposal for additional information to be submitted within 45 days.
- 18. Serial No. 29, 30, 33, 39, 41, 42, 43, 44, 45, 49, 51, 53, 54, 55, 57: The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals along with the additional conditions imposed by SEAC.
- 19. Serial No. 32, 36, 37: In these proposals, affidavit regarding implementation of cluster EMP from PP was not submitted. Hence, the Authority decided to <u>defer</u> these proposals for additional information to be submitted within 45 days.
- 20. Serial No. 35: In this proposal, DSR was submitted for Granite and application is for Quartz & Feldspar and certified production figures for FY 2022-2023 are not submitted. Hence, the Authority decided to <u>defer</u> this proposal for additional information to be submitted within 45 days.

- 21. Serial No. 38: The Authority accepted the recommendations of SEAC and decided to <u>grant Amendment in EC</u> to this proposal subject to compliance of condition no. 18 of CCR.
- 22. Serial No. 40: In this proposal, General Condition 10 and 15 are mentioned as Not Complied in the certified compliance report of condition given in the earlier EC, for which an ATR is required. Hence, the Authority decided to <u>defer</u> this proposal for additional information to be submitted within 45 days.
- 23. Serial No. 47: In this proposal, there is a High tension line at 10m, Canal at 5m. Hence, the Authority decided to <u>defer</u> this proposal for additional information of WRD Certificate to be submitted within 45 days.
- 24. Serial No. 48, 52: In these proposals, submitted DSR is not approved. Hence, the Authority decided to <u>defer</u> these proposals for additional information to be submitted within 45 days.
- 25. Serial No. 50: SEAC in its 5B.41st meeting recommended to close and delist this proposal since "PP/ Consultant failed to submit an adequate reply to the query letters issued 20.12.22 and 12.1.23. On the basis of production certificate issued by AME, Sawar. The committee recommended to close & delist this proposal and to apply for ToR under Violation".

SEIAA considered the proposal in its 5.69 meeting and decided to refer back the proposal to SEAC for "closer examination and give an opportunity of personal hearing to the project proponent before taking final decision" During the personal hearing consultant/project proponent submitted the Past Production certificate. The Authority examined the production figures submitted by PP in context of the observation of SEAC and disagreed with the views of SEAC. The contention of SEAC of considering monthly production of 2006 and reaching a conclusion of violation on account of production in a month exceeding production in the preceding month was completely unjustified. The Authority did not consider this to be a case of violation since there was no exceeding in annual production over the year. However, SEAC without application of mind sent the file back again to SEIAA with reiterating its recommendations given in 5B.47th meeting.

The Authority is clear that the contention of SEAC is not justified. Accordingly, the Authority overrules the recommendations of SEAC and

based on technical examination by SEAC and examination in SEIAA decided to grant EC to this proposal with standard conditions.

26. Serial No. 56: In this proposal, LOI letter attached in file was different from the one uploaded online. This proposal was referred back to SEAC in 5.65 meeting of SEIAA to "explain the manner in which the proposal was examined and specific reply must be given for the same." But no clarification was submitted. Hence, the Authority decided to <u>Close & Delist</u> this proposal.

The Authority has noted with growing concern the complete carelessness with which the Consultants are submitting the Project proposals. The provision of consultants assisting the Project proponents in submission of proposals for grant of EC is there only for the purpose of the consultants enabling the documentation process as per the requirements of the procedure established, and for which they are paid fees by the PP. However, it has been observed that consultants are paying scant heed to ensure the same. On many cases either no DSR is attached or wrong DSR is attached, conflicting affidavits are attached and the list is endless. On account of this reason a lot of time and effort of the SEACs and the Authority is wasted and cases deferred, causing avoidable delay for the PP. This situation is continuing unabated. In today's meeting too of the Authority there are several such cases which have been deferred on account of careless mistakes of the consultants. Accordingly, the Authority decided that an order be issued imposing fines on such consultants concerned who submit a proposal without essential documents or wrong documents, and do not rectify the situation even at the time of presentation in SEAC. The Authority would hold a separate meeting in this regard and issue an appropriate order.
