- Serial No. 3: The Authority accepted the recommendation of SEAC and decided to close & delist the proposal.
- 4. Serial No. 1: The LoI of this proposal has expired. Hence the Authority decided to defer this proposal with a direction that the project proponent must submit extended LoI letter along with Partnership deed within 45 days for further processing of the proposal.
- 5. Serial No. 37: The Authority decided to defer the proposal with a direction that the project proponent must submit GT Sheet showing 15 km radius and Partnership Deed within 45 days for further processing of the proposal.
- 6. Serial No. 17: The Authority accepted the recommendation of SEAC and decided to grant EC to this proposal with the condition stating that Trees of Neem and Mahua available in Mining Lease area shall not be cut down at any stage of Mining activity.
- 7. Serial No. 44: The recommendation of the SEAC is accepted. EC is granted to the Project Proponent subject to deposit of a penalty of Rs. 634 Lakhs with Rajasthan State Pollution Control Board by way of Demand Draft or through Online Mode and deposit a Bank Guarantee amounting to a total of Rs. 460 lakhs with the Member Secretary, RSPCB for Remediation Plan. Since the project is in violation and is also operational, it is further directed that such penalty amount and the Bank Guarantee be deposited within a period of 15 days from the issue of this order, in absence of which the project may be closed down and further necessary action be taken as per the provision of para 11 (SOP for dealing with violation cases) of the MoEF&CC OM dated 7-7-2021. Detailed order on the file.

A copy of this Order to be sent to Member Secretary, RSPCB to ensure compliance.

8. Serial No. 45: It is a violation case and the proponent had submitted the penalty amount as rupees 10,73,000 which is on actual production basis from year 2001 to 2007. The SOP for penalty calculation as outlined in MOEF&CC Government of India OM 7.7.2021 imposes a penalty on turnover. The Authority was of the view

that the project proponent must submit the turnover figures from 2001 to 2007 certified by a Charted Accountant. Hence the Authority had decided to defer this case for additional information.

The project proponent has now submitted the Turnover figures certified by Charted Accountant in compliance of the directions of the SEIAA meeting 5.38. As per the turnover figures now produced by the Project Proponent, the penalty is now calculated as Rs. 10,28,670.36 /-.

Hence, The Authority decided to grant EC to this proposal subject to deposit of a penalty of Rs. 10,28,670.36 /- with Rajasthan State Pollution Control Board by way of Demand Draft or through Online Mode and deposit a Bank Guarantee amounting to a total of Rs. 36,64,600/- with the Member Secretary, RSPCB for Remediation Plan.

9. Serial No. 46: This proposal was deferred in 5.36 Meeting of SEIAA as the LoI of this proposal had expired. The project Proponent has now got the lease registered in his name. Hence, The Authority based on the recommendation of SEAC, after detailed discussions and deliberations decided to approve EIA/EMP of this proposal and grant EC with the condition that all the lease holders of cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
