**MINUTES OF THE MEETING**

4.11<sup>TH</sup> Meeting of the State Level Environment Impact Assessment Authority was held on 14/05/2019 at 10.00 AM in the Chamber of Chairman, SEIAA under the chairmanship of Sh. R.K. Meena (IAS., Rtd.) to discuss and decide upon the recommendations made by SEAC, Rajasthan in respect of following applications listed below:-

## Following decisions were taken:

**S.No 1:** The Authority found that there is discrepancy in the information submitted in the column of environmental sensitivity and the Map of 10 km radius submitted. Kankriya P F, Norangpura block, Bhudoli Block are although shown in the map they have not been disclosed in the form. The Authority decided to send back the file to SEAC and seek the correct information for the environmental sensitivity column.


**S No 2,3,4:** The Authority accepted the recommendation of SEAC and decided to Grant EC in all these cases. For case mentioned at S.No 2 the first two lines written <sup>extra</sup> in the Agenda were found to be typographical error.


**S.No 5:** The Authority observed that in the column of Environmental sensitivity a forest Block has been named as R F at a distance of 0.8 km which has not named and the map showing 10km radius of the location of the project is also blurred, hence it is difficult to determine whether this block is a part of sanctuary or not. The Authority decided to seek clarification from SEAC.


**S.No 6:** The Authority found that although SEAC has resubmitted the file again but the basic question raised in the earlier meeting that if the project is situated in diversified forest land then the distance of the project from the forest land would be zero still remains unanswered. Moreover the comments made by SEAC and the documents put up before the Authority do not clarify the situation and hence it was decided that file be send back for clarification to SEAC.

**Additional agenda.No 1:** The Authority accepted and approved the comments of SEAC with respect to office memorandum dated 19.2.19 by SEIAA.
