


A large no of files are being submitted for grant of EC in mining cases. Therefore, it is necessary to ensure that the condition of cluster of mines, if applicable, under the relevant law is adhered to. Therefore, while granting the EC following condition should be included in the EC:

"Mining Department will ensure that while executing the mining lease, if the mine falls in a cluster, then lease will be executed after EIA/EMP study as well as grant of revised EC for the cluster as applicable."




