The Authority after detailed discussions and deliberations decided the following:

- 1. Serial No. 1, 4, 5, 7 & 9: In the context of the decision taken earlier in meeting of SEIAA, the project proponents/consultants made the presentations in respect of each and every proposal in detail. The Authority after detailed hearing based on the recommendation of SEAC decided to Grant EC to these proposals.
- 2. Serial No. 2: SEIAA after detailed deliberation decided to refer this proposal back to SEAC for re-examination and send to SEIAA with specific detailed comments after giving project proponent an opportunity to revise the plans with reasons:
 - A. SEIAA was not satisfied with the parking provisions. Provision for 379 ECU has been taken while in the view of SEIAA, looking in to the residential and commercial area, the requirement will be in excess of 1000 ECU. No vehicles of either residence, owners/lease holders of the commercial properties, customers and visitors can be permitted to be parked outside the premises in an unplanned manner.
 - **B.** The assessment made for solid waste generation seems to be grossly under estimated.
