

ITEM NO. 4: DISCUSSIONS

4.1 Compliance of order dated 07.12.2022 passed by Hon'ble NGT in O.A.142 of 2022 in the matter of Jayant Kumar vs. Ministry of Environment, Forests and Climate Change - reg.



The Ministry of Environment, Forest and Climate Change vide F. No. IA3-22/11/2023-IA.III (E-208230) dated 28th April, 2023 has issued an Office Memorandum in view of the compliance of order dated 07.12.2022 passed by Hon'ble NGT in O.A.142 of 2022 in the matter of Jayant Kumar vs. Ministry of Environment, Forests and Climate Change has decided that all valid ECs issued by DEIAA shall be reappraised through SEAC/SEIAA.

It has been directed that all concerned SEACs shall re-appraise the ECs issued by DEIAAs between 15.01.2016 and 13.09.2018 (including both dates) and all fresh ECs in this regard shall be granted only by SEIAAs based on such appraisal.

The exercise shall be completed within a time period of one year from the date of issue of this OM. DEIAAs shall transfer all such files where ECs have been granted to concerned SEIAA within a time period of one month from issue of this OM.

The State Government may assess the existing workload of SEAC(s) and accordingly, send proposals for constitution of additional SEAC for a specified period to deal with such additional workload.

In order to have a uniform approach across the country for such appraisal, SEIAA shall scrutiny and appraise the proposals based on the checklist provided below:

- Completely filled up Form-2 as per Ministry's OM dated 15.12.2021
- 2. Pre-Feasibility Report (PFR) as per MoEF Guidelines dated 30.12.2010
- 3. Valid Mine Lease Document
- 4. Approved Mining Plan from the concerned Authmities
- District Survey Report approved by SEIAA as per Ministry's Notification S.O 3611(E) dated 25.07.2018
- Implementation of "Sustainable Sand Mining Management Guidelines, 2016" and "Enforcement & Monitoring Guidelines for Sand Mining, 2020" in case of sand mining proposals.
- Details of forest land involved in the mine lease area and availability of Stage-I/II Forest Clearance (FC) for diversion
 of forest land for non-forestry purpose.
- Details of Eco Sensitive Zones (ESZ) and Eco Sensitive Areas (ESAs), National Parks, Wildlife Sanctuary, Coastal
 Zone, Water bodies and other ecological sensitive areas within/ in the vicinity of the mine lease area and if so details
 of NOC/ Clearances obtained.
- If any Schedule-I species is present in the study area, proof of submission of Wildlife Conservation Plan to the Forest Department.
- Cluster Certificate from State Mines and Geology Department.
- 11. Compliance of Hon'ble Supreme Court judgment dated 02.08.2017 passed in Common Cause vs Union of India Writ Petition (C) 114 of 2014.
- 12. Proposal of re-grassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora, fauna etc. in compliance to the direction dated 8th January, 2020 of Hon'ble Supreme Court in Writ Petition(s) Civil No. 114/ 2014, Common Cause vs Union of India & Ors.

The provisions of this OM shall be operational subject to the outcome of Civil Appeal No. 3799-3800 of 2019 titled Union of India vs Rajiv Suri filed by Ministry before the Hon'ble Supreme Court of India against the order dated 13th September, 2018 passed in O.A. No. 200 if 2016 (Rajiv Suri Vs UOI) & order dated 2151 December, 2018 passed in R.A. No. 47 of 2018 (UOI Vs Rajiv Suri).

The SEIAA in its 63rd meeting held on 13/6/2023 deliberated upon the Office Memorandum issued by the MoEF&CC, Gol vide F. No. IA3-22/11/2023-IA.III (E-208230) dated 28th April, 2023 in view of the compliance of order dated 07.12.2022 passed by Hon'ble NGT in O.A.142 of 2022 in the matter of Jayant Kumar vs. MoEF&CC. After detailed deliberations it was decided that:

- The SEIAA shall issue directions to all Dy. Commissioners/ Chairman of DEIAAs, SDM/ Member Secretaries (DEIAA) 15.01.2016 and 13.09.2018 to transfer all such files where ECs have been granted.
- The SEIAA Secretariat shall collect & compile all valid ECs issued by DEIAAs, Himachal Pradesh issued between 15.01.2016 and 13.09.2018.
- The SEIAA shall issue directions to all the Project Proponents granted ECs between 15.01.2016 and 13.09.2018 to apply afresh on PARIVESH portal with compliance of conditions of earlier EC issued by the concerned DEIAAs.
- The SEAC shall appraise all the proposals based on the checklist provide vide Office Memorandum issued by the MoEF&CC, Gol vide F. No. IA3-22/11/2023-IA.III (E-208230) dated 28th April, 2023.
- In compliance to Hon'ble NGT orders all the EC granted by DEIAAs in state of HP between 15.01.2016 and 13.09.2018 shall stand withdrawn till further order, MS SEIAA to issue necessary order of direction in this regard.
- 4.2 Regarding sanction & grant of funds under CER for BBNDA, Tehsil Baddi, Distt. Solan, HP.

A request letter from the office of CEO, BBNDA, Baddi, Solan, HP vide No. BBNDA-TCP-BADDI-Misc., Corres-8789 dated 25.05.2023 has been received stating that all the funds collected under CER for any project under BBN area be kept exclusively for the purpose of environmental restoration of this area. These funds shall be used by BBNDA in consultation with the DEST&CC for the activities deemed fit to protect and preserve the environmental degradation. The BBNDA has a full executing arm consisting of qualified engineer who can execute these works in a efficient and cost effective manner.

The SEIAA in its 63rd meeting held on 13/6/2023 deliberated upon the request received from the office of CEO, BBNDA, Baddi, Solan, HP and decided that CER funds collected from Project proponents falling in area of jurisdiction of BBNDA shall be spent through BBNDA in consultation with the DEST&CC for the restoration activities as may be required based on cases to case plan of action basis as deem fit to protect and preserve the environmental degradation in BBNDA.

Furthermore it was also decided that the DEST&CC may allocate funds based on the proposal so submitted by BBNDA for restoration and environmental monitoring in the BBNDA under CER funds collected by SEIAA.

4.3 Inclusion of BNDA NOC for environment clearance projects related to BBN Special Area, Distt. Solan, HP

A request letter from the office of CEO, BBNDA, Baddi, Solan, HP vide No. BBNDA-TCP-BADDI-Misc., Corres-8584 dated 17.03.2023 has been received stating that BBNDA is regulating the overall planning and development as per the provision of HP TCP Act & Rules & the Development Plan 2025 approved and notified for this area. It has been requested that NOC of BBNDA may be taken before consideration and issue of Environment Clearance of a project so that mandate of planned and sustainable physical planning and development could be achieved as per the directions of the State Govt.

The SEIAA in its 63rd meeting held on 13/6/2023 deliberated upon the request received from the office of CEO, BBNDA, Baddi, Solan, HP and decided that in future the NOC of BBNDA shall be pre requisite from all the project falling in area of jurisdiction of BBNDA area before grant of Environment Clearances.

- 4.4 The SEIAA also deliberated on the issue of restoration of hill slope mining sites and river bed mining sites during the meeting and recommended that DEST& CC may take expert opinion of different organizations individuals having expertise in such field such as Mr. Patanjli Jha who is Retd. IRS officer has expertise on regressing, restoration of such sites using e.g. Chrysopogon zizanioides, commonly known as vetiver and khus, which is a perennial bunchgrass of the family Poaceae. Vetiver is most closely related to Sorghum but shares many morphological characteristics with other fragrant grasses, such as lemongrass, citronella, and palmarosa as well
- 4.5. The SEIAA also decided to purchase drone for improving the monitoring of mining operations in the state during site visits and otherwise for the purpose of subcommittee visit for monitoring purposes. The Drones of good quality shall be purchased out of CER cost/ funds deposited with SEIAA.
- 4.6 The SEIAA also decided that MS SEIAA may write to all DCs / District Magistrates to submit the furnish public hearing proceedings with clear cut recommendation failing which the SEIAA shall refer back the PH proceedings to DC concerned for the same. The SEIAA will not consider any such case where recommendations are not clear from District admn. henceforth.
