4. **Case No. 5717/2018** Prior Environmental Clearance for **Limestone, Laterite, Ochre & Reject Stone** Deposit (opencast other than fully mechanized method) in an area of 107.01 Acres, total production capacity 269937 TPA (1,66,660 TPA of limestone + 60,301 TPA of laterite + 2,976 TPA of ochre + 40,000 TPA of reject stone) (Khasra no. 299P, 300P, 309P) at village - Lakhanwah, Tehsil - Rampur Baghelan, Dist. - Satna, MP by Shri Rajiv Pathak, Chayanakyapuri, Semaria Chowk PO & District - Satna, MP – 485001.

- (1) This is a project pertaining to mining of Limestone, Laterite, Ochre & Reject Stone Deposit in MLA of 107.01 Acres. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary/Biosphere Reserve etc. thus it is not attracted by the general conditions and falls under category 'B-1" by virtue of its location and mining lease area. There is no forest boundary in less than 250 m distance from the ML area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environmental clearance for the project. It was submitted that the mine lease has been executed for 50 years period in accordance with the MM (D&R) Amendment Act 2015 with total production capacity of 269937 TPA of limestone, laterite, ochre & reject stone.
- (2) The proposed area is revenue land and prospecting license was sanctioned by the State Govt. of MP, Bhopal vide letter no. F-3-228/90/12/2 dated 18.04.2007 over the area of 107.01 Acre. The prospecting license deed was executed on 26.08.2008 for one year period upto 25.08.2009. The State Govt. has granted the mining lease over the 107.01 Acres area previously held under PL for mineral limestone, laterite & ochre vide letter no. F-3-19/2010/12/1 dated

17.10.2014. The Mining Lease has been executed for 50 years period in accordance with the MM (D&R) Amendment Act 2015. The lease deed was registered on 03.11.2015 for 50 years period. This is a case of new mining lease. The Mining Plan has been approved by IBM, Jabalpur Vide Letter No. - MP/Satna/Limstone/MPLN/G-01/15-16/4094 Jabalpur dated 28.07.2015.

- (3) SEAC in its 438<sup>th</sup> meeting dtd 02.06.2020 has recommended the case with 33 special conditions for issuance of EC.
- (4) It was noted that as per DFO L.No. 1160 Majhgawan, dtd. 10.02.2016, the National Park/Sanctuary/Eco Sensitive Zone is not located within 10 Km. radius from the mining site. Hence, the General Conditions are not attracted. There is no forest boundary in less than 250 m distance from the ML area.
- (5) PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (6) It was noted that the water requirement is 21.0 KLD (4.8 KLD for Mine Operation & Dust Suppression + 11.7 KLD for Green Belt & afforestation + 4.5 KLD for Drinking & Domestic Purpose). Drinking water shall be taken from ground water source situated in ML area and mine operation & dust suppression and green belt & afforestation shall be met from mine sump.
- (7) The proposed plantation programme was examined and it was found that total 43500 saplings shall be covered under plantation program during the life of mine.
- (8) It was also noted that the Public Hearing was carried out on 12.06.2019 at Mine Parisar Village - Lakhanwah, Tehsil - Rampur Baghelan, Dist. - Satna (MP) under Chairmanship of Additional Collector, Satna.

**After detailed discussions and perusal of recommendations of 438<sup>th</sup> SEAC meeting dtd 02.06.2020, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-**

- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. Lease agreement shall be carried out before execution of mining operation.
- III. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- IV. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three rows plantation shall be carried out in the greenbelt area in current year with proper watering arrangement.
- V. PP will plant 3 years old 43500 saplings of suitable tree species Neem, Gulmohar, Mango, Bargad, Pipal, Dalbergia sissoo, Mahua, Karanj, Drumstick etc. will be planted by PP in consultation with DM at identified revenue land of the district. PP shall also explore and identify the chunk of

land in the area from revenue record to carry out plantation programme as proposed.

- VI. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table, approval of the Central Ground Water Board shall be obtained.
- VII. The overburden and waste will be stacked for five years and simultaneously backfilled in the mined out area where plantation will be raised on it.
- VIII. No dump shall be stacked outside the lease area.
- IX. Regular water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MPPCB. Regular air and noise quality monitoring shall also be carried out at regular interval from authorized laboratory in consultation with Regional Officer, MPPCB.
- X. PP shall ensure the generation of employment opportunities nearby Village on priority basis.
- XI. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- XII. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.

*”.....The case was presented by the PP and their consultant, during presentation as per Google image based on coordinates provided by PP, it was observed that this lease is beyond 300 meter radius of affected area declared by NGT as per Collector.s office letter no 1737 dated 04/10/2018 wherein in point number 06 it is clearly mentioned that this lease area is beyond 300 meters radius of NGT affected area and has given its approval. During presentation it was also submitted by PP that the national highway is approx. 1000 meters away from the lease which is in accordance with MMR, 1996. Mining shall be carried-out by Opencast Semi Mechanized Method.*

Non withdrawal of ground water for the project reflects positive impact on ground water regime of the area.

- (3) PP has also submitted Hydrogeological study report of the project area and also submitted that he is having captive limestone mines adjoining the cement plant near villages Bhatkotri and Dhanora in Nimbahera, Chittorgarh, Rajasthan. Ministry of Environment and Forest & Climate Change, New Delhi is emphasizing all industrial units to reduce ground water withdrawal and to utilize surface water resources as far as possible. MOEF vide EC order No. J-11011/298/2012/IA-II(I) dated 4-10-2019 at Specific Condition no. 1 of his Integrated Cement Plant in Chittorgarh Rajasthan has prescribed to utilize surface water for integrated cement plant and to control withdrawal of ground water .

- (4) The case was discussed in detail and recorded that :-

i. As per the hydro-geological study report the average annual rainfall in the region is 826 mm. The active storage capacity of the pond (abandoned quarry) is 110632.5 cum. Catchment of rainwater nallah is 496.4 ha which contributes flow to the pond (abandoned quarry).

- Average Yield from this catchment is 1.23 MCM (Million Cubic meter).
- The pond (abandoned quarry) gets direct rainfall volume of 0.012 MCM. from 1.4 ha of its surface area.
- Total water entering the pond (abandoned quarry): 1.242 MCM
- Evaporation loss in the pond (abandoned quarry) : 0.008 MCM
- The total annual industrial demand @ 245 cum/day (10 cum/day for domestic and 235 cum/day for industrial working purpose).

ii. During the study it was assessed that 235 cum/day water from the pond (abandoned quarry) can be withdrawn for industrial purpose for 300 plant working days.

  - The domestic demand 10 cum /day (3650 cum/year) will be met from groundwater.
  - If water from the pond (abandoned quarry) is utilized, it will reduce 235 cum/day (70500 cum /year) withdrawal from groundwater resources. An additional volume of groundwater 84804 cum/year will be from pond (abandoned quarry) water for recharge. Total increase in ground water resources to the surrounding area will be (70500+84804= 155304 cum/year) .
- iii. Total 12 nos Rain water harvesting structure constructed in the plant premise which recharge to the tune of 103249 cum/Year (0.103249 MCM).
- iv. Total increase in ground water resources 70500+84804 + 103249 = 258533 cum/year from all above mentioned measures.

After detail discussion and deliberation**, it is decided to accept the request of PP and accordingly specific condition No. A-3 mentioned as ***“PP should develop and conserve the existing water body within the plant area with proper fencing, landscaping with plantation. Fountains shall be installed within the water body for aeration. No drawal of water shall be permitted from this water body for domestic and industrial purpose”*** in EC letter No. 75/SEIAA/ 2017 dated 19.06.17 is hereby a amended as below :

After detailed discussions and perusal of recommendations of 414<sup>th</sup> SEAC meeting dated 6.1.2020, it was decided to ask pp to submit clarification from Revenue/Tehsildar that mining activities can be allowed/carried out on above said lease land as per khasra/revenue record.*

*PP has not submitted above desired information hence it has been decided to delist the case on the condition that if PP intends to present the case in SEIAA, it will then be relisted for appraisal. Copy to PP and all concerned.*

In response to query in 594<sup>th</sup> SEIAA meeting dated 6/1/2020, Patwari has clarified vide letter dated 7.05.20 that applied mining lease area is not suitable for agricultural work being plateau area hence murrum mining can be carried in proposed mining lease area. Since PP has submitted the required information vide letter dated 8.07.20 with a request to relist the case hence case is relisted and considered for EC appraisal.

PP in SEIAA, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-

- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. PP shall not start mining activity before execution of lease agreement.
- III. The depth of the pit shall be as per the Approved Mining Plan.
- IV. The entire area shall be fenced and three rows of plantation should be done on the periphery of the boundary.
- V. PP shall ensure the proper water supply arrangements for dust suppression, regular sprinkling, plantation and drinking purposes especially in summer season.
- VI. Total 1000 saplings of suitable tree species i.e. Neem, Pipal, Jamun, Mango, Gulmohar etc. shall be planted by PP in first three years under plantation programme in consultation with DM at identified revenue land of the district. PP shall also explore and identify the chunk of land in the area from revenue record to carry out plantation programme as proposed.
- VII. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- VIII. PP must ensure implementation of the following activities with separate budget provision of total Rs 1.35 under CER:

**a) Construction of cow shed.**

**PP shall give preference to develop/provide infrastructural facilities in schools or aanganwadies of above villages. The modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Gram Panchayat.**

- i. PP should ensure to submit half yearly compliance report, Plantation and CER activity report along with photographs of all activities in MP-SEIAA. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC, GoI, Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per OM No. 930/SEIAA/2019 dated 30.05.2019 issued by MPSEIAA..
