PP has submitted the response of above quarries same date vide letter dated 11.07.2019, which was placed before the committee and the same found satisfactory. The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A':

PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail. **After detailed discussions and perusal of recommendations of 384th SEAC dated 11.07.2019, presentation made by the PP in SEIAA, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-**

- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three row plantations shall be carried out in the greenbelt area in current year with proper watering arrangement.

- 1. The case was discussed in 523rd SEIAA meeting dtd 15.02.19 and recorded that:-**

This case was recommended in 340th SEAC meeting dated 30.01.19 and it was recorded that:

"The P.P has on 25.7.2017 submitted on line the application for Forest clearance for diversion of 54.87 ha vide proposal N.O FP/MP/IRRIG/20767/2016. The case for stage -1 clearance for diversion of 54.87ha Forest land for construction of project is pending at State Government level."

Since forest land acquired for the proposed project is 54.87 ha and PP has applied online application for forest clearance for diversion of 54.87 ha vide proposal No. FP/MP/IRRIG/20767/2016 dated 25.07.2017 for Stage-I Forest Clearance of proposed irrigation project. Hence after deliberation, it is decided to submit first stage forest clearance by PP in SEIAA for considering prior EC.

In response to above vide letter dtd 06.08.19 received in SEIAA office on 06.08.19, PP has submitted the copy of first stage of forest clearance letter issued by MoEF & CC, GoI vide letter No. F.No. 8-05/2019-FC MoEF & CC, GoI dated 10.07.19.

- I. Hiran medium Irrigation Tank project has been conceived by Water Resource Department, Madhya Pradesh across river Hiran, the biggest right bank tributary of the Narmada, in Block and Tehsil Kundam, District

Jabalpur, with a view to impound 31.69 MCM of monsoon discharge of the river and out of it harness 27.34 MCM for providing irrigation facility at 100% irrigation intensity during Rabi to 8125 ha command covering 15 and 39 villages under district Jabalpur and Katni respectively.

- II. The river drains a gross catchment of 91.67 sq.km at the project site, which includes 1.76 sq.km of intercepted catchment of a minor scheme. Thus, net or free draining catchment is 89.91sq.km.
- III. The Project is envisaged to have a live storage capacity of 31.25 MCM.
- IV. 1.06 MCM has been reserved for drinking purpose and 3.00 MCM water is kept reserved for Environmental releases.
- V. Project Features: The project shall encompass the following components: -
 - Hiran dam comprising of 810m long with maximum height of 39m zonal earthen dam;
 - 110 m long weir;
 - One RCC barrel type irrigation sluice (1.5m X 2.0m);
 - D-shaped 1.65km long tunnel;
 - 19.09 km long pressurized main canal (MS pipe);
 - 4 Number distributaries.
- VI. The project pertains to Item No. 1(c) category 'B' of the EIA Notification 2006 schedule and in terms of Notification dated, 25th June, 2014, as the CCA of the project is less than 10000 ha.
- VII. The project has a command area of 8125 ha, therefore as per EIA notification of September 2006 and a recent amendment (August 14, 2018), it is a Category B2 project (Medium irrigation project having CCA > 2000 ha and < 10000 ha)". And Being a B2 Category project, it does not require an EIA report and is exempt from Public Hearing; it require submission of EMP only However, Scoping Clearance of the project was taken as Category B1 (prior to August 2018 amendment).
- VIII. However, Public Hearing for this project has already been conducted prior to the date of issue of the notification dated 14.8.2018. Public Hearing was conducted by the Madhya Pradesh Pollution Control Board on 30th June, 2018 at school in village Badua, tehsil Kundam. The main issues were about adequate compensation to be granted and employment should be given to the residents and farmers of project affected villages.
- IX. There is no wildlife sanctuary, National park (DFO letter dtd. 07.12.15) or interstate boundaries (PWD letter dtd. 09.12.15) within 10 km of the project area hence general conditions are not attracted.
- X. The case was discussed in SEAC meetings 280th SEAC meeting dtd. 31.08.2016, and decided to issue TOR. ToR issued by SEAC vide letter Vide letter no.1522/PS-MS/MPPCB/SEAC-1/TOR (280) / 2016, Dated 15.10.2016 for CCA 8125 ha. PP has submitted the EIA report vide letter dated 08.10.2018 which was forwarded to SEAC vide letter no. 1672 dated 12.11.2018.

- XI. After submission of EIA report the case was considered in 336th SEAC meeting dated 04.12.2018 and 340th dtd. 30.01.19 is recommended for grant of prior EC subject to special conditions.
- XII. For execution of the project 220 ha land, falling in Block and Tehsil Kundam, District Jabalpur, shall be required of which the apportionment between State, Private and forestland shall be 50.67 ha, 111.72 ha and 54.87 ha respectively
- XIII. There are four project affected villages which are being impacted due to acquisition of private land. There shall be 166 affected families of which none shall be displaced families. The land acquisition shall be carried out as per RFCTLARRA 2013. The State Government of Madhya Pradesh vide S. N.22(A)349-44/17/MPS/31/657, dated 6.4.2018 has sanctioned a special package for submergence affected area in case of Hiran Medium Irrigation Project. As per paragraph A(i) G.O. dated 6.4.2018, the purchase/ acquiring cost per hectare of land shall be paid Lump sum @ Rs 10 lakh/ha.
- XIV. Compensatory afforestation in 109.75ha revenue land transferred to Forest Department which included 54.87 ha land for raising compensatory Afforestation. Payment of Net Present Value (NPV) of Forest land (54.87ha) for compensating the loss to ecology of the area. A provision of Rs. 623 lakhs made under Compensatory Afforestation Plan .
- XV. Generation of debris (9.41 lakh cum) from excavation of which 3.91 lakh cum muck shall be consumed and balance 5.52 lakh cum to be disposed at designated site. The balance 5.52 lakh cum shall be disposed in backfilling of voids of borrow area. Top soil (55950 cum) shall be stripped and stacked/preserved to be used in plantation and turfing areas. Provision of Rs. 11 lakh made under Muck Management Plan.
- XVI. For control of air pollution PP has proposed as follows:-
- Dust mask will also be provided to the workers.
 - Proper regular maintenance of machineries will be done.
 - Speed of the vehicles will be kept within the prescribed limits.
 - Trucks/dumpers will not be overloaded.
 - Copious sprinkling of water at the work site and haul roads shall be carried out and hooded trucks shall be used.
 - Wet drilling shall be adopted.
 - Periodical monitoring of ambient air quality.
- Provision of Rs. 7.20 lakh made under Management Plan for Control of Water, Air & Noise Pollution. For air quality monitoring, provision of Rs 6.0 lakh made under Environment Monitoring Plan (EMP)
- XVII. Solid waste generated from temporary and permanent colonies in construction as well as operation phase requires special management to dispose of as warranted under the new Solid Wastes Management Rules, 2016. The waste oil and oil contaminated wastes are to be sold off to

approved waste oil recyclers. For solid waste management, a provision of Rs 25.0 lakh made under Sanitation and Solid Waste Management Plan.

- XVIII. The sewage waste shall be disposed after treatment through STP. The effluent to be discharged should conform to the Standard opted vide GSR 1265(E), dated 13.10.2017. Provision of Rs. 4.32 lakh has been made for water quality monitoring under Environment Monitoring Plan (EMP).
- XIX. Fragmentation of habitat Land degradation in reservoir fringe due to felling of trees. Increase in temporary stress levels of wildlife during construction phase due to noise, human interference and reduction in present habitat. Threat due to poaching might increase. A provision of Rs 25 lakhs made under Wildlife Management and Conservation Plan.
- XX. Loss of trees to be felled in clearing the reservoir area. Green belt development around reservoir rim in about 8 ha. A provision of Rs 14.72 lakhs made for plantation along reservoir periphery.
- XXI. Fishery development to help in the increasing employment potential and to produce protein rich food. A provision of Rs 80 lakhs made under Fisheries Management Plan.
- XXII. Improvement in living standards of inhabitants in the project area and development of infrastructure in the area by implementing local area development plan.
- XXIII. The Catchment Area Treatment (CAT) plans with objective to address issues such as prevention of gully erosion, enhancing the forest cover for increasing soil holding capacity and arresting total sediment flow in the reservoir and flowing waters. 785 ha have been proposed to be treated under the CAT plan. This area includes 470 ha area of catchment which shall be treated by biological/ engineering measures and 315 ha area under private land treatment within the free draining catchment. A provision of Rs. 505 lakhs made under Catchment Area Treatment.
- XXIV. Disaster resulting from dam break/failure has been considered and dam break analysis by using BOSS DAMBRK model has been conducted. Evolution of disaster management plan dwells on various aspects such as provision of evacuation paths, setting up of alarms and warning systems, establishing communicating system besides delineating an Emergency Response Organization with an Effective Response System.
- XXV. Total cost of the project is Rs. 225.99 Crore.
- XXVI. **Benefit of the project:** Additional irrigation potential shall be created in area (8125 ha). Better living Standards for farmers of command area. Employment opportunities / fisheries. Improvement in environment through implementation of CAT, Compensatory Afforestation, Green belt Development and different other plans. Command Area Development. Better opportunities for cattle rearing. Increase in groundwater level.

The submissions made by the PP were found to be satisfactory and acceptable hence it is decided to accept the recommendations of 340th SEAC meeting dtd. 30.01.19 with special conditions and accord Prior Environmental Clearance for the proposed Hiran

1. The inputs given by the participants during Public hearing should be properly redressed. All the promises and assurances made during the public hearing shall be fulfilled completely by the water resources department GoMP. The implementation of R & R Plan to be closely monitored to ensure that all project affected families (PAFs) get adequate & timely compensation.
2. Besides the agricultural land, the rehabilitation of public buildings, infrastructures, monument etc. falling in the submergence area should also be included in the rehabilitation plan.
3. A monitoring Committee for R & R shall be constituted which must include representatives of project affected persons including form SC/ST community and at least a woman beneficiary.
4. A grievances redress mechanism is to be devised by WRD and put in place so that aggrieved PAFs and other stakeholders may approach the Authority easily for resolution of any dispute/conflict.
5. The implementation of Local Area Development Plan (LADP) to be closely monitored.
6. This being a seasonal stream/ river, a minimum environmental flow of 30 % in monsoon season should be released for downstream users.
7. Proposed Compensatory Afforestation programme shall be taken-up in consultation with State Forest Department. The allocated grant for this purpose shall be fully utilized and not to be diverted for any other purpose. For compensatory afforestation programme, preference shall be given to native species.
8. Proposed Bio-diversity Conservation & Management Plan in EMP report should be implemented with State Forest Department. The allocated budget for this purpose shall be fully utilized and not to be diverted for any other purpose.
9. The catchment Area Treatment (CAT) Plan as proposed in EMP report shall be strictly implemented in consultation with Madhya Pradesh State Forest Department. Major works shall be completed before impounding of reservoir. The financial allocation for CAT Plan implementation shall be fully utilized and not to be diverted for any other purpose. Catchment Area Treatment Plan as has been proposed should be completed in five years.
10. To enhance the natural environmental quality & aesthetics of project site, greenbelt, as proposed in the EMP Report shall be undertaken in project area. Allocated grant for this purpose shall be fully utilised and not to be diverted for any other purpose.
11. Fishery conservation & management plan as proposed shall be implemented in consultation with the Fisheries Department, Government of Madhya Pradesh..

Allocated grant for this purpose shall be fully utilised and not to be diverted for any other purpose.

12. Occurrence of stagnant pools/slow moving water channels during construction and operation of the project may provide breeding source for vector mosquitoes and other parasites. The river should be properly channelized so that no small pools and puddles are allowed to be formed. Even after taking precaution, due to unforeseen situations, breeding of mosquito and resultant malaria or mosquito borne diseases can increase. If such a situation arises, it will be the responsibility of project authorities to take all steps i.e. residual insecticidal spray in all the project area and surrounding 3 km. Area keeping the flight range of mosquitoes in consideration. Also medical assistance to be provided to the affected people at the cost of the developer and appropriate health benefits may be initiated with the help of State Health Department.
13. If the water of reservoir is used for drinking water supply, it should be done after conventional treatment.
14. Regular monitoring of water quality (Surface and Ground) including heavy metals shall be undertaken in the project area and around the project area to ascertain the change, if any, in the water quality due to leaching of contaminants, if any, from the increased use of chemical fertilizers and pesticides.
15. Conjunctive use of surface water shall be planned to check water logging as well as to increase productivity.
16. Consolidation and compaction of the generated muck should be carried-out in the muck dumping site. The entire muck should be utilized for service road and inspection path, formation of embankment, filling trenches, land levelling and construction of CD works etc. The muck disposal sites shall be reclaimed /restored with vegetation once the capacity is utilized.
17. The periodical soil health shall be verified in command area during operation phase to ensure the maintenance of soil fertility.
18. PP should ensure to compliance the condition laid down the forest clearance approval issued by MoEF & CC,Gol.
19. PP should ensure to submit half yearly compliance report and CSR activity report with photographs of plantation in MP-SEIAA. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC,Gol,Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per OM No. 930/SEIAA/2019 dated 30.05.2019 issued by MPSEIAA.
