The SEAC recommended the case application for consideration of grant of environmental clearance by the SEIAA, subject to fulfillment of conditions annexed at Annexure-I. The case may be listed before SEIAA for EC after prior compliance to the following observations:

- The project proponent shall submit details of Area and Khasra Numbers where the plantation will be carried out and list of tree species proposed for plantation in the area.
- The project proponent shall submit latest NOC from Panchayat.
- The project proponent shall submit a report w.r.t. impact on hydrology due to mining activities

- The project proponent shall submit KML (Keyhole Markup Language) file of mining lease area.

The proposed project is manufacturing of lead battery plates and assembling of Lead Acid battery. As proposed the waste water generated from the process is being treated through Effluent treatment plant and waste water generated from domestic side is also treated by STP. The existing water requirement of the unit is 215 KLD and after expansion it will be 455 KLD. The existing power requirement of the unit is 3850 KW and after expansion it will be 11983 KW.

The Proposed project has submitted report on 24.09.2018 and online on dated 15.09.2018 The project proponent has submitted form-1, pre-feasibility report, key plan, location plan, layout plan, flow chart of ETP, STP, Notification regarding exemption from Public hearing as the Industry is situated in Notified area of Himachal Pradesh, single window clearance letter dated 26.04.2018, project report for expansion proposal, process flow chart of lead acid battery, memorandum of understanding etc.

The committee after deliberating on the information submitted by the project proponent and considering the facts placed before the Committee it was observed that Environment Clearance is not applicable in the instant case. The project proponent also submitted an undertaking to the fact that the production of batteries process does not involve use of any Furnace like Induction, Arc & Caupla Furnace.

The case was appraised by the SEAC in 60th Meeting. The SEAC observed that as per provisions under Col. 5 of schedule of EIA notification ref. SO 3067(E) 1/ 12/2009 (ii) "In case of secondary metallurgical processing units, those projects involving operation of furnaces only such as induction, and electric arc furnace, submerged arc furnace, and cupola with capacity more than 30000 TPA would require environmental clearance".

Keeping in view the fact that the process does not involve use of any Furnace like Induction, Electric Arc, submerged arc furnace & Caupla Furnace, the SEAC recommended that SEIAA may inform the project proponent accordingly.

As an alternate to the cutlery made from harmful material the project proponent shall donate/provide one pattal-duna making machine & provide trainings to the local Mahila Mandal/ Self Help Group or identify, adopt existing traditional dona/pattal makers in the district for forming Self Help Group & shall provide a machine. The PP shall also impart trainings for operating the machine as part CER activity in consultation with DEST.
- The project proponent shall plant the Shorea robusta / maljhum species along the road from mining site to crusher site and other proposed area for plantation.

The proposed project is manual extraction of Sand, Stone & Bajri. The mining lease area is Government land which is part of Yamuna river.

The proposal was appraised in 59th Meeting of SEAC. The SEAC recommended the case application for consideration of grant of environmental clearance by the SEIAA, subject to fulfillment of conditions annexed at Annexure-I and a special condition that the project proponent shall obtain Forest Clearance if applicable, prior to starting mining activities. The case may be listed before SEIAA for EC after prior compliance to the following observations:

- The project proponent shall revise CSR costs for Rs. 1.00 lakhs (Capital Cost) & Rs. 0.10 Lakhs (Recurring Cost) for construction of community hall along with toilets in the Panchayat.
- The project proponent shall furnish a map depicting the boundary pillars of mining area.

- The project proponent shall submit details of Area and Khasra Numbers where the plantation will be carried out and will plant Poplar & *Maljhum* tree species in the area.
- The project proponent shall submit KML (Keyhole Markup Language) file of mining lease area.

The project proponent submitted compliance on dated 18/8/2018 to SEIAA of all the observations. Therefore the case is listed before the SEIAA for further necessary action.

The SEIAA Secretariat has also received one representation from Mr. Rana Randeep Singh on dated 10/8/2018. The request letter to examine the fact has also been forwarded to the concerned Authorities for comments. The comments are not received yet.

The matter was listed in the 37th meeting of SEIAA and it was decided that the case may be listed in next meeting after observation of SEIAA i.e. Forest Department – Wildlife wing may be reminded to give the reply as requested from this department and also the representations was also requested to supply the copy of notification dated 17.9.2015 and 15.12.2015 as indicated in the representation for necessary action in the matter. Notification dated 17.9.2015 is placed on record and reminder were issued accordingly.

The case was again listed before the SEIAA in its 38th Meeting. After deliberating on the recommendations of SEAC the Authority approved the grant extension / renewal of environmental clearance valid for the period of 5 years in favour of the Unit stipulating the conditions recommended by the SEAC with the following additional conditions:

ITEM NO. 3

The SEAC in 60th Meeting during the appraisal of the mining project proposals observed that while examining mining plans approved by the Mining Department contains many technical ambiguities and misleading facts. Based upon these mining plans the consultants are preparing pre-feasibility reports. Therefore, the Mining Department may be appraised about these mining plans mentioning with technical ambiguities and requesting not to approve such mining plans in future.

The issue was listed before the SEIAA in its 38th Meeting. After deliberating on the issue Authority recommended that the SEAC may refer such cases to Mining Department for corrections prior to consideration of cases for Environment Clearance.

The EC was issued vide EC letter No. HPSEIAA/F (13) M/s Shree Jee Land Developers & Promoters (P) Ltd. 2008/1839-1847 dated 25.10.2008 for construction of Commercial Complex at Baddi, Solan, H.P.

vii) M/s Amarnath Aggarwal Colonisers (P), Ltd, for Amarawati Hill City, Sabathu Road, Solan.

The EC was issued vide EC letter No. HPSEIAA/F (15) vii) M/s Amarnath Aggarwal Colonisers (P) 2008/76 dated 2.4.2009.

viii) M/s Shakun Infrastructure Development Ltd, Baddi, Nalagarh, Solan.

The EC was issued vide EC letter HPSEIAA/F(12)/Shakun Infrastructure Development Ltd./2008-1848 dated 25.10.2008.

The Chairman, SEIAA condoned the delay in filing of application for renewal of Environment Clearance.

The SEIAA considered the applications for date of extension of validity in accordance with Para 9 of EIA Notification 2006 and its subsequent amendments and approved that the Validity of Environmental Clearance may be extended for another period of 3 years for case No. i, ii & iv to viii. However, in case of sr. No. iii i.e. M/s Delanco Realotors (P) Ltd. it was decided that the clarification from the TCP Department may be obtained whether the area is in Kasauli Planning Area or Deemed Planning Area or outside it.

ITEM NO. 5

3.1 Sh. Anil Sharma, S/o Sh. Natha Ram, Village-Batamandi, PO Batamandi, Tehsil Paonta Sahib, Sirmaur, HP

The HPSEIAA secretariat vide letter No. 3591 dated 3/10/2018 has received a letter from DFO, Paonta Forest Division, correcting the earlier information that the mining lease of Sh. Anil Sharma, S/o Sh. Natha Ram R/o Village Kunja Matralio, Tehsil Paonta Sahib is falling within 5 kms of the National Park, Simbalwada.

An attention for necessary action on following points has also been informed:

- i. Mining lease allotted to Sh. Anil Sharma, S/o Sh. Natha Ram, Village-Batamandi, PO Batamandi, Tehsil Paonta Sahib, Sirmaur over area measuring 3-52-81 ha. Camping Khasra No. 953/2/2 falling in Mauza/Mohal/Upsampads Batamandi, Tehsil Paonta Sahib, Sirmaur dated 21/9/16 via letter No. 6965.
- ii. Reply submitted to Hon'ble National Green Tribunal New Delhi in Appeal No. 57 of 2016 in the matter of Sh. Rana Randeep Singh Vs. Union of India and others.
- iii. Environment Impact Assessment Notification dated Sept 16, 2006 highlighting treatment of Category B areas to Category A areas if located in whole or in part within 10 km from the boundary of protected area.
- iv. Govt. of India MoEF memorandum dated December 2, 2009 obtainment of prior clearance from Standing Committee of the National Board for wildlife in case of land situated within 10 km of a National Park.

After deliberating on the orders of NGT and the letter from the forest department it is evident that the mining lease site is falling within the 5 kms. of the Protected Areas, therefore, needs necessary clearance from the National Board for Wildlife as the case may be.

And it was also decided that the PP may also served show cause notice as why his Environment Clearance should not be withdrawn in view of the wrong information on Form-I filed for seeking Environment Clearance.

The SEIAA decided that keeping in view the revised information from DFO vide letter No. 3591 dated 3/10/2018 w.r.t. distance of mining sites for protected area to amend the terms and conditions of Environment Clearance by imposing additional terms and condition as under:

- The project proponent shall obtain approval from National Board for Wildlife.
- The project proponent shall prepare site specific conservation plan/ Wildlife Management plan approved by the Chief Wildlife Warden. The recommendations of the approved Site Specific Conservation Plan/ Wildlife Management Plan shall be implemented in consultation with the State Forest Department. The implementation report shall be furnished along with the six-monthly compliance report and
- The project proponent to be served with show cause notice as to why the Environment Clearance should not be withdrawn in view of the wrong information on Form-I.

Any Other Items

ITEM NO. 6:

6.1 Sh. Sunil Kumar Sood, M/s Homeland Exotica-Mixed Land use Construction Project at Village Kiyari & Rirka, Tehsil & Distt. Shimla, HP.

The Environmental Clearance was granted by the HPSEIAA in favour of Sh. Sunil Kumar Sood, M/s Homeland Exotica, 143, Sector-7, Panchkula, Haryana for the Mixd land use construction

project at Village Kiyari & Rirka, Tehsil & Distt. Shimla, HP. vide letter No. HPSEIAA/2015/360/02 dated 1/4/2016.

A request letter of Sh. Sunil Kumar Sood dated 20/4/2016 has requested to change the project name to Sh. Sunil Kumar Sood M/s Nirvana Woods in place of project name Sh. Sunil Kumar Sood, M/s Homeland Exotica.

The request of PP (Project Proponent) was placed before SEIAA in 27th Meeting & the change of name was approved by the authority. Before issuance the change of name letter the PP was asked to submit the desired documents like Essentiality Certificate etc. The project proponent submitted the Essentiality Certificate issued by the TCP dated 16-3-2017 vide File No. TCP-F(4)/2017 in the name of Nirvana Woods.

After deliberating on the information submitted by the PP, the SEIAA decided that keeping in view the fact that the revenue papers w.r.t. sale deed, transfer of the EC certificate are not available and needs to be examined before change of name in EC letter is considered. The PP also need to submit authorization letter as sole proprietorship decision in the matter. The SEIAA decided that:

- i) The project proponent may submit a copy of sale deed papers of Sh. Sunil Kumar Sood, M/s Homeland Exotica in the name of M/s Nirvana Woods whereby land in reference has been purchased/ transferred by/to Nirvana Wood with all rights.
- ii) The proprietor of M/s Nirvana Woods shall furnish certificate or Authority of Sole proprietorship of M/s Nirvana Wood.

ITEM NO. 7

The matter w.r.t. validity of EC (Environment Clearance) was discussed and it was decided that the validity of EC shall be mentioned in accordance with para 9 (i) of EIA notification 2006 and in case of mining projects the validity of EC shall be valid initially for a period of 7 years extended maximum upto 30 years or the validity period of mining lease period as the case may be (in case mining lease is valid for less than seven years) the validity will be upto the valid mining period.
