INTRODUCTION

The proponent made online application with final EIA report vide proposal no. SIA/WB/MIS/49324/2017 dated 02.01.2020 along with copies of EIA/EMP seeking environmental clearance under the provisions of the EIA Notification, 2006 for the above mentioned project. The project proponent has submitted application in SL.No. 8(b) Townships and Area Development projects, under Category "B2" of EIA Notification 2006.

The project proponent obtained ToR vide memo no. 483-2N-57/2018(E) dated 30.05.2019.

The proposal was placed in the 33rd meeting of SEIAA held on 09.09.2021. The project proponent was directed to submit the revised Remediation Plan & Natural Community Rehabilitation and Augmentation plan.

The project proponent submitted reply through letter vide Memo No. NTCD-II/AKN/245 dated 27.09.2021.

The withdrawal process of application SIA/WB/NCP/22733/2018 (duplicate application for ToR against same project) completed online.

DELIBERATION IN SEIAA

SEIAA considered the submissions made by the project proponent vide their letter memo No. NTCD-II/AKN/245 dated 27.09.2021 and accepted the same.

RECOMMENDATIONS OF SEIAA

The application for EC is approved based on the NKDA Building PIN No. 0070030020161230 dated 30.12.2016.

CONCLUSION

Approved for EC.

INTRODUCTION

The proponent made online application vide proposal no. SIA/WB/MIS/168212/2020 on 16.08.2020 seeking environment clearance under the provisions of the EIA Notification, 2006 for the above mentioned project. The proposed project activity is listed at SL.No. 8(a) Building and Construction projects, under Category "B2" of EIA Notification 2006.

The proposal was placed in the 30th meeting of SEIAA held on 13.08.2021. SEIAA recommended the following :-

- 1) The project proponent was requested to reconcile the discrepancies and submit a fresh drawing and calculation sheet tallying with the KMC sanction plan. The project proponent was further requested to submit a Auto-CAD soft copy (saved in 2010 version) of the land use plan.
- 2) The short fall of the required tree plantation area within the project site is to be compensated by identifying suitable adjacent area within 5 km. radius of the project or within the East Kolkata Wetland area.
- 3) The area outside the project so identified as mentioned in item no. 2 above is required to be taken either on ownership basis or on a long term lease of at least 30 years by executing a Registered Lease Deed and not merely a Notarial Certificate.

The project proponent submitted reply vide their letter No. Nil dated Nil submitted on 29.09.2021.

DELIBERATION IN SEIAA

SEIAA considered the reply vide letter No. Nil dated Nil submitted on 29.09.2021 wherein they stated that they have purchased a land within EKW area through a Deed of Conveyance vide Registration No. 160805424 of 2021. They have further submitted a Deed of Declaration vide Registration No. 190309436 of 2021 wherein they have declared to undertake exclusive tree plantation in an area of 24.75 decimal in 2 plots bearing LR No. 1172(P) and 1174(P), Mouza – Garan, JL No. 93, for a period of 30 years commencing from 20.09.2021 to 19.09.2051.

RECOMMENDATIONS OF SEIAA

The application for EC is approved based on the KMC Building Permit No. 2019010012 dated 02.05.2019.

CONCLUSION

Approved for EC.

INTRODUCTION

The proponent made online application vide proposal no. SIA/WB/MIS/180865/2020 dated 28.10.2020 seeking environment clearance under the provisions of the EIA Notification, 2006 for the above mentioned project. The proposed project activity is listed at SL. No. 8(a) Building and Construction projects under Category "B2" of EIA Notification 2006. M/s. P. S. Vinayak Complex LLP had obtained EC for the project "THE 101" vide No. 431/EN/T-II-1/013/2017 dated 22.02.2018 with proposal no. SIA/WB/MIS/63430/2017. The project name changed from 'The 101' to 'The 102' in the said EC based on the application made by the project proponent on 01.08.2018. The project proponent applied for EC vide their application No. SIA/WB/MIS/50926/2016 of the same project in the name of 'Moments 101' which was rejected. The project proponent made another application No. SIA/WB/MIS/34385/2016 under 'expansion' category on 08.04.2019.

Thereafter the project proponent informed SEIAA of dividing the whole project into 2 separate projects viz. 'The 102' and 'CGEWHO' vide their letter No. Nil dated 23.09.2019. They also requested to bifurcate the original EC into 2 separate ECs with a change of built up area. Since there was no scope to bifurcate the EC, the project proponent was advised to apply for EC for the 2 separate projects.

The project proponent applied online for EC on 28.10.2020. After appraisal of the project by SEAC, SEIAA made a site visit on 13.04.2021. During the site visit it was observed that the environmental parameters were compromised especially the tree plantation area in the project. It was further observed that in the event of splitting of the project would affect the environmental parameters adversely. The project proponent was informed about the observations of the site visit vide letter No. 820/EN/T-II-1/063/2020 dated 03.05.2021. The project proponent submitted reply through letter vide Ref. No. THE 102/004/2021-22 dated 10.05.2021. From the documents submitted by the project proponent it was observed that there is lack of clarity in connection with the tree plantation area, area specified for other services and the extent of the basement floor. Therefore the project proponent was requested to make a presentation before the SEIAA to address the issues referred above.

DELIBERATION IN SEIAA

The project proponent made a presentation before SEIAA on 04.10.2021. Following are the observations:-

- a) There is a change in the configuration of the project as well as the profile of the land.
- b) The green belt as proposed in the drawing may not be feasible since the said area is conflicting with all service lines as shown in the drawings. The project proponent admitted that they were aware of the deficiencies and proposed that they would procure additional adjacent land to meet up the requirement of exclusive tree plantation area.

RECOMMENDATIONS OF SEIAA

Withdrawal of EC application-

- i. The project proponent is advised to withdraw the fresh application (SIA/WB/MIS/180865/2020) made against the project 'The 102'.
- ii. The project proponent is further advised to withdraw their application No. (SIA/WB/MIS/34385/2016) submitted under 'expansion' category.

Cancellation of original EC -

- iii. This will tantamount to cancellation of original EC (Application No. SIA/WB/MIS/63430/2017) No. 431/EN/T-II-1/013/2017 dated 22.02.2018 issued to the project "THE 101" which was subsequently renamed as 'The 102'.

CONCLUSION

Deferred (for necessary action by the project proponent).

The proposed project activity is listed at SL. No. 8(a) Building and Construction projects under Category "B2" of EIA Notification 2006. M/s. P. S. Vinayak Complex LLP had obtained EC for the project "THE 101" vide no. 431/EN/T-II-1/013/2017 dated 22.02.2018 with proposal no. SIA/WB/MIS/63430/2017. The project name changed from 'The 101' to 'The 102' in the said EC based on the application made by the project proponent on 01.08.2018. The project proponent applied for EC vide their application No. SIA/WB/MIS/50926/2016 of the same project in the name of 'Moments 101' which was rejected. The project proponent made another application No. SIA/WB/MIS/34385/2016 under 'expansion' category on 08.04.2019.

Thereafter the project proponent informed SEIAA of dividing the whole project into 2 separate projects viz. 'The 102' and 'CGEWHO' vide their letter No. Nil dated 23.09.2019. They also requested to bifurcate the original EC into 2 separate ECs with a change of built up area. From the documents submitted by the project proponent it was observed that there is lack of clarity in connection with the tree plantation area, area specified for other services and the extent of the basement floor. Therefore the project proponent was requested to make a presentation before the SEIAA to address the issues referred above.

DELIBERATION IN SEIAA

The project proponent made a presentation before SEIAA on 04.10.2021. It was observed that

the above mentioned project is a part of the erstwhile 'The 102' project. The configuration of the project proposal differs from the original layout for which the EC was granted.

RECOMMENDATIONS OF SEIAA

The present application can be considered only after the cancellation of the original EC (No.431/EN/T-II-1/013/2017 dated 22.02.2018).

No. 7, Mouza - Purba Topsia, P.S. - Tiljala, Kolkata-700046 (Located on the Eastern Metropolitan Bypass opposite side of Science City in Kolkata), West Bengal.

INTRODUCTION

The proponent made online application vide proposal no. SIA/WB/MIS/130506/2019 dated 09.12.2019 seeking environment clearance under the provisions of the EIA Notification, 2006 for the above mentioned project. The proposed project activity is listed at SL. No. 8(a) Building and Construction projects under Category 'B2' of EIA Notification 2006.

It is observed that in some parts of E.M. Bypass there is lack of civic amenities i.e. water supply, drainage and sewerage. However, a number of high-rise, high-density projects are coming up in these areas and KMC is issuing approvals to those projects. Even after completion of such projects these amenities are not being provided. This results in rampant extraction of ground water and contamination of drinking water during excessive flooding and prolonged water stagnation due to lack of storm water drainage provision. This overall situation is leading to severe health issues of the occupants and serious environmental hazards.

DELIBERATION IN SEIAA

SEIAA considered the recommendation of SEAC and observed the following documents are required to be submitted:

- a) Land details -
 - i. Mutation copy showing land classification (earlier and present) from DLLRO/Concerned Authority.
 - ii. Assessment Book copy from KMC.
- b) Civic amenities - Confirmation from KMC regarding regular water supply, storm water drainage and sewerage connections are in place for the project at present. In case such amenities are not in place, the civic authority should indicate a time frame for placement of such amenities.
- c) Plantation - the project proponent proposed to undertake the shortfall in the exclusive tree plantation area by compensatory plantation in area outside the project. There is no provision for undertaking compensatory plantation outside the project area in fresh proposal. Hence, the project proponent is required to recast the layout in order to comply with the exclusive tree plantation criteria within the project site.

RECOMMENDATIONS OF SEIAA

SEAC is requested to reappraise the project in view of the above observations.



The State Expert Appraisal Committee (SEAC) has noted that as per the MoE&CC Notification no. S.O.141(E) dated 15.01.2016 'District Survey Report (DSR) shall form the basis for application of Environmental Clearance, preparation of reports and appraisal of projects'. Further considering the MoEF&CC Notification S.O.3977(E) dated 14.08.2018, Sustainable Sand Mining Management Guidelines, 2016 and also Enforcement & Monitoring Guidelines for sand mining, 2020 it was decided by SEAC that the other mandatory requirements for sand mining applications are :
