SEIAA/TRF/0266	Transfer of Environmental Clearance from M/s Mateshwari Minerals to Shri Sunil Kumar Yadvendu issued by DEIAA, Rajsamand vide letter dated 01.08.2016 for M.L. number- 40/2007, Area- 4.75 ha., Production Capacity- 36800 TPA for Quartz & Feldspar Mining near Village- Upli Miyari, Tehsil & District-Rajsamand (Raj.) (Proposal No- 300417).

The Authority after detailed discussion and deliberation decided the following:

1. Serial No. 1: Proposal was deferred in 5.83rd meeting of SEIAA for "PP has submitted objections that his representation to relist the proposal was rejected by SEIAA without having been afforded an opportunity of being heard. The authority decided to examine the objection in further detail and thereafter to call the PP for personal hearing before taking a final decision in the matter"

Accordingly, PP was called for personal hearing and heard in 5.89 meeting of SEIAA. During the personal hearing, the documents given in support of the arguments put forth were examined and the representation given by PP was accepted by the Authority. Hence, the Authority decided to relist the proposal and send to SEAC-1 for examination. Detailed order on the representation on file.

- 2. Serial No. 2: Proposal was deferred in 5.86th meeting of SEIAA for "Affidavit regarding implementation of cluster EMP is not submitted". Now, PP has submitted the same. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 3. Serial No. 3: Proposal was deferred in 5.81st meeting of SEIAA for "Affidavit regarding no violation by Consultant, implementation of cluster EMP by PP and certificate from DCF Pratapgarh were not submitted". Now, PP has submitted the requisite documents. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 4. Serial No. 4: Proposal was deferred in 5.33rd meeting of SEIAA for "LOI of this proposal has expired". Now, PP has submitted a lease agreement vide letter dated 16.05.2023. However, on further examination following points have come into notice:
 - a. Production capacity given in proposal [35,71,394 TPA (ROM)] is different from the production capacity given in Cluster Mining Plan [9,76,374 TPA].
 - b. Affidavit regarding implementation of Cluster EMP is not submitted by the project proponent.
 - c. Distance of nearest forest is mentioned in form I but is handwritten.

Hence, the Authority decided to <u>refer back</u> this proposal to SEAC for re-examination and also SEIAA would like to know what kind of technical evaluation was done by SEAC in this regard.

5. Serial No. 5: Proposal was deferred in the 5.86th meeting of SEIAA for "Cluster production capacity in proposal is 1316892 TPA (ROM) and in Cluster Mining Plan it is mentioned as 1244035 TPA (ROM)." Now, PP has submitted a revised mining plan with correct production figures of cluster, vide letter dated 18.07.2023, along with a letter from Mining Department dated 18.07.2023 stating that the earlier figure was a typing mistake and it is to be read as 1316892 TPA (ROM). Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

- Serial No. 6: Proposal was deferred in 5.86th meeting of SEIAA for:
 - "(1.) Maximum proposed excavation in form-1 is 1269039 TPA with mineral production 236606 TPA, OB 1032433 TPA. However, in mining plan mineral production is 255434 TPA
 - (2) Affidavit of Cluster EMP Implementation is not enclosed
 - (3) Query reply letter dated 16.5.23 is not enclosed
 - (4) DSR is not enclosed. Uploaded DSR on portal is not authenticated."

Now, PP has submitted the requisite details and documents. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to <u>approve EIA/EMP</u> and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

- 7. Serial No. 7: In this proposal, in the revised Aravalli & cluster certificate, Khasra 2301 is missing. Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information (i.e., revised Aravalli & Cluster Certificate with correct Khasra numbers as mentioned in the proposal) within 45 days.
- 8. Serial No. 8, 9, 11, 12, 14, 15, 17, 19, 20, 22, 23, 24, 25, 26, 39: The Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to these proposals.
- 9. Serial No. 10: In this proposal, DSR was submitted for Granite whereas the proposal is for Quartz & Feldspar. Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information (i.e., Correct DSR) within 45 days.
- 10. Serial No. 13: The Authority observed that EIA/EMP for the cluster of 101.4467 ha in which the PP's area is also included, has already been approved by the Authority while according EC to M/s. Banas Builders & Developers LLP (Proposal No. 406711). PP has already enclosed a copy of that EC issued, in this situation there is no need to approve another EIA/EMP for the same cluster area.

Accordingly, the Authority decided to accept the recommendations of SEAC and to **grant EC** to this proposal on the condition that the PP should adhere to the conditions laid down earlier in the already approved EIA/EMP and the relevant parts of the EMP submitted by the PP in respect of issues raised during Public Hearing of this proposal.

11. Serial No. 16: The Authority accepted the recommendations of SEAC and decided to grant <u>EC</u> to this proposal subject to the outcome of the final judgement of the Hon'ble High Court's order dated 27.04.2023 in D.B Civil Writ Petition No. 9525/2021.

- 12. Serial No. 18, 27: The Authority accepted the recommendations of SEAC and decided to approve EIA/EMP and grant EC to these proposals with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 13. Serial No. 21: The Authority decided to <u>refer back</u> this proposal to SEAC, because the mineral production wise capacity has not been indicated in the recommendations. This may be examined in light of the Mining Plan and revised abstract may sent accordingly. In addition, PP is directed to submit an ATR in respect of Non-Compliance of General Conditions 10 and 15 in the submitted Certified Compliance Report.
- 14. Serial No. 28 to 33: The Authority accepted the recommendations of SEAC and decided to close and delist these proposals.
- 15. Serial No. 34: In this proposal, as per certificate issued by DCF, Kota vide letter dated 25.01.2023, Mukundra Hills Tiger Reserve is at a distance of 1.28 km from the lease area, for which conservation plan is required. Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information (i.e., Conservation Plan with acknowledgment Slip from DFO) within 45 days.
- 16. Serial No. 35: In this proposal, Simplified Mining Scheme submitted with the proposal was valid till 2022-2023. Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information (i.e., valid Mining scheme/plan) within 45 days.
- 17. Serial No. 36: In this proposal, LOI has expired and General Conditions 10 and 15 in the Certified Compliance Report are mentioned as Not Complied for which an ATR is required. Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information (i.e., valid LOI and ATR for non-compliance in CCR) within 45 days.
- 18. Serial No. 37: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR under violation to this proposal subject to submission of Certified Compliance Report along with ATR for Non-compliance, if any at the time of EC.
- 19. Serial No. 38: In this proposal, Past Production Certificate has not been submitted for FY 2020-2021, 2021-2022 and 2022-2023. Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information within 45 days.
- 20. Serial No. 40: In this proposal, Cluster certificate is ambiguous. Hence, the Authority decided to <u>defer</u> this proposal for additional information to be submitted in 45 days.
- 21. Serial No. 41: The Authority decided to <u>refer back</u> this proposal to SEAC for the following shortcomings:

- a. The proposed capacity is being more than double, however, the same has not been reflected in the change in figures of the important environmental parameters like water requirement, waste water and Solid waste generation.
- b. In submitted Certified Compliance Report, specific conditions no. 7, 18, 19, 35, 36, 44, 45, 46, operational phase conditions no. 4, 15 and general condition no. 2 are mentioned as NOT COMPLIED.
- Conservation Plan not submitted for Nahargarh WLS which falls within 10 km radius of project area.
- d. Affidavit submitted by consultant does not state about violation or no violation.
- 22. Serial No. 42: Proposal was earlier considered in the 5.74th meeting of SEIAA and was referred back to SEAC as revised data was different from the proposal applied earlier. Now, SEAC has sent the file again with revised details. On examination, the proposal was found appropriate. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
- 23. Serial No. 43 to 46: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued earlier by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023 and Hon'ble NGT order dated 07.12.2022.
