(1) Proposed expansion of Neotia Getwel Multi Specialty Hospital at Uttarayan Township, JL No. 86 & 81, Mouza-Ujanu & Gourcharan, P.S. Matigara, LR Khatian No.-260 & 847; District- Darjeeling, Siliguri, West Bengal by M/s. Ambuja Neotia Healthcare Venture Limited.

INTRODUCTION

The proponent made online application vide proposal no. SIA/WB/INFRA2/419569/2023 dated 12 April 2023 seeking environment clearance under the provisions of the EIA Notification, 2006 for the above-mentioned project. The proposed project activity is listed at SL. No. 8(a) Building / Construction projects under Category "B2" of EIA Notification 2006.

SEAC recommended for rejection of the proposed project for Environmental Clearance during its 3rd meeting held on 14.06.2023.

The project site was inspected on 16.05.2023 by WBPCB. Based on the inspection report of WBPCB along with the completion plan / sanction plan submitted by the PP, the committee noted that the PP has already constructed project activity at the project site, for which the built up area exceeds 20,000 sqm., which is a gross violation of EIA Notification, 2006 and its subsequent amendments. Therefore, the SEAC recommended that the present proposal of the PP should be rejected and the PP may apply afresh for ToR under violation category.

The proposal was placed before SEIAA in its 10th meeting held on 03.08.2023 and after detailed discussion it was decided to inform the project proponent (PP) to appear for a hearing before the SEIAA, WB before a final decision on EC application is taken.

Accordingly, the PP was requested to appear before SEIAA for hearing in the 12th meeting on 11.08.2023.

DELIBERATION IN SEIAA

The PP appeared for a hearing and gave a presentation to SEIAA. It was observed from the sanctioned building plan dated 07.02.2023 from Matigara Panchayat Samity that the total built up area 20287.765 sqm. Construction of Phase I and Phase II has been completed by the PP. Based on the sanctioned building plan, inspection report of

WBPCB, submission of PP and considering the recommendation of SEAC, SEIAA decided that the project is a violation project and need to apply afresh for ToR under violation category.

RECOMMENDATIONS OF SEIAA

The present proposal is rejected.

CONCLUSION

INTRODUCTION

The proponent made online application vide proposal no. SIA/WB/MIS/47616/2019 dated 23 February 2022 along with copies of EIA/EMP seeking environment clearance under the provisions of the EIA Notification, 2006 for the above-mentioned project. The proposed project activity is listed at SL. No. 7(d)(a)Common Bio-Medical Waste Treatment Facility projects under Category "B1" of EIA Notification 2006.

The PP obtained ToR issued by SEIAA, WB vide No. 1510/EN/T-II-1/006/2020 dated 12.11.2020 against proposal no. SIA/WB/MIS/47616/2019.

SEAC recommended for rejection of the proposed project for Environmental Clearance during its 3rd meeting held on 14.06.2023. Based on the certified compliance report of WBPCB, the committee noted that the PP has already installed 2 nos. of Incinerators without obtaining EC, which is a gross violation of EIA Notification, 2006 and its subsequent amendments. Therefore, the SEAC recommended that the present proposal of the PP shall be rejected and the PP shall apply afresh under violation category.

The proposal was placed before SEIAA in its 10th meeting held on 03.08.2023 and after detailed discussion it was decided to inform the PP to appear for a hearing before the SEIAA, WB before a final decision on EC application is taken.

Accordingly, the PP was requested to appear before SEIAA for hearing in the 12th meeting on 11.08.2023.

DELIBERATION IN SEIAA

The PP appeared for a hearing and submitted that due to excess accumulation of biomedical waste during COVID time, they have installed two incinerators as standby, and also based on the minutes of the meeting of WBPCB held on 19.04.2021. SEIAA decided that the matter may be referred to WBPCB for their opinion if the case should be considered as violation or not.

INTRODUCTION

The proponent made online application vide proposal no. **SIA/WB/MIS/240409/2021** dated **26 April 2023** seeking environment clearance under the provisions of the EIA Notification, 2006 for the above-mentioned project. The proposed project activity is listed at SL. No. **8(a) Building and Construction projects** under Category "**B2**" of EIA Notification 2006.

SEAC during its 2^{nd} meeting held on 07.06.2023 observed that the project is an expansion / modification of the existing township. However, the project proponent appears to have submitted only the particulars of the project and not of the township as a whole. The SEAC noted that the proposal submitted by the PP does not attract the provisions of EIA Notification, 2006 since the total built up area of the project is < 20,000 sqm. The SEAC decided that the PP should submit a fresh proposal considering the above project to be an expansion / modification of the entire township of IISCO, Burnpur Therefore, the present proposal has been forwarded to SEIAA for rejection.

The proposal was placed before SEIAA in its 7th meeting held on 10.07.2023 and after detailed discussion it was decided to inform the PP to appear for a hearing before the SEIAA, WB before a final decision on EC application is taken.

Accordingly, the PP was requested to appear before SEIAA for hearing in the 12th meeting on 11.08.2023.

DELIBERATION IN SEIAA

The PP appeared for a hearing and gave a verbal submission to SEIAA. It was observed that the project is an expansion / modification of the existing township. The project proponent submitted only the particulars of the expansion project of having building up area 8618 Sq. m. and not of the entire township as a whole.

Therefore, SEIAA considering the submission of PP and recommendation of SEAC, decided that the PP for any expansion within the township need to apply as an expansion project of the entire township. It was further decided that the present application being stand alone proposal of 8618 Sq. m. built up area is rejected.

RECOMMENDATIONS OF SEIAA

The present proposal is rejected.
