- 5. Serial No. 19: The Authority in its 5.06<sup>th</sup> meeting had deferred this proposal as the LoI of this proposal had expired. The proponent has submitted the increased LoI letter, so the LoI is valid for 12 months from 7<sup>th</sup> Jan 2022. The Authority based on the recommendations of SEAC decided to Approve EIA/EMP and Grant EC to this proposal with the condition that all the lease holders of cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

6. Serial No. 20: The Authority decided to Grant Transfer to EC this proposal.
