The representative of the project proponent Madhu Sudhan Reddy; and Smt. Srilatha of M/s. Pridhvi Enviro Tech Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

During presentation, the SEAC observed that few trees exists in the site. In this regard, the proponent informed that the intervening trees will be translocated to the boundaries of the site.

The SEAC noted that total plot area is 16,291.44 Sq.m., Net Plot area is 13,530.93 Sq.m; out of which green area is 1375.90 Sq.m. (10.17%)

It was informed that the total built-up area of the project is 79,119.02 Sq.m. The project consists of Residential Aparments to accommodate 168 units. Maximum No. of Floors proposed in the project are 2B + Stilt + 12 Floors.

It is also noted that Parking area to be provided is 20,052.68 Sq.m. (33.95% against required 22%).

The total cost of the project is Rs. 260 Crores. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 2.8 Crores and recurring cost: Rs. 10.0 Lakhs/annum.

After detailed discussions, the SEAC recommended for issue of EC.

The representative of the project proponent Susheel Jain; and Sri L. Chandrashekar Reddy of M/s. Space Enviro Solutions, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that total plot area is 9,791.0 Sq.m., Net Plot area is 7,928.0 Sq.m; out of which green area is 797.0 Sq.m. (10.05%)

It was informed that the total built-up area of the project is 84,636.43 Sq.m. The project is for construction of 750 bedded Hospital. Maximum No. of Floors proposed in the project are 4C+G+13 Upper Floors.

It is also noted that Parking area to be provided is 21,664.06 Sq.m. (34.40% against required 33%).

The total cost of the project is Rs. 85.0 Crores. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 125.0 Lakhs and recurring cost: Rs. 30.0 Lakhs/annum as per revised EMP budget during presentation.

After detailed discussions, the SEAC recommended for issue of EC.

The representative of the project proponent G. Raja Reddy; and Sri L. Chandrashekar Reddy of M/s. Space Enviro Solutions, Hyderabad attended and made a presentation before the SEAC.

Earlier, the SEIAA-TS issued EC vide order dt.05.05.2021 under violation for IT Campus Construction Project with a total builtup area of 44,121.89 Sq.m. The proponent obtained CFO vide order dt.15.11.2021.

Later, the proponent proposed expansion of the project by proposing Terrace floor & modifications in other floors of existing building with additional builtup area of 2,404.51 Sq.m. and increasing the total built-up area of the project to 46,526.40 Sq.m. Subsequently, the proponent submitted application in Parivesh under EC (Amendment) which was rejected by SEIAA as the proponent uploaded the project under EC (Amendment), but not under EC (Expansion).

Now, the project proponent uploaded for EC (Expansion) along with a copy of Certified Compliance Report dt. 28.10.2021 issued by MoEF&CC, GoI.

The proponent informed that they have already started Implementation of Remediation plan; Natural Resource Augmentation Plan; and Community Resource Augmentation Plan and submitted supporting documents.

The proponent also submitted Structural Stability Certificate dt.19.07.2021 that the structural designs for the proposed Terrace floors in Building No. 3A & 3B has already being considered while designing stage of the project itself. But, Building 3A with Basement + Ground + 4 Upper Floors & 3B with Basement + 2 Stlit + 6 Upper Floors is constructed. The structures for this building block comprises of RCC floor & roof is of structural steel and is complying with the Buereau of Indian Starndard Norms and is safe and suitable for the purpose of which it is intended.

The details of the project after proposed expansion are as follows:

The SEAC noted that total plot area is 16,376.0 Sq.m., Out of which green area is 952.9 Sq.m. (5.81%). In addition to it, the proponent informed that the project is part of layout developed by M/s. K. Raheja IT park for construction of IT projects and greenbelt area of 10% of the total area was developed before issue of G.O.Ms.No.168 dt. 07.04.2012 of MA&UD Department. Hence, the proponent requested to consider their proposal and issue EC for proposed expansion.

It was informed that the total built-up area of the project is 46,526.40 Sq.m. The project is for construction of IT Office Building. Maximum No. of Floors proposed in the project are B+2S+6 Upper Floors + Terrace Floor.

The proponent informed that Parking area to be provided in the project after expansion is 15,361.94 Sq.m. (against required parking area of 13,314.61 Sq.m. considering 35% of built-up area as per Master Plan for Cyberabad Development Authority Area notified vide G.O.Ms.No.538 dt.29.10.2001 by MA&UD Dept., for existing building and considering 66% as per G.O.Ms.No.168, dt.07.04.2012 of MA&UD Dept., for proposed expansion).

The total cost of the project is Rs. 74.97 Crores. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 137.90 Lakhs and recurring cost: Rs. 28 Lakhs/annum.

After detailed discussions, the SEAC recommended for issue of EC for Expansion.

The representative of the project proponent G. Raja Reddy; and Sri L. Chandrashekar Reddy of M/s. Space Enviro Solutions, Hyderabad attended and made a presentation before the SEAC.

Earlier, the SEIAA-TS issued EC vide order dt.07.06.2021 under violation for IT Campus Construction Project with a total built-up area of 1,01,870.31 Sq.m. The proponent obtained CFO vide order dt.16.11.2021.

Later, the proponent proposed expansion of the project by proposing Terrace floor & modifications in other floors of existing building with additional built-up area of 2,475.82 Sq.m. and increasing the total builtup of the project to 1,04,346.16 Sq.m.

Now, the project proponent uploaded for EC (Expansion) alongwith Certified Compliance Report dt. 28.10.2021 issued by MoEF&CC, GoI.

The proponent informed that they have already started Implementation of Remediation plan; Natural Resource Augmentation Plan; and Community Resource Augmentation Plan and submitted supporting documents.

The proponent also submitted Structural Stability Certificate dt.19.10.2021 that the structural designs for the proposed Terrace floors in Building No. 2A & 2B has already being considered while designing stage of the project itself. But, Building No. 2A with 2 Basements + Stilt + 10 Upper Floors & 2B with 1 Basement + Stlit + 9 Upper Floors is constructed. The structures for this building block comprises of RCC floor & roof is of structural steel and is complying with the Buereau of Indian Starndard Norms and is safe & suitable for the purpose of which it is intended.

The details of the project after proposed expansion are as follows:

The SEAC noted that total plot area is 23,683.7 Sq.m., Out of which green area is 1,377.9 Sq.m. (5.81%). In addition to it, the proponent informed that the project is part of layout developed by M/s. K. Raheja IT park for construction of IT projects and greenbelt area of 10% of the total area was developed before issue of G.O.Ms.No.168, dt. 07.04.2012 of MA&UD Department. Hence, the proponent requested to consider their proposal and issue EC for expansion.

It was informed that the total built-up area of the project is 1,04,346.16 Sq.m. The project is for construction of IT Office Building. Maximum No. of Floors proposed in the project are 2 B + S + 10 Upper Floors + Terrace Floor.

The proponent informed that Parking area to be provided in the project after expansion is 29,210.95 Sq.m. (against required parking area of 29,144.98 Sq.m. considering 35% of built-up area as per Master Plan for Cyberabad Development Authority Area notified vide G.O.Ms.No.538, dt.29.10.2001 by MA&UD Dept., for existing building and considering 66% as per G.O.Ms.No.168, dt.07.04.2012 of MA&UD Dept., for proposed expansion).

The total cost of the project is Rs. 145.42 Crores. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 156.4 Lakhs and recurring cost: Rs. 28.0 Lakhs/annum.

After detailed discussions, the SEAC recommended for issue of EC for Expansion.

The representative of the project proponent Sri Chandrakanth Goud and Sri Vishnu Sharma of M/s. Ampl Environ Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

The SEAC noted that the project is for Quartz and Feldspar Mine with Mine Lease Area of 8.5 Ha. The proponent informed that the production capacity of the project is to mine 49,400 TPA of Quartz and 24,700 TPA of Feldspar Mine.

The SEAC noted from Notice dt. 18.09.2018 that quarry lease was granted in favour of the proponent for a period of 20 years. It may be noted that the Mine Lease is granted after 09.09.2013. The proponent submitted application along with Scrutinized /Approved Mining Plan.

The Proponent also submitted a copy of lr.dt. 14.02.2019 of ADMG, Wanaparthy District informing that there are no quarry leases falling within 500m from the proposed quarry lease. The SEAC noted that the mine lease area is 8.5 Ha. which is more than 5.0 Ha. It is further noted that the total Cluster area is 8.5 Ha. and Net cluster is 8.5 Ha, which is more than 5.0 Ha. Hence, the project is considered under B1 Category as per provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT.

Nearest human habitation is Kasimnagar Thanda @ 0.58 km; Nearest water body is at a distance of 320 m (E); Nearest RF i.e., Wanaparthy RF exists at 276 m from the mine lease area.

The proponent informed that they have already collected the baseline data from October to December-2021 and requested to consider the same for preparation of EIA report based on the Standard Terms of Reference for projects of Mining of Minerals.

The SEAC considered the request of the proponent. After detailed discussions, the proponent is directed to prepare EIA report as per the Standard Terms of Reference (TORs) issued by the MoEF&CC, GoI for "Mining of Minerals" considering baseline data from October to December-2021, undergo the process of public hearing in consultation with TSPCB and submit final EIA report along with minutes of public hearing & response of the proponent to the issues emerged in the public hearing to the SEAC for appraisal.

Item No. 07	2.33 Ha. Building Stone & Road Metal Mine of M/s. D Arun Kumar, Sy.No. 19/1/1 PP, Sawathi (V), Wankidi (M), Kumarambheem-Asifabad District Environmental Clearance - Reg.

The representative of the project proponent Sri V. Ravi Kumar and Sri Vishnu Sharma of M/s. Ampl Environ Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

The proponent informed that the lease was granted (in-principle) on 26.10.2021 in favour of the proponent for a period of 20 years. It may be noted that the Mine Lease is granted after 09.09.2013. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The proponent submitted a copy of Ir. dt 28.09.2021 of the District Collector, Kumarambheem Asifabad District addressed to the DFO, Kumarambheem Asifabad District and Tahsildar, Wankidi requesting to conduct Joint inspection along with forest officials to verify details of classification, availabily of land and whether the applied area is falling in Schedule village and out of Reserve forest area or not, and to offer specific remarks if there is any objection and if no objection is filed within 7 days, it will be deemed that there is an objection from Forest officials and concerned Tahsildar will take necessary action in terms of G.O.Ms.No. 4, dt.19.01.2015 issued by Revenue (Assignments-I) department. Accordingly, as per the provisions of above G.O.Ms.No. 4, dt.19.01.2015, the Tahsildar vide Ir. dt.04.10.2021 recommended that there is no objection for proposed quarry lease and it was reported that there is Forest at 70 mts away from the proposed mine lease area. The SEAC observed from the documents submitted that the extent of land is mentioned as 4.88 Ha. instead of 2.33 Ha. In this regard, the proponent informed that quarry lease applied area is 4.88 Ha. but, after deletion of area fallen another side of road and safety area of 15 mts from Mission Bhagiradha pipeline, the net available area is 2.33 Ha. only.

The Proponent also submitted a copy of lr.dt. 03.11.2021 of ADMG, Kumarambheem Asifabad District informing that quarry leases falling within 500m from the edge of proposed quarry lease is treated as Nil. The SEAC noted that the mine lease area is 2.33 Ha. which is less than 5.0 Ha. It is further noted that the total Cluster area is 2.33 Ha. and Net cluster is 2.33 Ha. which is less than 5.0 Ha. Hence, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT.

The nearest village to the proposed site is Dongargoan Hamlet which is existing at a distance of 0.4 km; nearest water body exists at 720m (E); nearest RF i.e., Manikgarh RF exists at 60.8 km from the boundary of the site.

It is proposed to mine 66,347 m³/annum of Building Stone & Road Metal and the life of mine is reported as 5 years.

The total cost of the project is Rs. 50.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 9.1 lakhs and recurrin cost: Rs. 5.4 Lakhs/annum.

After detailed discussions, the SEAC recommended for issue of EC.

The representative of the project proponent Dr. Kishore and Sri Vishnu Sharma of M/s. Ampl Environ Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

Earlier, the GHMC issued permission vide order dt.02.03.2020 to M/s. Dhunji K Mistry, K.F Pestonji and M/s. Chermas Exquisite Ltd Dhunji K Mistry, Capt. K.F Pestonji and M/s. Chermas Exquisite Ltd., for Commercial Building Construction project and started excavation activities. Subsequently, they proposed expansion of the project and entered Development agreement cum GPA with the proponent (M/s. Meenakshi Infrastructures Pvt. Ltd.,). Hence, the proponent submitted the present proposal for Residential Apartments seeking EC.

The SEAC noted that total plot area is 6,119.66 Sq.m., out of which, green area is 614.98 Sq.m. (10.1%).

It was informed that the total built-up area of the project is 72,208.0 Sq.m. The project consists of Residential Apartments to accommodate 132 units. Maximum No. of floors proposed in the project are 2C + 4P + 33 Floors.

It is also noted that Parking area to be provided is 19,918.0 Sq.m., (38.1% against required 33%).

The total cost of the project is Rs. 100.0 Crores. The proponent is proposing budget for Environmental protection towards Capital cost: Rs.150.0 Lakhs and Recurring cost: Rs.83.0 lakhs/annum.

After detailed discussions, the SEAC recommended for issue of EC.

The representative of the project proponent Sri S. Ravi and Sri Vishnu Sharma of M/s. Ampl Environ Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

It is noted that the mine lease area is 56.68 Ha. which is more than 5.0 Ha.

During presentation, the proponent informed the following:

- Original Mine lease was granted on 4th June, 2002
- Mine lease was transferred and executed on 21th January, 2009.
- Mining lease expires on date: 2nd December, 2022.
- TOR issued on 9th September, 2010.
- Public Hearing conducted on 4th January, 2013.

- Proposal was considered in EAC meeting held on 25th September, 2013 and asked the additional information as per MoEF Observation.
- Additional information submitted was considered in EAC meeting held on 31st December, 2013 and after detailed discussion based on Letter issued by mining department, it was found that quarry was operated during the period 2010 to 2012, hence MoEF has issued Violation letter.
- Letter submission to Principal Secretary for initiating creditable action on 26th February, 2015.
- Principal Secretary send the letter to MoEF for credible action on 18th October, 2016.
- Ministry has issued S.O. 804 (E) date: 14th March, 2017 to submit the application as per the new notification with clarification.
- Date of submission of TOR application on 16th November, 2017.
- Application was considered for EAC meeting held on 24th January, 2019 and requested additional information.
- Reconsidered in EAC meeting held on 10th May, 2019 and deferred for Next EAC meeting to submt the Non forest land letter from Forest department.
- Reconsidered for EAC meeting 22nd to 24th July, 2019 and recommended to issue the TOR with specific and Additional Terms of Reference. However when Project proponent requested for exemption of Public hearing orally accepted since public hearing was already conducted for the above project, general TOR with public hearing was issued stating that since the SEIAA committee was not constituted. Hence the EAC at MoEF has issued TOR vide lr. dt.05.11.2019 as per the S.O. 3977 (E) dated 14.08.2018.
- Now they request the Hon'ble committee to exempt them from the Public hearing, since they have already conducted the public hearing on 4th January, 2013.

The SEAC observed that the project proponent applied under TOR instead of applying under Amendment to TOR. Hence, the proponent was informed to submit proposal under Amendment to TOR.

After detailed discussions, the SEAC decided to return the proposal.

Agenda Item No. 10	5.0 Ha. Stone & Metal Mine of Sri. K.Naveen Kumar, Sy.83, Bodajanampet (Village), Balanagar (Mandal), Mahabubnagar District Environmental Clearance - Reg.
Proposal No.	SIA/TG/MIN/42002/2019 (EC)

The representative of the project proponent Sri P. Gopi and Sri P. Hari Prasad of M/s. Rightsource Industrial Solutions Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

During presentation, the SEAC observed from the google map that an old worked out pit exists in the proposed mine lease area. In this regard, the proponent informed that it is an old worked pit which was existing before the grant of Mine lease and the same was verified with google timelines.

The proponent informed that the lease was granted (in-principle) on 09.08.2018 in favour of the proponent for a period of 20 years. It may be noted that the Mine Lease is granted after 09.09.2013. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The Proponent also submitted a copy of lr.dt. 29.10.2021 of ADMG, Mahabubnagar District informing that there are 6 existing quarries (all leases granted before 09.09.2013) falling within 500m from the proposed quarry lease. The SEAC noted that the mine lease area is 5.0 Ha. It is further noted that the total Cluster area is 38.15 Ha. and Net cluster is 5.0 Ha. Hence, the project is considered under B2 Category as per provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT.

The nearest village to the proposed site is Appajipalli (V) which is existing at a distance of 1.4 km, however, nearest settlement is at 0.8 km (W); nearest water body i.e., Suraram Nadi exists at 2.9 km from the boundary of the site.

It is proposed to mine 1,32,600 m³/annum of Stone & Road Metal and the life of mine is reported as 18 years.

The total cost of the project is Rs.40.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs.4.0 lakhs and recurring cost: Rs.3.0 Lakhs/annum.

After detailed discussions, the SEAC recommended for issue of EC.

The representative of the project proponent Sri C.Satyanarayana Reddy and Sri P. Hari Prasad of M/s. Rightsource Industrial Solutions Pvt. Ltd., Hyderabad attended and made a presentation before the SEAC.

Earlier, the SEAC in its meeting held on 13.08.2021 submitted a copy of acknowledgement slip for TOR application generated on 06.04.2018 for uploading TOR proposal. The proponent also submitted copies of statements for CSR activities which was not satisfactory. Hence, the proponent was requested to submit proper clarification with supporting documents.
