Proposed Alaknanda Metals Private Limited (Expansion Project), Mauza:- Simlimurapur, Village:- Kothia, P.S:- Didarganj, Tehsil:- Patna Rural, District:- Patna, State:- Bihar; with total production capacity for MS Billet of 1,35,360 MTPA, for Induction Furnace of 1,35,360 MTPA, & Structure of 1,80,000 MTPA (File No.: SIA/3(a)/1713/2021, Proposal No.: SIA/BR/IND1/406346/2022).

➤ **Resolve of the SEIAA:-**

In view of the consideration of SEAC and its recommendation to grant of Environmental Clearance (EC), the SEIAA resolved to grant EC with standard conditions in addition to special conditions i.e. (a) Three tier plantations shall be developed on 33% of total plot area of the project be done. Additional rows of plantations be done all around the Plant across the prevailing wind direction at the site. Additional block plantation should be raised and maintained even inside the project area if land is available out of stipulated green belt area. Selection of suitable species of plant shall be made as per CPCB guidelines in consultation with concerned Forest Division of the State Forest Department. (b) The

Proposed green belt area should be permanently barricaded for its exclusive maintenance (c) Important mobile numbers / contact number for emergency purpose should be displayed at different convenient locations including at the entry gate of the industry. (d) Must keep First Aid Box emergency medicine, stretcher, Mask, Sanitizer, etc. These be kept away from the plant area, at the entry and exit gates and other suitable places. The conditions be fulfilled along with special conditions as imposed by the SEAC in its MoM (Ref. No. 484, dated 21.12.2022).


