



The proposed project of API and intermediate bulk drug manufacturing unit (fermentation based) by M/s Kinvan Private Limited is situated at Industrial area Nalagarh, Solan, H.P. The pp has applied as per S.O. 1233(E) dated 27.03.2020 where it is mentioned that "all proposals for projects or activities in respect of Active Pharmaceuticals ingredients (API) received up to 30.03.2021 shall be appraised as Category-B2" extended till 31-12-2021.

The project proponent was earlier granted EC on dated 24th September 2021. Now, the project proponent has applied for amendments in EC letter on dated 03.09.2024, which was accepted by SEIAA on dated 05/02/2024, where project proponent has requested for amendments as per detail given below. These amendments have been proposed by the pp



after observing necessary requirements during the process of establishment of the project and after discussions with the SPCB concerned.

The case was listed in 99th meeting of the SEAC held on 7th February, 2024. After deliberating on the information submitted by the project proponent and considering the facts placed before the Committee, the SEAC recommended the case for amendment in EC in following manner:

The case was listed in 68th meeting of SEIAA held on dated 17th February, 2024. The SEIAA considered the recommendations of the SEAC and approved the changes/amendments in Environment Clearance letter as per the request received from the applicant.

3.8 Smt. Vanita Kumari, Vanita Kumar, M/s Building Stretch Crushing Zone, Village & P.O Pubbowal, Tehsil Haroli, District Una, Himachal Pradesh.

The project proponent Smt. Vanita Kumari, Vanita Kumar, M/s Building Stretch Crushing Zone, Village & P.O Pubbowal, Tehsil Haroli, District Una, Himachal Pradesh has submitted hard copy of application on dated 3/1/2024 and online application No. SIA/HP/MIN/307886/2023 for extension of validity of EC granted vide Letter No. HPSEIAA/2016/467-3411 dated 24/10/2016.

The mining plan was renewed by Department of Industries vide No. Udyog-Bhu(Khani-4)Laghu—175/20155 dated 8/12/2023 for the period of five years i.e. upto 23/10/2026

The case was listed in 68th meeting of SEIAA held on dated 17th February, 2024. The SEIAA approved the extension of validity of Environment Clearance in favor of the project proponent for the period of 5 years or which will be co terminus with the validity of the mining plan upto 23/10/2026, whichever is earlier. The Extension of validity of EC will be subject to the following conditions:

- a) The project proponent shall deposit capital cost (@ Rs. 4.00 lacs per ≤ ha.) under CER, in HDFC Saving Bank Account No. 50100626488752, IFSC: HDFC0006405, office of Member Secretary (SEIAA)/ EC Monitoring Cell, DEST&CC, GOHP within one month of the issuance of extension of EC letter. The Director (DEST&CC) will devise a plan for this purpose in consultation with project proponent.
- b) The project proponent shall provide one Pattal & Duna making machines within 15 days from the issuance of this letter in the office of Director (DEST&CC) for further distribution under CSR. Pattal & Duna Machines shall be purchased from authorised/ approved sources and CMC/AMC shall be assured with supplier for at



- least three year from date of installation. The Project proponent shall be responsible for functioning of the machines
- c) Other terms and conditions of Environmental Clearance letter shall remain same as imposed in earlier issued EC letter referred above.
- d) The implementation of revised Environment Management Plan and Terms & Conditions shall be sole responsibility of project proponent during the extended period of EC and after the project is commissioned or made functional.
- Before issuance of letter of extension of validity of period of EC, the Member Secretary (SEIAA) will check status of minerals of proposed mining site is as per District Survey Report duly approved/endorsed by EIA Authority as the case may be.

ITEM No. 4 Additional discussions

A representation from Mr. Illumudin, Former Panchayat Pradhan, Gram Bag Kuljan, PO & Tehsil-Jaisinghpur, Kangra was received on dated 11.12.2023 requesting to cancel the Environment Clearance granted to Smt. Kalpana Devi issued vide EC identification NO. EC22B001HP173837 dated 17/9/2022 in view of submission of false/fake "No Objection certificate" from Gram Panchayat Bag Kuljan. This matter was forwarded to the office of Sub Divisional Officer (c), Jaisinghpur, District-Kangra on dated 15.01.2024 for examination and submission of action taken report. Thereafter, ATR was received from the office of Sub Divisional Officer (c), Jaisinghpur on dated 08.02.2024, informing that as per the record available with Gram Panchayat no "NOC" was issued on dated 24/07/2018" to the project proponent, Smt. Kalpana Devi by Gram Panchayat Bag Kuljan. Therefore, the resolution of Gram Panchayat at Sr. no. 17 dated 24/07/2018 was invalid.

After detailed examination, the matter was placed before the SEIAA in its 68th meeting held on 17/2/2024. After detailed deliberations in the matter, following observations were made:

- i. Since the NOC is fake, BDO concerned may be advised to take necessary action in the matter as per the legal provisions under H.P. Panchayati Raj Act, 1994.
- ii. show cause notice shall be issued to the project proponent, as why Environment Clearance should not be withdrawn in view of submission of fake Gram Panchayat NOC produced before SEIAA & SEAC.
- iii. The matter may be placed before the SEIAA in its next meeting.

While deliberating on the matter, the Chairman (SEIAA) further advised the HPSEIAA secretariat to undertake district wise random test checks of some of the projects to which Environment Clearances have been granted by the SEIAA based upon "NOC" of Gram Panchayats produced by the project proponents and submit a report for perusal of SEIAA in next meeting.
