Unit I (formerly known as Sanhoc labs Limited Unit II) obtained consent for establishment (CFE) for manufacturing chloromethanes from APPCB vide Letter No. 473/APPCCB/CFE/RO-SKLM/HO/2019 dated 05.07.2019 at Plot No. 2 and Plot No. 9 (Part) of area 15 acres in sector specific industrial estate for synthetic organic chemicals which obtained environmental clearance in the name of M/s. Vivimed Labs Limited with a total 15 plots.It is proposed to enhance the chloromethanes production capacity, with backward integration by including Chlor-alkali manufacturing, and inclusion of active pharma ingredients manufacturing activity, co-generation power plant in the remaining plots of sector specific industrial estate for synthetic organic chemicals spread over an area of 274 acres (total site area after expansion is 289 acres) at Sy. VIVIMED labs Ltd, obtained the EC & CRZ clearance, F.No. 21-14/2011-IA. III dt: 11/8/2014 and Shreas Industries Ltd, Unit I (formerly SANHOC Labs Ltd, UNIT – II) purchased part of land and obtained the CFE, No: 473/APPCB/CFE/RO-SKLM/HO/2019, Dt: 05/07/2019.

The Committee noted that the EE,RO, Srikakulam submitted the certified compliance report and stated that

The industry has provided barbed wire fencing around the site.

The industry has started development works, excavation works for construction of structures and laid metal roads within the site. The representative of the industry informed that at present they have stopped the works due to COVID pandemic. They proposed to restart constructions works after obtaining EC for expansion.

The industry has not yet laid pipeline from plant to Bay of Bengal for marine disposal of treated effluent.

The entire site is having coconut garden and they are cutting the plants at wherever required and kept remaining plants as it is.

It is also submitted that the industry has not completed the construction of plant. Hence, the issue of condition wise certified compliance report on EC does not
